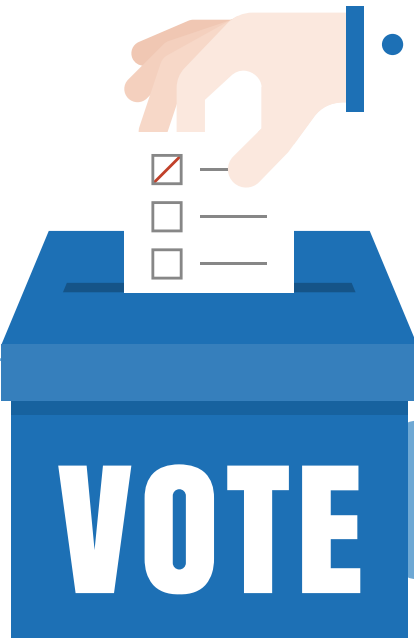
Meet Current Chair of WW REA

**Regulated
Rate
Option**



The Regulated Rate Option (RRO) may increase or decrease from month to month as it is priced on the open market and subject to many factors relating to supply and demand. It is not a 'regulated' rate, rather is a default rate. If you do not have a contract with an electricity retailer, then you are on the RRO. For February 2024, the RRO is priced at \$0.15338 per kWh, reflected on your enclosed orange bill. For March 2024, the Battle River Power Coop monthly RRO billing rate is \$0.10409.
