#### PRESIDENT'S REPORT

My friends,

After many years in the planning stage, we finally have the dredging operation underway to protect our lake and maintain our high property values. The working hours are from 7:00 a.m. to 7:00 p.m., Monday through Friday with no work on weekends or holidays, and only the areas being dredged should be affected. The silt will be moved by truck to a certified disposal site across North Lakeshore Drive by Clearwater Lane. We have covered this extensively in our Board minutes, Lake Committee meetings, Joint Annual Meetings and alert emails.

To stay informed of dredging operations, changes in trash pickup, wild animal sightings and community events, please **SIGN UP** for our **EMAIL ALERTS** by contacting the office.

#### A reminder as we go through summer and more of our neighbors are out and about:

- 1. State fishing licenses are required of all adults fishing most anywhere in BRS, including from boats and docks, except a member and family members fishing from their own lakefront property (guests still need them). (Best thing is to buy the license and not have to worry about it.)
- 2. All boats on the lake must display a valid BRS decal and be operated by a graduate of the required boating course. Guest boats are not allowed on our lake.
- 3. Power boats must stay at least 100 feet offshore and proceed counterclockwise around the lake. Fishermen with electric motors may be closer in and can go in either direction.
- 4. All boaters should be on the lookout for swimmers at all times.
- 5. The maximum speed limit is 25 mph on our community roads, unless a slower speed is warranted. When you see children or walkers, please slow down.
- 6. Dogs, alcohol, or glass containers are not allowed on our beaches.
- 7. All dogs must display a valid county dog license and be controlled. Please call Louisa County Animal Control if you need assistance or to report a loose dog.
- 8. As a member, you are responsible for the actions of anyone you let in or who

## RULES OF THE BEACH



- Use of the beach and other facilities are for BRPOA Members, Nonmember Occupants, & Guests
- Swim at your own risk, no lifeguards on duty
- No diving from the seawall or marina
- No dogs or other pets on the beach
- No Alcoholic Beverages or Glass Containers Permitted
- Use of a grill beyond the chain and posts/parking area is not permitted
- Children under 12 MUST be accompanied by Parent or responsible person at least 16 years of age
- BEWARE: Many areas of the lake are more than 5 feet deep and are dangerous for children, non-swimmers, and poor swimmers.
- Swimming beyond the post areas is discouraged.
- Manager on duty may ask any person who acts in an unsafe manner or who violates the Regulations applicable to the beach and swimming areas to leave the area.
- No loud or offensive music will be tolerated.

## **Boat Registration & Slip Rentals**

Boating season is here! Please as a reminder, the office will need CURRENT copies of your <u>State registration and Insurance Policy</u> that shows watercraft liability. If you renewed either of these since your registration with the office last year, please make sure to forward a copy to the office. If you are unsure if we have current information, please call the office and we will review your file. The cost to register a motorized boat is \$50.00. This is reviewed annually. The cost to register a non-motorized boat, (paddle boat, kayak & canoe) is \$25.00 and is a onetime registration. You must have paid the first half of 2016 assessments to acquire either decal.

The price to lease a boat slip for 2016 is \$150.00. Slips at the main beach require 2 slips for pontoon boats. We currently have 18 slips available. If you are interested in renting one, please contact the office @ 540-967-1408.

## **POSTED SPEED LIMITS**

The Association Office receives complaints routinely for people driving throughout the Community and exceeding the posted speed limits. The Louisa County Sheriff's Department has been most helpful in their attempts to resolve this problem. They have jurisdiction to write summons for speeding or reckless driving on Association Roads and the results go into Louisa County General District Court and if found guilty those results will be posted with DMV and appear on your Virginia Driver's License Records.

The Sheriff's Department has assured us of enhanced efforts to resolve these problems and will be placing Deputies in the areas of complaint. Please be considerate of yourself and others as it relates to the potential consequences of traveling too fast within the Community.

REMINDER: All Members and Registered Renters are responsible for their guests and their actions.

#### **Compliance Committee Report**

**Septic System Inspection** 

All members are required to have standard septic systems inspected every five years by a certified septic company. Alternative pumping systems must be inspected every year. Please submit your certification to the office. This is not only a BRS requirement but a requirement from the Commonwealth of Virginia enforced by all county health departments. The BRS office notifies each member at the beginning of the year when your system is due for inspection. You have until December 31 to comply. Members that do not comply will be fined \$10 per day for 90 days. Our Committee recently took this action on three members and this information may be posted in the Shore Line by name and Street Address. There are no exceptions. This rule is to ensure the health of our lake and the health of our water supply. Thank you for keeping Blue Ridge Shores a healthy community for all.

## **URGENT**

## Let's Be Proactive and Stop The Spread Of Hydrilla

About 25 years ago, Lake Louisa was invaded by an aquatic grass called Hydrilla. This is a plant originally imported into the U.S. to be used in aquariums and sometimes called "water kudzu" because it grows so fast. Hydrilla became so thick in the lake that many of the coves were unsuitable for swimming or wading and it even became difficult to operate boats in these areas because the hydrilla fouled the propellers so badly. By introducing a type of grass carp that feeds on hydrilla and other underwater vegetation (not the common carp found in most rivers, lakes and ponds) hydrilla has been eliminated from the lake.

While we have not seen any evidence that hydrilla is making a comeback in Lake Louisa, it is definitely making a comeback in Lake Anna and other rivers and lakes in Virginia. We do not want to have a recurrence in our lake. Hydrilla is easily spread by introducing even very small pieces into the water.

Therefore, we are asking that if you use your boat in other lakes or rivers please do the following before putting your boat in our lake.

- 1. Carefully check the boat, motor, propeller, and trailer:
- 2. Remove all plant material;
- 3. Thoroughly rinse off the boat and trailer before launching in Lake Louisa; and
- 4. Do not allow the runoff from this to enter the lake.

More information can be found by doing a simple internet search on "hydrilla in Virginia waters". Your cooperation will help protect the health of our lake.

# 2016 Boating Policies and Safety Tips

Boating Season is here and we hope everyone has a 2016 Fun but Safe experience. Blue Ridge Shores adopted the provisions of the Virginia Boating Safety Education Requirement for operation of a motorized boat on Lake Louisa. The Virginia Conservation Police Department has authority to enforce all provisions of State Requirements on Lake Louisa. Just a few reminders for everyone:

- Anyone operating a motorized boat in Virginia must possess a card indicating they have taken the **Virginia Boater Safety Education Class** or the State's Safety Class where the boat is registered on or before July 1, 2016.
- Operators must be at least 14 years old.
- Boats must be registered to a member or a non-member occupant who are members in good standing.
- All motorized boats must be registered through the office with current State Registration and Insurance Information in order to have and display a current Association Decal.
- All Non-Motorized Boats excluding a paddle board must be registered through the Association and display the appropriate decal.
- Jet Skis and jet powered boats are not permitted to be on the lake. Jet powered boats registered with the Association prior to August 13, 2011 are exempted from this rule.
- All motorized boat traffic must travel in a counter clockwise direction, unless they are fishing and under the power of a trolling motor.
- · All boats that are non-motorized have the right of way.
- All fast moving boats are required to stay off the Shoreline by 100 feet.
- All boats pulling tubes, skis, aqua boards or any other object are required to have a spotter. These activities are limited from 9:00 AM until sunset.
- All boats are to have running lights or navigational lights after dusk or before dawn.
- The Association's Special Assistant to the GM is patrolling the Lake and will issue violations as appropriate and the member affected will be required to attend a Compliance Committee Hearing.
- Should you have questions, require clarification, or a copy of these rules please contact the office.

## **General Manager's Report**

We hope you are enjoying your Summer in Blue Ridge Shores and we look forward to serving the continuing needs of the membership during the remaining months of 2016.

Welcome to the Ridge Utilities Board, new Members Bill Haase and June Smith! Good luck and best wishes to both.

We appreciate the many members and guests that have been considerate of others during your visits to the beach this year. Rules of the Beach are posted and we respectfully submit they apply to everyone. Ridge Utilities furnishes water for the bathrooms and outside faucets, so please be considerate and do not let children play in the streams or leave them on once you have cleaned the sand off your feet. Some vandalism was experienced recently in the Men's Room at the Main Beach and fortunately was located early.

The 2016 Dredging Project will begin in a few days and is scheduled to be completed within 150 days. Initially the majority of the work will be in the upper Hickory Creek Channels and then extend into those coves as designated on the 2013 Lake Survey. The project is designed to create "little to no" disruption of lake enjoyment, with no work on the weekends or holidays. The contractor, **Docks of The Bay** is accustomed to working in populated areas and will conduct their operations with courtesy and respect of the membership! Please contact me with any concerns or questions you may have!

I urge those that wish to sign up for a partial payment agreement in order to avoid higher monthly payments to do that immediately. To date we have approved twenty-four. We have collected 89 % of the 2016 revenue affiliated with assessments and rental fees by the end of June, 2016. A MNIGS Hearing was established for August 13, 2016. Our delinquency rate for 2015 was 3.2%.

Remember nothing can be placed in the Lake including leaves without Board permission.

Please look at your 911 address for your property and be sure it is accurate and per the regulations. The 911 address as assigned by the County must be displayed in three inch numbers, clearly visibly from the street. That address/number must be displayed on the side of the street that the house is located and be adjacent to the entryway/access to your house from the street. This is very crucial when seconds count in having emergency personnel responding to your needs.

Ridge Utilities is very pleased to announce that all wells are in excellent condition for water supply and all required testing to date has been completed with a 100% passing of those requirements. The 2015 Water Quality Report was distributed early and if you did not receive that, extra copies are in the office.

Water Quality Testing of the Lake was completed recently and all samples were within allowable standards.

Should you witness any activity that appears unlawful contact the Sheriff's Department immediately and also make the office aware of the issue including tag numbers, type of vehicle, and if by chance you know the individual(s). Your identity will not be disclosed by them. This also includes stray dogs. The Sheriff's Department is currently assisting by monitoring the speed of vehicles on the roadways. Their nonemergency # is 967-1234.

We welcome James Hawley to the Maintenance Staff for BRPOA and RU. James comes to us, as the result of Jeff Garrett's departure. Jeff worked nine years for BRS and we wish him well as he returns to Rigid Tool in Orange.
