### NEWS AND NOTES

#### **CCA Bond Issue Passes**

A \$65 million bond issue was passed with 77 percent of those voting in support of the measure that will allow the Clear Creek Amana School District to build a new, two-story elementary school on the eastern edge of the district in Coralville and add classrooms at the high school and middle school, plus upgrade playgrounds.

Tennis courts will be refurbished and pickle ball courts added to the Amana Elementary school-yard according to the list of updates planned by the CCA School District.

A total of 949 voters cast ballots in the March 1 election of the 10,526 registered voters in the school district. The issuance of bonds will not result in a property tax increase, the CCA district school board has assured the voters.

### Amana Arts Guild Exec Retires and New Staff is Hired

Longtime, Amana Arts Guild executive director Deborah Hawks, has retired from her position at the AAG.

After 11 years at work she described as a "fun and challenging" position, Hawks made the decision to retire this past fall. As she wrote in the AAG Fall newsletter, "I will miss working with everyone." During her tenure, Hawks helped create the Villages of Amana Christmas Haus Walk, the Fall Fibre Show and brought new arts instructors to head Art lowa workshops while making sure the annual Founders Day meal and Summer Festival of the Arts events were successful. Most recently she worked with the AAG board to move the Folklife Shop to the Amana, Gallery on Main.

The AAG Board expressed their gratitude to Hawkes. "We are so thankful to have had Deb at the AAG. She did wonderful work and she will be missed," said founder and board member Gordon Kellenberger.

Erin Shoup Wilding joined the AAG February 14 as executive director. A graduate of CCA High School and Drake University, Wilding created a social media and administrative management service for small, independent companies. She also provided graphic design capabilities for companies and nonprofits. With a growing interest in nonprofits and the arts, Wilding was pleased to be brought on board as the AAG's new executive director.

Growing up in South Amana, she attended AAG childrens' summer art workshops and remembers well mornings at the Folklife Center in High Amana creatively having fun and learning with her friends. She's pleased to be back now working with the AAG board on the arts group's goals.

"I think this is an exciting time for the arts in Amana and I'm thrilled to be here and to be part of that," she told us last week.

"There are so many things that have been developed here and the foundation is firmly in place thanks to Deb's hard work, Gordon, Kristie and so many others. I'm just grateful to be able to support their work and to help work for the future. I think there are so many potential things we can do."

The Amana Arts Guild Board, led by board president Kristie Yoder, hired Ashlie Beltz as the new manager of the Gallery on Main as well.

The Gallery, which opened last summer, has not had a formal manager on staff, so this is a step forward for the group.

The Gallery on Main has proven to be a popular shop with tourists and the AAG board is happy with the first year of operation. So now was a good time to move ahead. "We are very excited to have Erin and Ashley on board," she told us adding that the Gallery has been a success thus


