2. HEREBY acknowledges that the above-described EVENT is VERY DANGEROUS and involves the risk, hazards and dangers of personal injury, disability, death, property damage and other loss. The undersigned further acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF ANY OF THE RELEASEES, as defined in paragraph 5.
3. HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the EVENT(S) whether caused by the negligence of the RELEASEES, as defined in paragraph 5, or otherwise.
4. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the RELEASEES and each of them, as defined in paragraph 5, FROM ANY LOSS, LIABILITY, DAMAGE OR COST he/she may incur arising out of or related to his/her INJURY OR DEATH WHETHER CAUSED BY OR NEGLIGENCE OF RELEASEES OR OTHERWISE.

RELEASE AND WAIVER OF LIABILITY

5. HEREBY RELEASES, WAIVES, DISCHARGES AND CONVENANTS NOT TO SUE the promoters, participants, racing associations, sanctioning organizations or any subdivision thereof, track operators, track owners, officials, vehicle owners, drivers, pit crews, rescue personnel, any persons in any RESTRICTED AREA, promoters, sponsors, advertisers, owners and leasees of premises used to conduct the EVENT, premises and event inspectors, surveyors, underwriters, consultants, and others who give recommendations, directions, or instructions or engaged in risk evaluation or loss control activities regarding the premises or EVENT and each of them, their directors, officers, agents and employees (all hereinafter refer to as "Releasees"), FROM LIABILITY TO THE UNDERSIGNED, his/her personal representatives, assigns, heirs and next of kin FOR ANY AND ALL LOSS, DAMAGE, CLAIMS, DEMANDS, and/or RIGHTS OF ACTION, WHICH ARE RELATED TO , ARISE OUT OF, OR ARE IN ANY WAY CONNECTED TO THE UNDERSIGNED'S PARTICIPATION IN THE EVENT, CAUSED BY NEGLIGENCE OF THE RELEASEES.
