I have read, understand, and agree to the following:

The novel coronavirus ("COVID-19"), has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. While rules, guidance, and personal discipline may reduce this risk, the risk of serious illness and death does exist. South Valley Athletics ("SVA") cannot completely mitigate the transfer of communicable diseases like COVID-19 especially when involved in sports. Participation in sports includes possible exposure to and illness, injury, or death from infectious diseases including COVID-19.

In consideration for providing myself or my child the opportunity to participate in sports and any related transportation to and from the sporting events, both my child and I voluntarily agree to waive and discharge any and all claims against SVA and release it from liability for any exposure to or illness or injury from an infectious disease including COVID-19, including claims for any negligent actions of SVA or its employees or agents, to the fullest extent allowed by law, for myself, my child, our estates, our heirs, our administrators, our executors, our assignees, and our successors.

I also agree to release, exonerate, discharge and hold harmless SVA, its Board of Directors, the individual members thereof, and all officers, agents, employees, volunteers, and representatives from all liability, claims, causes of action, or demands, including attorney fees, fines, fees, or other costs (e.g. medical costs) arising out of any exposure to or illness or injury from an infectious disease including COVID-19, which may result from or in connection with my or my child's participation in sports. I further certify and represent that I have the legal authority to waive, discharge, release, and hold harmless the released parties on behalf of myself and the above-named athlete.

I certify that I have read this document in its entirety and fully understand its contents. In exchange for the opportunity to participate in sports, the above-named athlete and I freely and voluntarily assume all risks of such hazards and notwithstanding such, release SVA from all liability for any loss regardless of cause, and claims arising from the athlete's participation in these sports.

South Valley Athletics strives to provide a positive experience for all persons involved in our programs. All persons involved shall respect the facilities, teams and referees/staff. Any perceived misconduct during the 3vs.3 tournament from players, coaches or official should be reported immediately to SVA.

Players will be expected to demonstrate good sportsmanship on and off the court. No one may address an official/staff or other teams in a demeaning, disrespectful, profane or threatening way. Profanity/abusive language or behavior directed at anyone, by anyone will not be tolerated and may result in immediate ejection from the event. Any person ejected more than once during the 3 vs.3 tournament will not be allowed to finish the 3vs.3 tournament. SVA or referees will assess the penalty against the team whose participant that committed the offense. If the problem persists, the game may be forfeited. Parents/coaches/players are responsible for the behavior of their kids and any guests at all times.

In consideration for the right to participate in this activity, I agree to indemnify and hold harmless SVA and its Board of Directors, South Lane School District, the City of Cottage Grove, Oregon and their agents for any injury suffered as a result of my participation in this activity. I understand that there are inherent risks when playing Basketball, that serious injury or death can occur. I agree to assume those risks on behalf of myself/for my minor child. I agree to abide by the rules and regulations set forth by SVA and understand that SVA will have ultimate decision-making authority on any matters that might arise concerning the 3vs3 tournament. I understand that my failure to abide by any rule and/or regulation can jeopardize my team's participation in this 3vs.3 tournament.
