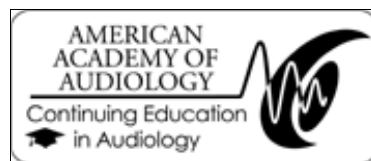

Harvey Abrams, PhD

Harvey Abrams, PhD has served in a number of academic, clinical, research, and administrative capacities with the Department of Veterans Affairs, the Department of Defense, academia, and private industry, including Chief of the Audiology and Speech Pathology Service and Associate Chief of Staff for Research and Development at the Bay Pines VA Healthcare System, the Director of Research at the Army Audiology and Speech Center at Walter Reed Army Medical Center, and the Director of Audiology Research at Starkey Hearing Technologies. He received his undergraduate degree from the George Washington University and his master's and doctoral training at the University of Florida. Harvey instructs students from several AuD programs and he is a frequent lecturer on the topics of outcome measures, health-related quality of life, professional issues, and evidence-based audiology practice. His research has focused on treatment efficacy and improved quality of life associated with audiology intervention, to include, most recently, computer-based training.



Kathy Dowd, AuD

Dr. Kathy Dowd, AuD received her undergraduate BA in French Education from Spalding University, MEd in Audiology from University of Louisville and AuD from Salus University. She worked for 39 years in clinical audiology. In the last few years Dr. Kathy Dowd has worked to raise the awareness of chronic disease and ototoxic medications and the comorbid impact on hearing loss and risk of falls. Her work on this emerging issue in Audiology has focused on diabetes educators, state agencies for chronic disease, hearing loss and fall prevention, as well as federal agencies such as Centers for Disease Control and Healthy People. Dr. Dowd is presently the executive director of The Audiology Project, a nonprofit organization working with national audiology professional organizations to define a medical management model of audiological care for diabetes and other chronic and infectious diseases.



Alexandra Tarvin, AuD

Dr. Alexandra Tarvin, Au.D. is Board Certified in Audiology. Dr. Tarvin received her Doctor of Audiology degree from the University of South Florida and her Bachelors in Communication Sciences and Disorders from the University of Florida. Dr. Tarvin completed her residency at a not-for-profit audiology institute in Louisville, Kentucky where she practiced all audiology specialties and focused on adult diagnostics and treatment. She started her career at a private practice in Greenville, SC for 3.5 years prior to starting Elevate Audiology. She is a twice published researcher completing her audiology doctoral project, entitled Acceptable Noise Level and Hearing Aid Noise Reduction, which has also been presented at multiple conferences. Dr. Tarvin is a Certified Fellow of the Tinnitus Practitioners Association specializing in tinnitus and sound sensitivity, has her Certificate of Clinical Competence by the American Speech-Language and Hearing Association, volunteers as Technology Chair and former President of the South Carolina Academy of Audiology, a fellow of the American Academy of Audiology, and a committee member of the Academy of Doctors of Audiology.



Angela Zuendt, AuD

Dr. Angela Zuendt obtained a Bachelor of Science and a Bachelor of Arts from Kent State University in Ohio. She then graduated with a doctoral degree in audiology for the Northeast Ohio AuD Consortium (NOAC) in 2010. She is a fellow of the American Academy of Audiology and President-Elect of the South Carolina Academy of Audiology, and holds her Certificate of Clinical Competence in Audiology from the American Speech-Language-Hearing Association. Dr. Zuendt implemented and oversees the student externship program at Greenville Ear, Nose, and Throat. She has been with the Greenville ENT family since August 2012. Dr. Zuendt's passion is in tinnitus management and hearing aid technology. She also specializes in adult diagnostics, auditory evoked potential testing and balance testing.
