REQUEST FOR APPROVAL OF EXTERIOR MODIFICATION**

INSTRUCTIONS: Article VI of the Association's Declaration of Covenants, Conditions and Restrictions requires that approval of the Association's Architectural Committee be obtained for " modifications . . . which would materially affect or change the appearance of the house or lot as viewed from the Common Area, streets or other lots." These include, but are not necessarily limited to, buildings, structural additions or alterations to the exterior of any structure, changes in any exterior color, fences, walls, hedges, sheds, decks, raised patios, some antennas, swimming pools, walks, driveways, exterior light fixtures, statuary, grading or any other change to the topography.

WHAT YOU MUST DO: Complete, sign and submit this application to the Architectural Committee and be available to answer questions (Send to: Architectural Committee, WCWHA, PO Box 1151, Annandale, VA 22003 or, to insure early receipt by the committee, hand deliver to the Committee chair at 4504 Fidelity Court).

WHAT THE COMMITTEE MUST DO: Act on your request within 30 days of the date it receives the request (has it in hand). If your request is approved, it will assign a committee member as liaison to you.

THE COMMITTEE'S OPTIONS: (1) Approve the request (2) Disapprove the request (3) Disapprove the request subject to reconsidering it when you provide additional information the committee needs (the committee will specify what is needed.)
