
2019-2020 Invoices get a New Updated Look with the Data Management Tool

Welcome to our newest members!

Message from the President

The Shasta Tehama Watershed Education Coalition is here to assist all our current members in complying with the Irrigated Lands Regulatory Program. Our goal, as always, is to keep your cost of compliance to an absolute minimum. I am pleased to announce that once again we were able to REDUCE your membership fee and per-acre fee even though the State Water Resources Control Board costs per acre have increased, along with our contract with the Resource Conservation District of Tehama County (RCD). The RCD increase is due to elevated costs for staff to administer the ever-changing regulatory demands. We pay the Sacramento Valley Water Quality Coalition to provide monitoring services to us and the other sub-coalitions in the Sacramento Valley. The upcoming 2019-2020 year is a core monitoring year which is less costly than an assessment monitoring year (which is required every three years). The core monitoring is one factor that has allowed us to lower our costs this year.

I am also excited to say that the Regional Board is considering lower ILRP requirements for irrigated pasture where NO fertilizer (nitrates) are applied.

I truly hope you all had a great harvest season and wish you Happy Holidays and hopefully an abundance of stored water in 2020!
