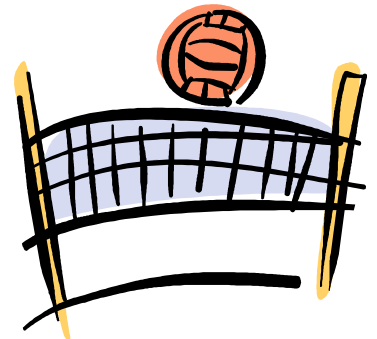

PLAYERS MUST PAY ADMISSION TO THE FAIR!

THERE WILL BE NO EXTRA CHARGE TO ENTER THE TOURNAMENT

1. Waiver forms must be signed and turned in at registration.
2. There will be a minimum of five (5) players per team; maximum of eight (8) per team. Total of five (5) players on court at one time.
3. There will be two (2) divisions consisting of Middle School (5-8 grades), High School (9-12 grades)
4. A coin toss will determine first serve and side of court.
5. Tournament format: A single elimination tournament format with each match being best of three (3) games to 21 points, win by two or 25 points (the first team to 25 points). Rally scoring will be used. A point is awarded on each serve.
6. Warm-up time will be limited. Matches will start as soon as teams are present and ready to go.
7. Teams are to bring their own towels to clean off. Games will not be delayed to spray off mud. Shoes are to be worn by all participants. All players play at their own risk.
8. Shirts, shorts or pants must be worn by all participants.
9. Hits do not have to alternate between the two sexes. The call cannot be blocked or spiked on the serve.
10. Trophies or prize will be awarded to the winning teams.
11. All the official's decisions are final. NO ARGUING! Any harassment from a team or a participant toward the official may cause the elimination of that team or person from further participation.
12. Team captains may substitute players an unlimited number of times.
13. Players may not purposely add mud to the ball.
PENALTY: Side out/point to other the team.

Cleanup instruction will be given during the tournament.
