A final development plan proposed by ModWash RC, LLC for car wash in a HB-S zoning district.

Today's Public Hearing is a final development plan proposed by ModWash

RC, LLC for car wash in a HB-S zoning district.

The petitioner is Glenwood Walkertown Land Company, LLC.

The site is .92 acres located on the east side of Martins Trail Lane, west of Old Hollow Road.

The request is for the Final Development Plan for property zoned HB-S Two Phase for the use of a Car Wash.

(Marc's PowerPoint includes: Legacy map, Location map, Aerial image, Area Plan, picture of: Martins Trail looking northwest, Pinecrest Apartments to the south, Old Hollow Road looking northwest, Site Plan, Elevations) The request does not require a rezoning.

The use and SIDA have already been approved for this site.

The request is consistent with the commercial land use recommended for the site in the area plan update.

The Site Plan meets Walkertown UDO requirements. Lighting and trees are the same as Walkertown Commons with Type 4 bufferyard on apartment side.

The dumpster is enclosed. No Old Hollow Road access.

There are 15 parking spaces, 3 lanes of stacking with room for 13 F-250's. Any questions from the council?

We are happy to be coming to your town.

We operate mostly east of the Mississippi. There is a high demand for a quick express car wash with all the extras. We keep a manager on site. We will have one employee directing traffic and another employee as cashier. The customer can clean the inside of their car or pay one of our people to do it for them. We have lots of extras available. We have 3 vacuums. We have 3 levels of car wash. We have monthly plans available.

Wesley: How many cars are inside?

Josh: It is auto loading, auto spacing so, more than one.

Peggy: Will there be sidewalks?

Marc: They added sidewalks to the site plan.

Peggy: Hours? Josh: 8am to 8pm.

Wesley: How many employees always there?

Josh: 4

Wesley: Perimeter lighting?

Josh: 24 hours for our customers. Doc: Do you have others nearby?

Josh: Mebane, Mt. Airy, there is one on Country Club Road.

Doc: Where is your home base?

Josh: Knoxville.

Peggy: Do you recycle the water?

Josh: Yes.
