MEMBERSHIP REGISTRATION FORM:

Please register me as a member of Savoie Organic Farm's Community Supported Agriculture (CSA) Program with drop off at The Farm and Fisherman Tavern & Market, Cherry Hill, NJ for the upcoming 2016 growing season. I understand that farming is a seasonal and unpredictable undertaking, and the exact selections and quantities included in the weekly distribution will change as the season progresses. In joining the CSA, I agree to share in the fluctuations and variations inherent in farming and understand that my produce will be grown using certified organic practices. I understand the CSA share program will run for 16 weeks, starting on or about Thursday, June 9, 2016 and ending on or about Thursday, October 13, 2016 with a 3 to 4 week hiatus taken between the summer and fall.

Note: Registration forms and payments (in full) must be received before April 1, 2016 to ensure membership in the program. Memberships must be postmarked by April 1, 2016; any submissions received after April 1st will be returned.

MEMBERSHIP AGREEMENT:

What is a CSA program and why should you consider joining the Savoie Organic Farm CSA?

Community Supported Agriculture (CSA) programs represent a partnership between community members and their local farms. Consumers purchase a share in the farm during the preceding fall/winter months, providing farmers with much-needed capital to cover upfront costs such as the fuel, seeds, and supplies that are vital to vegetable production. In return, the shareholders receive freshly harvested vegetables throughout the following season. Our CSA program is ideal for people who value organic produce, who enjoy eating what's in season, and who are willing to try new varieties of vegetables. Your weekly CSA share becomes a diverse, culinary adventure, but isn't that what you are looking for? It's a wonderful alternative to the generic, limited selection that grocery stores provide, and it's a guarantee that you are eating veggies that have been harvested at their peak of freshness and nutritional value. The Farm and Fisherman BYOB in Philadelphia and the Farm and Fisherman Tavern & Market in Cherry Hill are both committed to supporting local farmers and have featured our vegetables on their menus for years. This coming season, the Tavern & Market has generously offered to serve as a CSA pick-up location for the residents of the Cherry Hill area. We are thrilled to be partnering with the Farm and Fisherman and look forward to a bountiful season!

How it works:

Our CSA program runs for 16 weeks, with a 3 to 4 week break taken between the summer and fall harvests. We offer CSA shares of two different sizes: large and regular (see below). You purchase the size that will suit your weekly vegetable needs. We fill your box with an array of vegetables from the week's harvest and deliver it to the Farm and Fisherman Tavern, where you can pick it up each Thursday (see below for details). The selection of vegetables will vary as we progress through the season. Please refer to the "Seasonal Harvest" information on our website for an idea of what's available and how it changes from summer through fall. Shareholders will be contacted in early June via e-mail to confirm the program start date. There will be weekly correspondence thereafter regarding what to expect in your share every Thursday.

Share sizes and prices:

- Regular--** a 1/2 bushel box. This will feed a family of 3 to 4 people or 2 to 3 vegetarians.
\$480.00 after January 15, 2016
\$450.00 before January 15, 2016 (*GET 1 WEEK FREE FOR EARLY SIGN-UP*)
- Large--** a 1 1/9 bushel box. This will feed a family of 5 to 6 or feed 3 to 4 vegetarians.
\$848.00 after January 15, 2016
\$795.00 before January 15, 2016 (*GET 1 WEEK FREE FOR EARLY SIGN-UP*)

We understand that it may be difficult to predict your vegetable needs and that you might discover early in the season that you need a different size. Customers can adjust to a different share size within the first two weeks of the program (with fees pro-rated accordingly), but no adjustments will be permitted thereafter. Also, no refunds (for the entire season) will be provided after the program starts.

You can pick up your share anytime between the hours of 1 p.m. and 7 p.m. Shares must be picked up by 7 p.m. on Thursday, no exceptions.

Missed pick-up policy:

Shares that are not picked up by the end of the business day will be donated to the Farm and Fisherman staff members on a weekly basis. If you have vacation planned for a certain week you are welcome to arrange for an alternate person to pick up your share. Please provide us with his/her contact information just in case we need to get in touch with them. If you know in advance that you will not make it and would like us to donate your share to the restaurant staff, kindly let us know via e-mail at contact@savoieorganicfarm.com or phone (856) 629-9020.

Things to consider before joining a CSA:

Members of the CSA program are considered shareholders in the farm. CSA members can enjoy eating the absolute freshest and highest quality certified organic produce available, as well as the satisfaction of knowing that they are supporting a local, family-owned and operated farm. However, there are some risks. In the event of a catastrophic crop loss due to severe weather or pest conditions, the CSA program may have to be shortened and/or pickup weeks cancelled. In the event of such an occurrence, please know those of us at Savoie Organic Farm will make every effort to overcome the loss. By joining our CSA program, the shareholder agrees to share in this risk and will not expect any monetary reimbursement.

NOTE: This CSA membership agreement is made solely with Savoie Organic Farm, not with The Farm and Fisherman Tavern & Market; they merely serve as a drop-off/pick-up point.
