General Show Info

Entries: Entries will be accepted for sixty-five riders. Others will be waitlisted. Secretary will notify you once your entry has been accepted.

Schooling Day: Sept 9th: Schooling is available at \$25.00 per horse and open from 3-6pm.

Show Day: Sept 10th: Rings will open at 7:30am. No riding will be available in the show rings in the morning. Hand walking is available 30 min prior to show time. Schooling on day of the show is available at \$50.00 per horse if you have not entered two or more classes.

No classes can be added the day of the show.

RPHSA Membership: An \$8.00 Non-Member Fee will apply to all those not signed up for RPHSA.

Stabling: Stabling available for \$60.00 per day stall (Friday and Saturday) and \$20.00 per overnight stall: if you are not schooling. If you are schooling Friday the overnight fee is waived. You must purchase minimum of two bags of shavings. Horses can arrive after 2:00pm on Sept 9th and no later than 6pm. No refunds after closing date.

Awards: Show themed Ribbons first through sixth place.

Six high percentage awards: Intro Jr & Adult, Training Jr & Adult, Upper level Jr & Adult.

Times: Ride times will be posted at www.rphsa.com on or after Sept 7th.

One form per rider and horse combination. Riders can enter a max of three riding tests.

I AGREE THAT THIS INSTRUMENT ALSO SHALL BIND MY HEIRS, EXECUTORS AND PERSONAL REPRESENTATION AND CAN BE REVOKED ONLY BY WRITTEN INSTRUMENT TO WHICH YOU HAVE CONSENTED, AND NOT ORALLY.
