#### **New Business**

- Melodie presented Resolution 2022-08 Resolution Accepting the Amounts and Rates as
  Determined by the Budget Commission and Authorizing the Necessary Tax Levies and
  Certifying them to the County Auditor. Melodie provided Schedule A & Schedule B for
  the coming year, and the past year for comparison.
- Bill Bogantz made a motion to accept Resolution 2022-08. Doug Strait seconded the motion. The motion passed with all YES votes.
- The trustees discussed the road proposal from Small Asphalt Paving for additional repairs on Dutch Ridge and the intersection of Windy Hollow and Nichols.
- Bill Siegel made a motion to approve the proposal. Bill Bogantz seconded the motion.
   The motion passed with all YES votes.
- Melodie gave the status of the reduced speed limit signs on Liberty Church Road. The reduced speed of 45 has been approved and McKean Township is putting up signs.
- Melodie presented the letter from OTARMA that listed 11 items that the township need to address to reduce liability. Below is a brief list of the items and who is assigned to address each item
  - 1. Provide Annual Sexual Harassment/Anti-Harassment Training. **Melodie** will get everyone access to a training video on OTARMA's website.
  - 2. Obtain Proof of Insurance for Personal vehicles used for township business. **Melodie** will get this information from Ed Wasem.
  - 3. Document Road & Sign Monthly Inspections. **Jeff Irvin** will update the form and perform inspections.
  - 4. Document Pre-Trip Vehicle Inspections. Jeff already does this. **Melodie** will put a clipboard with blank forms in the shop for the Trustees to use.
  - 5. Document Public Access Building Inspections. **Doug Strait** will do this at least annually.
  - 6. Obtain Motor Vehicle Record Checks. **Melodie** will do these checks on all employees.
  - 7. Adopt a written driving policy with Driver Acceptability Standards. **Bill Bogantz** will review our current policy to make sure everything is covered.
  - 8. Erect road warning signs where road surfaces change from pavement to gravel. Jeff has already done this.

- 9. Adopt a written process to review incidents. Doug Strait will do this.
- 10. Remove gauges and provide separation for compressed gas cylinders on oxyacetylene welding cart. Jeff already did this.
- 11. Improve labeling for the above ground storage tanks. **Jeff** will order and display the necessary signs.
- The trustees discussed the proposed township building's location.
