

**AMELIA VILLAGE, OHIO**  
**Ordinance O-2017-23**

**AN AMENDMENT TO SECTION 112.02(a)(1)(H) OF THE PEDDLERS AND SOLICITORS ORDINANCE AND DECLARING AN EMERGENCY**

**WHEREAS**, the Amelia Village Council passed Chapter 112 of the Amelia Code of Ordinances which regulates peddlers and solicitors, and

**WHEREAS**, Amelia Village Council now seeks to amend Section 112.02(a)(1)(H) of the Amelia Code of Ordinances to not require peddlers and solicitors to be fingerprinted consistent with a recent federal court decision.

**NOW, THEREFORE**, be it ordained by the Council of Amelia Village, Clermont County, Ohio, that;

**SECTION 1:** Section 112.02(a)(1)(H) of the Amelia Code of Ordinances shall be amended as follows:

H. Evidence as to the good character and business responsibility of the applicant as will enable the Chief of Police or the Chief of Police's designee to properly evaluate such character and business responsibility; and

**SECTION 2:** That this Council hereby finds and determines that all formal actions relative to the passage of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 3:** This Ordinance is declared to be an emergency measure necessary for the preservation of the health, safety and well-being of the residents of the Village in order to ensure continuity with the regulation of peddlers and solicitors in the Village.

**SECTION 4:** This Ordinance shall take effect at the earliest period allowed by law.

MR. CAMPBELL moved to suspend the rules requiring three readings on three separate dates.




