# **DOGS ELIGIBLE TO ENTER**

This Agility trial is open to all dogs 15 months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds. Dogs not registerable with the AKC, bitches in season, aggressive dogs, dogs that are blind or suffering from any deformity, injury, or illness which may affect its physical or mental performance are not eligible to participate.

#### **Entries will be FIRST RECEIVED**

Express mail must be left WITHOUT signature required. Entries received before the opening time and date MUST be returned to sender.

Per AKC rules: Only 10 ENTRIES maximum per envelope.

No hand delivered may be accepted for the first 24 hours the trial is open. Entries received opening day must include postage or be metered or be delivered by a multi-state or multi-national postal or carrier service, including but not limited to USPS, FedEx, UPS, DHL. Any entries not meeting the above requirements must be returned.

For fast acknowledgment of entry, enclose a SASE or e-mail address.

FAX ENTRIES OR MOVE-UPS WILL NOT BE ACCEPTED.

All entries will be acknowledged <u>AFTER entries close</u> with a judging program. Should acknowledgment not be received by the exhibitor within a reasonable time, please notify the Trial Secretary.

IF A WAIT LIST IS NEEDED: the Agility Rules and Regulations, Chapter 1, Section 16 states: Wait List for Withdrawn Entries after the Closing Date/Time: The Club is offering a Wait List to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of 50 entries will be placed on the club's wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to this trial's closing date/time. Any entries withdrawn that are received by a minimum of 3 days prior to the first trial date will be replaced by a wait listed entry if any are available. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. Any wait listed entry that does not move off the wait list into the trail by a minimum of 3 days prior to the first trial date will receive a full refund.

#### Ribbons and Awards
