# **Southwyck Community Association – Call for Candidates & Annual Meeting Information**

In our past newsletter, we called for candidates for the position available on the master board. Since then we have decided to change the annual meeting date so that we would not conflict with other section elections and we had an issue with scheduling a meeting location. So, the 2009 Annual Members Meeting of the Southwyck Community Association is scheduled for *Thursday, January* 7, 2010 at Calvary Baptist Church, 3302 County Road 89 at 7:00 P.M. The purpose of the meeting is to hold elections for 1 position on the Board of Directors, and to bring you up to date on issues affecting the Association.

The Assocation (sometimes called the "master" Association) represents all of the homeowners in Southglen, Emerald Pointe, Huntington Park, Southfield Village, Edgewater Estates, Lakecrest Estates, and Southmanor. Each community is also represented by a Section or "village" Association that handles maintenance of pools and other common areas, as well as deed restriction enforcement. The master board is a separate board from the section boards with each having different areas of responsibility to our community. The Southwyck (master) Community Association handles assessment collection for both the master and villages Associations, and maintenance of certain common areas throughout the community.

The master Association is governed by a five member volunteers Board of Directors. The position up for election this year is currently vacant, but was previously held by Paige Gallegos who resigned at the end of August. This vacant position is for a Director.

Nominees must be in good standing (current on fees or payments due the Association). Candidates are asked to provide a brief (no more than 250 words) note presenting biographical information and their interest or qualifications for the positions. Interested individuals will also be asked to fill out a questioner which will be emailed or sent to you. This information will be shared with the membership. Notice of intent to run for election and your biographical summary must be postmarked or emailed **no later than November 30, 2009**. Only one member per household may run for a position on the Board. Write-ins or volunteers from the floor will not be accepted.

Additional information concerning the date, time and place of the meeting will be mailed to all homeowners in December. Please watch for our mailing and make plans to attend this once a year meeting.

Monday, November  $30^{\text{th}}$  - last date to get your name in as a potential candidate. Bio & questionnaire must be provided.

Early December - proxies will be sent out.

Tuesday, January 5 - proxies are due to Southwyck Community Association, if you are not going to be delivering your proxy in person at the annual meeting.

## **Magnolia Phase III Project**



The Magnolia Phase III Project is set to begin soon. This phase of the project will extensively involve our Emerald Pointe and Southfield Village Subdivisions. The major part of the road work has three areas of involvement to our area: Magnolia will tie in from Harkey Road to CR 89; Southfork from CR 89 to Morgan Road will be widened to four lanes; and County Road 89 from Northfork to Southfork will be widened to four lanes. In addition traffic lights will be added at the CR 89/Southfork intersection as well as the intersection of Morgan Road/Southfork.

Bids for the project were awarded at the City Council Meeting on November 9 with construction commencing by the end of the year. It is scheduled to be a 15 month project with completion in early 2011. Timing of the construction in our area will determined after bid is awarded. It is known that the CR 89 portion of the project has a 6 month completion requirement and it is anticipated the road will remain open throughout the construction.

The Association as part of the process is working closely with City to upgrade fencing along roadways; add/upgrade irrigation and landscaping; and to create a formal entrance on the south side of Emerald Pointe at Dryberry creating a new ingress/egress to the community.

It is anticipated we will have additional information at our Annual Meeting in December and as more is known, we will post at <u>www.southwycktexas.com</u> as well as in future correspondence. Likely the City will also send out updates as well on the project.
