

AMELIA VILLAGE, OHIO
Ordinance No.: O-2014-28

AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR AND FISCAL OFFICER TO ENTER INTO AN AGREEMENT WITH COMPMANAGEMENT, INC. TO ADMINISTER, PROCESS AND ANALYZE WORKERS' COMPENSATION CLAIMS SUBMITTED AGAINST THE VILLAGE.

WHEREAS, Amelia Village provides workers' compensation benefits to its employees through the State of Ohio Workers' Compensation Fund, administered by the State of Ohio, by the payment of premiums to the State of Ohio; and

WHEREAS, CompManagement, Inc., provides consultation and administration services with respect to workers' compensation matters; and

WHEREAS, Amelia Village desires to contract with CompManagement as the Village's third party administer (TPA) for the performance of consultation and administrative services with respect to its workers' compensation matters.

NOW, THEREFORE, be it ordained by Council of Amelia Village, Clermont County, Ohio that:

SECTION I. Village Council hereby authorizes and directs the Mayor and Fiscal Officer to enter into the Workers' Compensation Service Agency Agreement, attached hereto as Exhibit A and made part hereof, with CompManagement, Inc for a cost of two hundred ninety-five dollars (\$295.00) for services from January 1, 2015 through December 31, 2015.

SECTION II. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.

SECTION III. Council hereby finds and determines that all formal actions relative to the passage of this ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Revised Code.

MRS. GERBER moved for the adoption of the ordinance.

MR. DICKERSON seconded the motion.


