




Precent Increase in Flowering of Confederate Jasmine

1 Rate recommendations based on plant height are general starting rate recommendations and may vary based on plant species, growth habit, soil type, and climatic conditions. The users should evaluate Cutless Granular on a small area prior to large scale applications to target landscape ornamentals.

2 NOTICE TO USERS: The rates recommended above are rate ranges of Cutless Granular for growth regulation of established perennial landscape ornamental and should be used only as guidelines. The amount of Cutless Granular required for optimum growth regulation response is dependent upon the height and mass of woody stems, foliage volume, sunlight exposure, soil texture, rainfall and temperature conditions, and species tolerance. The higher rate range should be considered in regions of the country with higher temperatures and longer growing conditions. The users should evaluated Cutless Granular on a small area prior to large scale applications to target landscape ornamentals.

When to apply Cutless Granular

Apply Cutless Granular for growth suppression as needed to actively growing, healthy landscape ornamentals. Only apply when rainfall is expected, or the treated area can be irrigated with 1/2" of water following application. Repeat applications should be applied every 2 to 6 months or when growth regulation is no longer visible.

For extremely aggressive and vigorous landscape ornamentals, pruning or shaping should occur 4 weeks following application. Repeat applications should be applied every 2 to 6 months or when growth regulation is no longer evident.
