Summary of Water Ouality Information

The **Driftwood Mobile Home Park** drinking water system is owned and operated by Diane Benton. The facility office is located at 1027 Old Jesup Road in Brunswick, Georgia. If there are ever any comments or inquiries to be made, please feel free to visit the office or contact Diane Benton by phone at the numbers listed above.

Included in this report is information about where your water comes from, what it contains, and how it compares to standards set by regulatory agencies. The **Driftwood Mobile Home Park** is committed to providing your community with clean, safe, and reliable drinking water for everyone. Your water comes from two (2) community *groundwater* wells, Well 103 and 104. These wells, located within the **Driftwood Mobile Home Park** in Brunswick, Georgia, derive water from the *Coastal Plain Aquifer*. Necessary treatment, such as the addition of disinfectant, is performed at the well sites. This property is protected from activities which could potentially cause contamination of this water source.

The *Source Water Assessment Plan* (**SWAP**) for this facility has been completed by the Georgia Department of Natural Resources Environmental Protection Division. This report identifies any types of pollution to which your water supply could be vulnerable and includes information regarding potential sources of contamination in your watershed. A control zone has been established around the perimeter of both wells. Potential sources of contamination in the control zones include utility poles and electrical transformers. For more information on pollution sources in the control and management zones visit **the facility office.**

Driftwood Mobile Home Park water system is tested for more than eighty (80) drinking water parameters on a periodic basis determined by the Georgia Department of Natural Resources Environmental Protection Division Drinking Water Program and/or the United States Environmental Protection Agency. Sample/testing schedules are based on initial contaminant level assessments and can be changed by EPD if deemed necessary. Waivers may also be issued for the analyses of certain contaminants if analytical data shows that the distributed drinking water in this area is not vulnerable to pollution from these compounds.

During 2022, **Driftwood Mobile Home Park** drinking water was tested for bacteriological content, nitrates-nitrites, and volatile organic compounds. The **Driftwood (MHP) water system did not have any violations of water quality** parameters during 2022. However, for the monitoring period of 1/1/2022-12/31/2022 we did not monitor or test for Lead & Copper and therefore cannot be sure of the quality of our drinking water during that time. Please see the Public Notification for additional information. All other detected contaminants are delineated in the accompanying chart.

Results from the most recent lead and copper monitoring event are included in the Water Quality Chart. For this event samples were taken from five (5) representative locations throughout your community. While **NO** tested site exceeded the *Action Level* limits, detectable levels of copper were found in one or more sample(s). This could indicate the presence of some service lines that may contain this contaminant.

Customers should know that lead and copper are metals naturally found throughout the environment in soil and water. These metals can also be found in lead, copper, or brass household plumbing pipes and fixtures. Even consumer products such as paints, pottery, and pewter can contain lead and/or copper. Corrosion or deterioration of lead or copper-based materials, as well as erosion of natural deposits can release these metals into the drinking water.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. **Driftwood Mobile Home Park** is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Information on lead in drinking water, testing methods, and steps you can take to minimize exposure is available from the Safe Drinking Water Hotline or

The following measures may also be taken to minimize exposure to lead and/or copper:

- Use cold water for drinking or cooking.
- Do not cook with or consume water from the hot water faucet.
- Do not use hot water for making baby formula.
- Use only "lead-free" solder, fluxes and materials in new household plumbing and repairs.

Drinking water, including bottled water, may be expected to contain at least small amounts of contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that *may* be present in source water include the following:

- *Microbial contaminants*, such as viruses and bacteria which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- *Inorganic contaminants* such as salts and metals, which can be naturally occurring or result from urban storm runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- *Pesticides and herbicides*, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.
- *Organic chemical contaminants*, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.
- *Radioactive contaminants*, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Driftwood Mobile Home Park strives to maintain the highest standards of performance and quality possible. In order to maintain a safe and dependable water supply, improvements that benefit the community must be made. Please help keep these costs as low as possible by utilizing good water conservation practices.

DEFINITION OF TERMS AND ABBREVIATIONS USED IN THIS REPORT

<u>Maximum Contaminant Level (MCL):</u> "The highest level of a contaminant that is allowed in drinking water. MCL's are set as close to the MCLG as feasible using the best available treatment technology."

Maximum Contaminant Level Goal (MCLG): "The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLG's allow for a margin of safety."

Action Level (AL): "The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow."

Secondary Maximum Contaminant Level (SMCL): reasonable goals for drinking water quality. Exceeding SMCL's may adversely affect odor or appearance, but there is no known risk to human health.

Treatment Technique (TT): "A required process intended to reduce the level of a contaminant in drinking water."

Maximum Residual Disinfectant Level (MRDL): "The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbiological contaminants."

<u>Maximum Residual Disinfectant Level Goal (MRDLG):</u> "The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

<u>TTHMs (Total Trihalomethanes):</u> One or more of the organic compounds Chloroform, Bromodichloromethane, Chlorodibromomethane, and/or Bromoform.

<u>HAA5s (Haloacetic Acids):</u> One or more of the organic compounds Monochloroacetic Acid, Dichloroacetic Acid, Trichloroacetic Acid, Monobromoacetic Acid, and Dibromoacetic Acid.

IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER

Driftwood MHP Water System - 2022 Monitoring Requirements Not Met for Lead & Copper

Our water system recently violated monitoring requirements for drinking water. Although this incident was not an emergency, as our customers, you have a right to know what happened and what we are doing to correct this situation.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether our drinking water meets health standards. For the monitoring period of 1/1/2020-12/31/2022 we did not monitor or test for Lead & Copper and therefore cannot be sure of the quality of our drinking water during that time.

Who is at risk?

The Lead and Copper Rule protects public health by minimizing lead and copper levels in drinking water, primarily by reducing water corrosivity. Lead and copper enter drinking water mainly from corrosion of lead and copper containing plumbing materials.

What should I do?

There is nothing you need to do at this time.

What happened?

We failed to collect the required sample for Lead & Copper.

What is being done?

Samples will be collected during the 2023 monitoring period. Once the samples are collected and analyzed, the Driftwood MHP Water System will have satisfied the requirements of the EPD.
