**Program: How Civil Contractors Estimate Their Work**

As part of a typical PS&E package, Engineers are tasked to prepare construction cost estimates prior to the contractor's submittal of bids. Vital for budgeting, it is critical that these estimates be accurate and up to date with the current construction climate. Scott Jennings, P.E., from SJ Construction Consulting will provide an insight to the contractors perspective and give our members a glimpse of what is behind a contractors bid.

Scott Jennings has been in the heavy/civil construction business for approximately twenty-five years. In that time he has estimated over \$2 billion of construction from coast to coast and in Hawaii. Mr. Jennings will share an actual civil construction estimate created by him in one of the heavy/civil industry's leading estimating softwares: HeavyBid by HCSS, Inc. Mr. Jennings will dive into the details of production, crew sizes, equipment evaluation, subcontractor analysis, and fee structure.
