### **Basics of Operation**

1. The Institute is both licensed and approved for pre-license education requirements of 96 hours.
2. It is mandatory that students attend 96 hours and pass the course with an average grade of 75%.
3. A certificate of completion, as required by the Kentucky Real Estate Commission, will be furnished.
4. All course materials (including textbooks) will be furnished as part of the course fee. In the event a student drops out, there will not be a refund of the course fee, but the student can keep the materials and complete the course any time within one year at no additional cost.

### **Schedule**

**Daytime:** Monday, Wednesday and Friday; 9:00 a.m. until 4:00 p.m. for only four weeks.

Classes will be held in the WKU Carroll Knicely Center, 2355 Nashville Road (31-W) in Bowling Green.

This schedule will enable us to complete all the course material and do a thorough review (including a “practice exam”) prior to taking the State Licensing Exam.

### **Licensing Requirements**

It is the responsibility of each student to meet the Kentucky Real Estate Commission requirements for salesperson license. Those requirements, as listed in Kentucky Revised Statutes (KRS) 324.040 – 324.046 are:

1. Statement as to whether previously licensed.
2. Sworn statement re: business & residence addresses.
3. Naming of person or company with whom to be associated in the business of real estate.
4. Having attained age 18.
5. A high school diploma or its equivalent.
6. Have completed six semester hours of courses in real estate or 96 clock hours of instruction at a real estate school approved by the Kentucky Real Estate Commission and licensed by the State Board for Proprietary Educations (as this institution is!).
7. Complete the above pre--license education requirement prior to taking and passing the State Licensing exam.

**Note:** *Any applicant previously convicted of a felony, or a misdemeanor in the last 5 years, must contact the Kentucky Real Estate Commission (888--373--3300) before proceeding with pre-license education.*

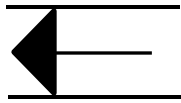

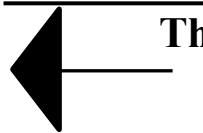
