Terms & Conditions

The following terms and conditions shall govern the services to customers provided by Brick Street BBQ from this web site (the "Site").

At Brick Street BBQ, we value our relationship with you. We have created this web site to serve you better, to offer you a way to improve accuracy of your delivered order, and to allow you a convenient way to create your order exactly the way you want it.

By using this Site, you acknowledge that you understand these Terms & Conditions, and that you accept them and agree to be legally bound by them. You should not use this Site if you have any objections to any of these Terms & Conditions.

Brick Street BBQ may revise these Terms & Conditions over time as new features are added to the Site or as Internet law and standards evolve. We will post those changes prominently, but we recommend that you read these Terms & Conditions each time you visit the Site.

1. Privacy Policy

Brick Street BBQ policy is to respect and protect the privacy of our users. Your confidence in us as a guardian of the information you provide is very important to us. 2. Links

3. "Cookies"
