COURSES, GROUNDS, ATTIRE AND BIRDS

All levels will run on a single course. All tests will be walked – horses will be used by officials only. In accordance with AKC rules, Chap. 1 Sec. 16, all dogs must be on leash at ALL times except when actually being tested. Bitches in season shall not be eligible for entry and shall not be allowed on the grounds. All handlers, judges, workers and gallery members must be attired in an article of Blaze orange while on the Club's grounds. **Quail** and/or Chukars and/or Pheasant and/or Pigeons, to be released for all test levels.

The Water Test will be held at Farmland Conservation Club. Ducks *may* be used in the Water Test; a blank pistol must be fired by the handler. Club is not responsible for providing pistols. Pistols used must be incapable of firing live rounds.
