Supervisor Peterman called the Sidney Township Board meeting to order at 7:00 p.m. followed by the Pledge of Allegiance.

ATTENDANCE:

AGENDA:

Leyrer motions to approve agenda. Welder seconds. All in favor. Carried.

MINUTES:

Leyrer motions to accept last month's Board minutes. Welder supported. All in favor. Carried.

CORRESPONDENCE:

Walters presented the AT&T Metro Act Right of Way Permit Extension paperwork for approval.

Peterman opened an estimate for reworking the cemetery roadways from Dairyland.

Leyrer motions to accept reworking the cemetery roadway for \$2,345 or less. Welder supported. All in favor. Carried.
