Dear Chief, Officer-in-Charge, Traffic Officer:

I invite you and your police agency to participate in the 71st Passaic County Distracted and Aggressive Driving Task Force event. The next event is scheduled for **"Thanksgiving Eve" on Wednesday, November 24, 2021 from 0700-1900 hours.**

The goal of the **PCDADTF** is to focus on distracted and aggressive driving via education and strict enforcement. The enforcement actions taken by your agencies can make a positive impact on the safety of the streets of Passaic County and the state of New Jersey safe.

Passaic County has suffered **20** fatalities on our roadways in 2021. We have lost **8** drivers, **4** passengers and **8** pedestrians.

New Jersey has experienced a significant increase in deaths on our roads. The state has seen **15%** more fatalities in 2021; this number represents **77** lives that were lost. In 2021 we could see an increase of **100** plus lives lost compared to 2019. Since January 1, 2019, we have lost **over 1500** people on our roadways.

Since its inception in September of 1999, the previous **70** task force events have yielded more than **47350** summonses, more than **472** arrests and hundreds of impounded vehicles.


I urge your agency to participate. Participation in the task force event should include press releases and social media messages urging your community to slow down and don't be distracted while driving.
