**2. Fire:** Jesse EMS fire training will be in Townhall in July. Discussed application, What Three Words? to help use gps locators in phones to find locations. 1526 (new) Hall equipment not able to do work until August/September. Called Fallsway in Akron can have job in 2 weeks. Jeffrey approved Fallsway for work. some more general discussion.

Camp Karl would light to know if they can set off fireworks on 4th of July. Review of rules and regulations cannot prevent private property use, based on size. Exception would be if Township passing a resolution to prevent use. Also, some weather restrictions. General regulation discussion. Insurance also discussed. Chris suggested we supply fire department grass truck to be present. He said they can sit there as well as at Station. General discussion. Tim agreed.

- **3. Zoning:** Tentatively sent up meeting for variance for BZA Meeting in July. Some general discussion regarding property size. Shill has contacted Rhonda for variances, but they never had approval for the building to be put up 15,000 sq. foot building. Not a commercial building, not in commercial area, and being used for commercial and she voiced potential hazards to storage of vehicles in the building. Continues to work on other violations and Brett Bencze involvement. Cannabis use related to zoning discussed in general, with question of the authority of a township. More general discussion. Discussed need to post it in paper.
- VII. **Fiscal Officer**: Bill provided financial reports, payments report and warrants EFT reports. Annual Tax budget reports for 2025 also presented. Bill requested payroll to be received by July 4th as he will be on vacation that next week, but will come in for that meeting for budget approval. Must have resolution passed to send to County Auditor. Bill shred and reviewed the documents he shared with trustees regarding how revenues, yearend carry over and taxes and property taxes affect the numbers estimated for the budget. He also shared reports from 2023 to give trustees idea of how carryovers work, and reminder that property taxes in 2024 do not come into play until April 2025. So a carry over must support the first 3 months of next year in certain funds, with tax money. Reminder that this is just an estimate of Tax budget.

Rhonda received email and asked trustees regarding litigation for zoning violation and asked what trustees agreed to at the meeting. Chris said it was only a mediation, but did review the procedure. She said the problem being you can't present for a variance if the actual documentation application for the building to begin with, that had never been made. More general discussion and agitation regarding this zoning issue and how it plays out in court system. She reported frustration with County prosecutor's performance regarding this issue.

Bill said in regards to this, he did forward the court costs for this case, and he sent it to Brett as he said the other party was to pay court fees. He is waiting for support.

Chris made motion to pay the bill, eft and warrants; 43515-43527, Tim made motion seconded by Chris.
