Policy for Pool and Park Parties

Members who sponsor parties at the pool or park with more than four (4) non-member guests must comply with the following rules and restrictions.

The member must:

- Fill out a Request Form for Use of Walnut Knolls Recreation Area and Pool Facilities for Parties and sign a Liability Waiver
- Make a \$50.00 donation for renting the facilities. (Members receive 1 free rental per calendar year)
- Pay a \$200.00 refundable damage/cleaning deposit, payable to the Walnut Knolls Association. The deposit will be refunded if the rented areas are cleaned up after the party and no damage is found.
- Clean up after the party to the satisfaction of the Pool Managers and take away all refuse from the pool and park area.
- Pay for any and all damage to the pool or park area caused by any member of the party.
- For pool parties with more than 10 guests, a certified lifeguard must be present at all times, arranged and paid for by the member. In addition to the lifeguard, there must be one adult for every five children.
- Pool parties shall be limited to 25 children and 25 adults (maximum 50 people). Parties at the park only shall be limited to 100 people.
- The parties shall be limited to a maximum of 4 hours between the hours of 10 a.m. and 8 p.m. Clean-up must be completed before 10 p.m.
- The Pool Manager or a member of the Board of Directors can end the party at any time if the group's behavior is unsafe or the noise level is too loud.
- A Walnut Knolls Association member must be in attendance during the entire party.
- **Please be aware that the general association membership is still allowed to use the pool and park at any time, even during parties.**
