Where do I vote?

It Depends Where You Live

This election marks a change from previous school board elections. This year Amana Colony residents will vote in their precinct of residence just as they do for a national/ state election, rather than at the Lakeside school as has been done in years past.

According to the Iowa County Auditor and Commissioner of Elections, county residents received a notice in the mail several weeks ago regarding the change.

Voters are directed to polling places in their townships/ precincts. The polls open at 7 a.m. and close at 8 p.m. Polling sites by township/ precinct are as follows:

- Honey Creek/ Marengo rural – Marengo Public Library
- Hilton/ Washington – Hilton Township Hall in Conroy
- Lenox/ Iowa – Middle Amana Fire Station
- Pilot/ Troy/ York - Williamsburg Rec Center.

For a complete list of all precincts and all polling sites in Iowa County go to the CCA school website or of the Iowa County, Iowa, Auditors website.

Election Day is Tuesday, November 5

Clear Creek Amana School District voters will be electing two board members to serve as "at large" directors, one member for district one and one member to represent district two.

The ballot includes the request of approval for the updated revenue purpose statement. Passage of it would allow the district to continue to be able to spend the penny sales tax (SAVE) funds as Iowa law allows for the duration of the penny sales tax. This measure must be approved by a majority of district voters in order to allow the district to continue to access these funds through the year 2050. This will not raise taxes, according to information provided by the district on its website.

Amana residents, Jennifer Mooney and Dr. Bryan Hosford, are candidates for two of the board positions on the ballot.

Meet the Candidates:

Dr. Bryan Hosford – At large. 1700 133rd Drive, Amana, Statement from candidate from the CCA website: "My name is Bryan Hosford and I'm running for an at-large seat on the Clear Creek Amana School Board. I live in Amana with my wife Holly and son Connor and employed with Pearson Education (25 years) in Iowa City. I moved to Iowa in 1994 with my wife, an Iowa farm girl. I grew up in a military family and have lived all over the world, but knew after visiting Iowa that this is where I wanted to live and raise a family. I am a United States Air Force (USAF) Veteran, and my education background includes a Bachelor's degree in Computer Science and Mathematics from Western Illinois University, Master's of Science degree in Project Management from the University of Wisconsin and a Ph.D. in Information Technology. I feel that my education, business background at Pearson Education and military service could be an asset to not only the board and teaching staff, but also the students in seeing that education is a life long journey."

Matt McAreavy – At large, incumbent. 4018 Erica Blvd. Oxford. Statement from the candidate from the CCA website: My name is Matt McAreavy and I live in Cosgrove with my wife Jody. We have two sons. Keyan, who is a 2015 CCA graduate and currently attends Drake Law School and Kaden who is a 2019 CCA graduate and is currently in his first year at the University of Iowa. I grew up in Oxford and am a '87 graduate of Clear Creek. I attended Kirkwood Community College where I received my AA. I am a Facilities Mechanic at the University of Iowa.

I am in my sixth year of service to the Board and would love the chance to continue my service. As a lifelong resident of the district I have always taken great pride in calling this district my home. Our incredible growth creates unique challenges but tremendous opportunities. I am excited to see just how far this district can go and would love a chance to continue to guide it in a positive direction. GO BOATS!!!!

Jennifer Mooney – incumbent for district 1 (Amana area). 712 27th Ave. Middle Amana, Iowa. Statement from the candidate from the CCA website: "My family and I have lived in Middle Amana for 12 years. We have three daughters who currently or previously attended CCA from elementary through high school. Classic Mystery is Much More Fun than Sponge Cake at a Cream Tea

Agatha Christie certainly knew what she was doing when she wrote "The Unexpected Guest," a witty whodunit with enough plot twists to startle and mystify even her most devoted fans.

From the first shot to the final curtain nothing is quite as it seems in this sleek, smart and puzzling thriller about a late night murder in a stately English country home. Inspired by the real-life downward spiral of her own brother-in law who used to take potshots with his revolver at his neighbors just for fun, here Dame Christie gives us the classic, cozy murder mystery with all the stock characters and plot devices – the foggy night, the beautiful lady of the house, the stodgy butler, the devoted housekeeper, the imperious, grand old dame, and yet, no one and nothing is quite as they seem, and the tension mounts as the story unfolds.

Directed by Emily Clinger, this is a well-paced, classic drama with enough spice and laughter to make it more than simply entertaining. Jackie McCall is lady of the house and lady in distress, Laura Warwick, and she does an outstanding job. It's been a real pleasure to see McCall progress as an actor over 16 years as company member at the Creamery and this is one of her best performances. Though we wish her well, we were sad to read in Sean McCall's production program note, that McCall has taken a position with her alma mater, Augustana College, in the Quad Cities, as outreach coordinator for the Brunner Theatre. We hope we'll continue to see McCall in future OCTC productions.

Kay Francis as Laura's mother in law, Mrs. Warwick, is simply outstanding, bringing to mind the chilling power of actresses like Eileen Atkins ("Doc Marten") and Penelope Keith ("To the Manor Born"). Watching Kay Francis in any role is delightful, but this is just the sort of thing she can really sink her teeth into and she is wonderful start to finish. Jacob Kilburg gets my vote as supporting actor of the year at the Creamery for his portrayal of Jan Warwick, the simple-minded brother to the murdered Warwick. He absolutely nails this truly complicated character.

Sean McCall might just have walked from the screen of a stylish 1950's British thriller. As the questing Scotland Yard detective, his accent, his on-stage presence is spot-on. We loved him in this role. His side kick the reedy Scotsman Sgt. Cadalader (Keegan Christopher) adds a bit of humor at just the right moments. While Marquetta Senters and David Q. Combs as the devoted housekeeper and the stodgy yet sinister "man servant" / butler make this entire show work. They create the characters necessary to drive this plot to its strangely, satisfying conclusion.

We can't forget Dion Stover as Julian Farrar the sleek, well, let's say oily politician who lives next door and is friend to all. Stover has fun with his part and it's a lot of fun to watch him.

That brings us to the Old Creamery debut of the very impressive Daniel A. Stevens as Michael Starkwedder, the friendly fellow who blunders into this fine mess. Stevens is perfect: engaging, handsome and comic. We hope to see him here in the future as he is one very talented actor.

I and my friend loved the show. The Sunday matinee house loved the show and we believe you will love this show. Perfect for a chilly October or November day, don't miss seeing this spine-tingling drama, powerful proof that good theatre is transporting.
