# **NACD Technical Assistance Grant**

Oconee Soil and Water Conservation District was able to help our NRCS staff continue to support our local cooperators by using a grant to bring in additional help by adding a program specialists focusing on EQIP agreements. Our ability to complete these agreements was enhanced by that addition allowing multiple contracts to have designs in place, new plans written, practices installed and certified. OSWCD and NRCS staff were so satisfied with the process that applications for the 2020 round were submitted and awarded. We will use this grant for personnel to support the coming Conservation Stewardship Program application incentive.

## **Education Programs**

As stated earlier Covid certainly has restricted what our usual programs were able to do. We were not stopped on some fronts though. We continued to promote our Essay and Art Contests though we could not present our usual end of contest banquet we were able to provide our winners with the usual prize awards and certificates which were presented at each schools virtual awards day. We had over 200 participants and 8 students were awarded prizes for their great work. The theme this year was "Cause and Effect of Global Warming" and the winners put forth some very thought filled work expounding upon their thoughts on the subject and their outlook on the natural world

The Conservation Stewardship Program (CSP) is a voluntary program through the USDA's Natural Resources Conservation Service (NRCS). Fa choose to add to their conservation efforts, in addition to continuing their current efforts, may receive payment through this program.

The CSP addresses several concerns, such as:

Air Quality
Animal Resources
Energy
Plant Resources
Soil Erosion
Soil Quality
Water Quality
Water Quantity

Through a 5-year contract, participants can receive annual payments for installing new conservation activities (enhancements), while maintaining existing practices. This program has helped numerous producers over the past ten years and may benefit you too.

#### EASEMENT PROGRAM

The District easement program currently protects upwards of 2800 acres in Oconee County. This year added two additional easements one in the crossroads area of the county (252 acres) and one near the five forks community near Walhalla (165 acres). We are working diligently to continue to offer this protection to our threatened farmland and open space. Working with NRCS, the South Carolina Conservation Bank, and The Oconee County Conservation Bank, we are partnering to put preservation on the ground and provide open space for generations to come. We are currently working on two additional easements for completion by summer of 2021. ## The Coronavirus Food Assistance Program (CFAP) Deadline Has Been Extended

The USDA's Farm Service Agency is accepting CFAP applications through September 11, 2020.

If you are you a farmer or rancher whose operation has been directly impacted by the coronavirus pandemic, the CFAP can provide direct relief, if you faced price declines and additional marketing costs due to COVID-19. CFP offers financial assistance to producers of agricultural commodities who have suffered a five-percent-or-greater price decline or who had losses due to market supply chain disruptions due to COVID-19 and face additional significant marketing costs. Eligible commodities for CFAP include:




## **Environmental Quality Incentives Program (EQIP)**

The Environmental Quality Incentives Program (EQIP) provides financial and technical assistance to farmers that address and benefit natural resource concerns. Participants receive assistance from your local NRCS office to plan, fund and implement improvements to conservation practices. These efforts not only help conserve natural resources, but also help improve local agricultural operations, in order to meet the farmer's goals and vision.

Working with your local NRCS office can help you find the right conservation efforts for you and your operation, while providing financial assistance to help cover the costs of implementation. This is a voluntary program that allows you and NRCS to co-invest in efforts to make conservation work for you.

Through the 2018 Farm Bill, EQIP now offers incentive contracts to increase benefits and practices for farmers. EQIP incentive contracts can be a stepping stone for producers between EQIP classic and Conservation Stewardship Program (CSP) contracts.

## Livestock Forage Program (LFP) – Drought Assistance

Are you an eligible livestock owner, contract grower who have covered livestock and producer of grazed forage crop acreage that has suffered a loss of grazed forage due to a drought? If so, the Livestock Forage Disaster Program (LFP) provides payments for qualifying grazing losses during qualified droughts.

Eligible livestock are grazing animals that satisfy the majority of nutritional needs through grazing of forage grasses or legumes and include alpacas, beef cattle, equine, goats and other species. Animals that are eligible include those that are or would have been grazing the eligible grazing land or pastureland:

- During the normal grazing period for the specific type of grazing land or pastureland for the county; or
- When the federal agency prohibited the livestock owner or contract grower from having livestock graze the normally permitted livestock on the managed rangeland due to fire.
