Secretary Minutes As of June 3rd, 2009.
The GSSN met at the American Legion Hall in Henderson, NV on Wednesday June 3rd, 2009. President Nic Johnson opened the meeting which started at 6:35 Pm and led the Pledge of Allegiance. 45 signed in and there were three visitors. Nic asked if anyone had found gold, and some vials were passed around.

Nic asked members about the minutes of the May 6th meeting which were published in the May 22, 2009 High grader; and Fred Zajac made a motion that such minutes be approved, with Don Adams seconding the motion. There was no discussion and the motion was carried with unanimous approval.

Next Nic introduced Joyce Johnson, the new GSSN Librarian-as well as Dara Thaler, the new GSSN treasurer (who had been appointed at the May 20, 2009 executive board meeting). She gave a brief treasurer's report. The group learned that on the GSSN website there is a video which members might want to check out. It was also announced that outings would not be held in June, July, and August, because of the heat.

Next Nic addressed the board recommendations regarding amendments to the bylaws and asked the members to consider these suggestions which had been published in the May 22, 2009 High grader newsletter.

Regarding Article 1: Name/purpose: Doug Parker made a motion to approve changing Article 1 by replacing its wording with A and B as published. Don Adams seconded the motion. After a brief discussion the motion was approved unanimously.

Regarding Article 3: Add E and F as published. There was a brief discussion about the grace period but no change was made. Charlotte Foley made a motion to approve adding E and F as published. Fred Zajac seconded the motion. The vote was unanimously.

Regarding Article 4, Section C: Change quorum from $20 \%$ to $10 \%$. Fred Zajac explained why it would be better for the group to have the quorum changed to $10 \%$ and then made a motion that such change be made. Morris Seguin seconded the motion. The vote was approved unanimously.

Regarding Article 5: Add 1—There was a brief discussion about the wording of section 1, and nic amended the wording to say that "The membership officer is the point of contact for implementing methods to attract new members to the organization." Charlotte Foley made a motion that section 1 be so stated; Fred Zajac seconded the motion. After a brief discussion, the vote was approved unanimously.

At 7:10 PM the group took a ten minute break following Fred Zajac making a motion to do so, which was seconded by Morris Seguin. At 7:20 PM the meeting resumed.

Regarding Article 6: The group discussed a typo in the five sections of this Article. Jean Davis made a motion to correct the typo (the second section C would become D; D would become E; and F would be added as published -Doug Parker seconded the motion. The vote was approved unanimously.

Regarding Article 7: Nic amended the published suggestions to replace this Article with the addition of Section C-8 "The Audit Committee" -Don Adams made the motion to approve Article 7 as published with the addition of section c8 "The Audit Committee" and Fred Zajac seconded the motion. The vote was approved unanimously. In connection with the approval of amending this Article, the breakdown of "Duties of Committees" (On page 6 of the Highgrader) will be changed to read " 8 . The Audit Committee shall be responsible for conducting audits of the organization and will meet semi-annually." The published $\# 8$ will be changed to " 9 . The President will appoint other committees from time to time for specific purposes."

Regarding Article 11, Charlotte Foley made a motion to add this article to the Bylaws and Morris Seguin seconded the motion. After a brief discussion, it was so carried and the vote was approved unanimously.

Nic thanked the members for their input and assistance in revising the Bylaws. Next a member asked if anyone had found sunglasses at an outing and unfortunately no one had. The next agenda item was a discussion of the group having T-shirts made as well as possibly caps, badges, etc. Morris made a motion that a committee be formed to explore this possibility and Dennis Johnson seconded the motion. A brief discussion ensued and then the vote was unanimously in favor of approving the motion. Four members volunteered to constitute this group (Al Krause, Bonnie Evelyn, Jeff Harper \& Joyce Johnson). The committee will get back to the group at a subsequent meeting.

Nic then spoke to the group about Global Positioning Satellites (GPS) and said there would be a follow-up meeting about this subject. It was mentioned that on 8-27-09 a great view of Mars would be visible.

Next, the door prize of $\$ 5$ was awarded to Fred Hissong; and the raffle was held, with fifteen prizes awarded as noted on the attached list. (See front page for raffle).

Afterwards, Fred made a motion to adjourn the meeting which was seconded by Morris Seguin, and the meeting was so adjourned at 8:15PM.

## Board Meeting Minutes as of June 17th, 2009

Minutes: GSSN Board Meeting - Wednesday, June 17, 2009 (Panera Bread, Henderson NV, Those who Attended: nic, Dolores, Joyce, Dara, Jeff Harper, John Bronstien, Fred, Morris, Jake, Bonnie \& Richard Evelyn)
Nic called this meeting to order at 6PM. He said that Gordon Eggleston had contacted him relative to selling some of his gold. He asked the group for some recommendations and Morris S. made a motion that we ask Gordon to bring his gold to our next meeting, at which time a committee will weigh the gold and decide how much to propose paying Gordon for the gold. Fred seconded the motion and after a brief discussion the vote was unanimously in favor of the motion and it was so carried. Nic then announced that Janet Schelling has volunteered to do a panning demonstration at the next meeting and asked the board if that would be agreeable. The board agreed that it would be o.k. and Nic will follow-up regarding this. He then circulated a copy of the revised Bylaws for the board to review prior to publishing same in the Highgrader newsletter. The board was in agreement to the revised By- laws with one exception: Joyce Johnson made a motion to amend Article 3, section E. to with the addition of the following sentence: " After a 30-day grace period, all member privileges will be revoked relative to voting privileges and using the organization's claims." Fred seconded the motion. There was discussion of this Article and then the voting was unanimously in favor of approving the motion. The amended section E of Article 2 will be included with the revised Bylaws to be published in the Highgrader newsletter for consideration by GSSN members.
At this time Dara T. gave a brief treasurer's report and said that since the bank statement had just arrived she will have an up-to-date report at the July 1, 2009 meeting. Nic then talked about the possibility of the education committee consider the possibility of a wild life presentation and this will be followed up. He also mentioned the possibility of a presentation on GPS. Morris S. and John Bronstein will get together about arranging this.
Next, Fred Z. announced that the audit committee had audited the financial books (which Barre Kennerley had turned over and which were given to Dara Thaler) and said that everything was correct and that an exact recap was reached. Afterwards the recently organized merchandise committee discussed their research relative to $t$-shirts and caps. Jeff Harper said the group would continue their research and would report back on this at the next meeting.
Nic then brought up a problem at the claim site regarding the burning of some Joshua trees. The group discussed this, and it was decided that Nic would call the BLM to notify them of this matter. At this point Fred made a motion to adjourn the meeting which was seconded by Morris. The meeting was adjourned at 7:10PM.

PUMP: Comes from Kmart. Cost is around $\$ 15.00$. Any 12 Volt pump will do. The buckets are plastic. Bucket \#2 has a plastic pipe glued in for the overflow.

SLUICE: Any Trough or Ramp will do. Put carpeting in the bottom to collect the gold.

FILTER: A and B are filtering material from a swap cooler or netting material.

# June 4, 2009 Bylaws of Gold Searchers of Southern Nevada, Inc. 

## Article 1: Name

A. The name of the organization shall be "Gold Searchers of Southern Nevada, Inc."
B. The Gold Searchers of Southern Nevada, Inc. is organized as a non-profit Nevada Corporation exclusively for charitable, scientific and educational purposes, more specifically to educate its members and others about prospecting for gold and other precious minerals.

## Article 2: Objectives

A. Protect the rights given us under the Mining Law of 1872.
B. To educate, exchange information and knowledge in prospecting, milling, mining safety, and operating a small mining organization.
C. To obtain enjoyment and success from prospecting potential mineral bearing areas.
D. To locate, lease and/or purchase claims for the use of the organization.
E. Exchange ideas with other like or similar organizations.

## Article 3: Membership

A. Any individual eighteen (18) or older, wishing to participate in and further the objectives of the organization are eligible for membership.
B. Members will be required to pay the annual dues which are set by the organization.
C. Each member in good standing shall have one (1) vote in matters voted upon at the general meetings.
D. Non members or guests may attend a maximum of two meetings and/or one outing prior to joining. Any person exceeding these limits during a calendar year may be asked to leave any meeting and/or outing by any officer.
E. To be considered a member in good standing, to retain voting privileges and use the organizations claims, the annual dues shall be paid up to date. After a 30 -day grace period, all privileges will be suspended.
F. After a 90-day grace period, a member will be removed from the organization's membership and shall pay a new membership fee to rejoin.

## Article 4: Meetings and Quorums

A. There shall be at least one (1) general meeting each month.
B. The general meeting in November shall be designated as the annual meeting at which time the election of officers shall be held.
C. A quorum for the general meeting of the organization, for the transaction of business, shall be $10 \%$ percent of the membership in good standing.
D. The executive committee shall designate the time and the place for the general meeting and the executive meetings.
E. Any officer who misses three (3) consecutive meetings (without approval of the executive board) may be considered for removal from office.

## Article 5: Officers and Duties of Officers

A. All officers shall be "members in good standing" and shall remain so during their terms of office.
B. The elected officers of the organization shall consist of the President, Vice President at least one (1) Secretary, at least one (1) Treasurer and Membership Officer.
C. Additional elected officers of the organization may be created by the Executive Committee, as the need arises.
D. The President shall be the executive officer of the organization and shall preside at all meetings of the organization. $\mathrm{He} /$ she shall recommend committee chairpersons to the executive committee for appointment.
D. The Vice President shall preside at all meetings of the organization when the President is absent. He/she shall carry out the duties as appointed by the President.
E. The Secretary shall take the minutes at all general meetings and executive committee meetings. $\mathrm{He} /$ she shall be the holder of the Corporate Minutes Book and Seal.
F. The Treasurer shall receive all the funds of the organization and disburse only such funds as are authorized by the executive committee. He/she shall be present at all audits of the books.
G. The President, with the approval of the executive committee, shall be authorized to assign other duties to officers as may be deemed necessary from time to time.
H. The Membership officer is the point of contact for implementing methods to attract new members to the organization.

## D. Article 6: Election of Officers

A. Nominations for the election of officers shall be declared open at the October general meeting, with the election taking place at the November general meeting. Nominations may be made by any member, in good standing at such meeting. Any member in good standing may be nominated or appointed to any office. No member may be appointed for or appointed to any office without his or her consent. The names of the nominees for each respective office shall be published in the organizations newsletter following such meeting.
B. An election/nominating committee of not less than three members, none of whom shall be a candidate for election, shall volunteer or be appointed by the executive committee to supervise and conduct the election.
C. After any nominations have been made from the floor, a motion shall be in order to cast a majority ballot for all non-contested offices; after such motion has been made, seconded, and passed, such nominees shall be declared duly elected. Contested offices shall then be elected by written ballot.
D. No elected officer may hold the same office for more than two and a half ( $2^{1 / 2}$ ) terms. However, he/she may run for a different office, if so desired, at the end of the two and a half $\left(2^{1 / 2}\right)$ terms.
E. If any office is declared vacant for any reason, the President, with the approval of the executive board, shall appoint another officer to carry out the duties until an election can be held to fill the vacancy.
F. All records shall be transferred to newly elected officers during the month of December. Names of signers on the bank accounts shall be changed in December. Newly elected officers will take office January 1st.

## Article 7: Committees, Standing and Others

A. The executive committee shall consist of all elected officers.
B. The board shall consist of the executive committee and the chairperson of all standing committees. The minutes of its meetings are the official record of the board and shall be published in the newsletter.
C. The standing committees shall be:

1. The executive committee
2. The newsletter committee
3. The claims committee
4. The outings committee
5. The library committee
6. The education committee
7. The webmaster committee
8. The audit committee
9. The executive committee shall conduct the affairs of the organization between its regularly scheduled meetings
10. The newsletter committee shall consist of the editor and assistance as needed. The editor shall be responsible for the publication and mailings of the newsletter in a timely fashion.
11. The claims committee shall be responsible for the proper marking of all claims, filing of all claims and mapping of all claims for the organization's use.
12. The outings committee shall be responsible for researching and arranging outings for the organization.
13. The library committee shall be responsible for keeping all soft goods, i.e., books, videos, tapes, maps and other material belonging to the organization and making this available for the use of the members. The librarian shall also act as historian for the records.
14. The education committee shall coordinate education activities of the organization.
15. The webmaster committee shall update and maintain the organization's website.
16. The audit committee shall be responsible for conducting audits of the organization and will meet semiannually.
17. The President will appoint other committees from time to time for specific purposes.

## Article 8: Amendments to the Bylaws

A. A motion to amend to Bylaws may be made by any member in good standing at any general meeting. A written copy of the proposed amendment must be presented to the secretary prior to the start of the meeting. The proposal must be seconded. The proposed amendment must be published in the newsletter prior to the next general meeting. At the next general meeting after publication, the proposed amendment shall be discussed under "New Business". The final form of the amendment must published in the next edition of the newsletter and the President shall place the proposed amendment on the next agenda for the next meeting. It shall be taken up in "Old Business" and requires a two-thirds ( $2 / 3$ ) majority of the members present at such meeting. If adopted, it shall become effective immediately.
B. The executive committee may introduce any amendments as a group, and cause the editor to publish the first draft of such proposed change. The amendment procedure will then proceed as though submitted by an individual member, as fully described in section "A" above.

## Article 9: Parliamentary Guidance

A. Roberts Rules of Order are hereby adopted for Parliamentary usage at the meetings of the organization.

## Article 10: Dissolution of Organization

A. Any member may make a motion to dissolve the Corporation at any general meeting of the organization. If such a motion is made, seconded and passed, it will be placed on the agenda for discussion and action at the next general meeting of the organization under "New Business". Announcement that such motion has been made shall be published in the newsletter.
B. The motion to dissolve the Corporation will then be acted on at the next general meeting under "New Business". If two-thirds ( $2 / 3$ ) of the members in good standing approve the motion to dissolve, the audit committee shall then meet and perform an audit to verify the remaining balance in the treasury. They shall research and submit the names of at least two (2) non-profit educational organizations which support mining and individual mining rights in Nevada.
C. All assets of the Corporation shall be liquidated at reasonable value and the funds shall be added to the treasury.
D. The executive committee shall select those organizations from the ones submitted by the audit committee and determine the amount each is to receive.
E. At the next general meeting, the report of the audit committee shall be presented immediately after the Presidents opening remarks. The members present shall discuss the report and modify it or adopt it as recommended, by a simple majority vote.
F. The treasurer shall allot a sufficient sum to pay all authorized and outstanding bills and report the balance in the treasury. The President will then call for an immediate vote on the dissolution of the Corporation. A vote of greater than three-quarters ( $3 / 4$ ) of the members in good standing shall be necessary for dissolution. If the vote to dissolve is passed, it shall be effective immediately, and the treasurer shall write and post the amounts allotted to past bills and current authorized expenses, and shall write and post the amounts in the designated percentages to the educational groups as voted upon by the executive committee. This action shall deplete the treasury to a zero balance, checking account to be closed and the Corporation shall be considered dissolved.
G. Notification of dissolution is to be sent to the "Secretary of State" of the State of Nevada.

## Article 11: Code of Ethics

A. Respect the rights of all members at meetings and activities. Those failing to be respectful of others will be asked to leave the meeting or activity.
B. Before searching or prospecting sites or lands, always check on laws, ordinances or regulations that govern your search area.
C. NEVER trespass! Always get permission when searching or prospecting on private land.
D. Never leave open holes. Try to leave the area as it was. Fill in and or level your prospecting holes and piles. Leave flora and fauna alone.
E. Anyone not filling in their dig holes when detecting or drywashing will be banned from club claims.
F. Report the discovery of any item of significant historical value to the local historian or museum.
G. If you discover live ammo, explosives, detonators, or lethal object, DO NOT touch it. Mark the site and notify police at once.
H. Be polite and informative to those who inquire about your activities. You are an Ambassador of the club and a pastime we want to protect. We will be judged by how we act and respond.
I. Do not litter! Pick up your trash and some extra, Please.
J. All gold found on our claims belongs to the finder.
K. Access to the claims is on first come, first serve basis. There are no reserved locations. Leave a ten-foot space between you and the next member when any members are present and working the same area.


I, Nicolas Johnson, your President of Gold Searchers of Southern Nevada, Inc. would like to inform members about our claims.

I went with some new friends out to the claims to show where they can prospect and know how to get there. We first went to the 20 Acre and did a little Metal Detecting along with some sampling (Waiting to here if there was a little gold in the bucket). My friends found mostly other metals within the ground (metal wires, shotgun lead slugs, and .22 bullet shells) but our hopes were high on finding Gold! We went to the Section 34 but only drove through on the road to see the dirt road leading to the center of the claim. After looking we left to the Dog Gone / White Hills claim, it was a beautiful day to be out having fun Playing in the sun! Upon Arriving at the Dog Gone / White Hills Claims I noticed that someone had been burning in the water trough that was at the BBQ area and found out that three trees had been burned on one side and that one Joshua tree was pulled from the ground and laying next to the water trough. I have never been so disgusted in my life for what happened there. One tree was started on fire at the base of the tree and flamed up the one side of it, as with another tree that was started the same way. This reflects on the club, especially on how we conduct ourselves at the claim(s), each member that prospects on the claims does have a responsibility to have respect towards the land we prospect on and do our part to help. All I ask is if you find anything to report it to the Executive Committee so that we may deal with this appropriately.
