Supervisor Smith called the public meeting to order at 6:00 pm followed by the Pledge of Allegiance.

Supervisor Smith presented the audience with the reason for the increase. The Village of Watkins Glen has served notice that it will no longer run the Town portion of the water system. This will result in the Town having to purchase equipment and hire personnel to run and maintain the system. This leaves the Town with a couple of options, one - raise the rates to cover expenses and take out a loan to purchase equipment or two - dissolve the system which would force everyone to go back to wells and septic systems. Supervisor Smith presented two options for the rate increase needed.

After a short discussion the public hearing was closed at 6:35 pm.

Supervisor Smith called the regular board meeting to order at 6:36 pm followed by the Pledge of Allegiance.

If Town can hold a flat 2025 budget anyone that had a increase of value under 140k should not see an increase in taxes, it should remain flat, if we can hold costs down.
 - Water and Sewer Rates, spent many hours on these gathering costs, running numbers and ways to reduce cost for Public Hearing
 - Worked on Town Hall items, parking lot expansion, Door readers, Few items left over from Construction
 - Highway Part 284
 - New Fax Service options to save money-sent to Board
 - New postage service to save money
 - Generator Repair for Pump Station issue
 - Pro housing Program working on it
 - Reviewing Grants for many items for the Town-met with County Administrator and SCOPED

- b. Deputy Supervisor finally able to meet with Mr. Vickio and he is unable to make the signs after all but he did give a few names of someone who might be able to.
- c. Bookkeeper none.
- d. Superintendent of Highway Ditched Cross Road, Townsend Road, Pearl Street, Hauled in #1's from Seneca Stone for road service treatment, Prepped Hedden Road for warranty work, Soil and water hydro seeded all ditches that we had ditched, Repaired VanZant Hollow Road from winter damage, Oil and stoned Beaver Dams/Price Road, Baker Hill Road. 2 guys spent a total of 37 hours cleaning up Moreland cemetery, Repaired excavator twice (hydraulic line, wiper motor module)

NYS budget has passed and between rollover from previous year and 2024 budgeted amounts for PaveNY, extreme winter and pothole money I have \$110,221.78 and I would like to amend the 284 agreement and finish my list of road projects that I presented to board in March.

Here are my balances for 2024 state funding with rollover added to the total balances. Pave NY, EWR and POP with a total of \$151,972.15 to spend to finish out remainder of road projects and replenish our

storage amount of materials that we have used on these projects.

Another similar issue was found but the owners came in and applied for a permit and will provide proof that things were done properly.
