USA WRESTLING WAIVER AND RELEASE FROM LIABILITY

1. I, the undersigned, on behalf of myself, my heirs, and next of kin, personal representatives, agents, insurers, successors and assigns (all hereinafter "Releasors") hereby FOREVER RELEASE, DISCHARGE AND COVENANT NOT TO SUE THE UNITED STATES OF AMERICA WRESTLING ASSOCIATION, INC., its insurers, its affiliate clubs, administrators, agents, directors, officers, state organizations, members, committees, volunteers, all employees of USA Wrestling, and any and all participants, officials, referees, coaches, host clubs, sponsoring agencies, sponsors, advertisers, local organizing committees (and if applicable) owners, lessors, and operators of premises used to conduct any USA Wrestling sanctioned event, meet, practice or activity (all hereinafter "Releasees") from any and all liabilities, claims, demands, causes of action or losses of any kind or nature, past, present or future, direct or consequential that I may hereafter have for PERSONAL INJURY, PERMANENT, TEMPORARY, TOTAL OR PARTIAL DISABILITY, DISFIGUREMENT, PARALYSIS AND ANY OTHER LOSSES OR DAMAGES TO PERSON OR PROPERTY OR DEATH, arising out of my participation in, attendance at or traveling to and from any USA Wrestling sanctioned event or activity including, but not limited to, LOSSES CAUSED BY THE PASSIVE OR ACTIVE NEGLIGENCE OF THE RELEASEES, or hidden, latent or obvious defects in the facilities or equipment used.
2. Releasor understands and acknowledges that USA Wrestling sanctioned activities and the sport of wrestling in general have inherent dangers that no amount of care, caution, training, instruction, supervision, or expertise can eliminate. RELEASOR EXPRESSLY AND VOLUNTARILY ASSUMES ALL RISK OF PERSONAL INJURY, PERMANENT, TEMPORARY, TOTAL OR PARTIAL DISABILITY, DISFIGUREMENT, PARALYSIS AND ANY OTHER LOSSES OR DAMAGES TO PERSON OR PROPERTY OR DEATH, sustained while participating in, attending, preparing for or traveling to and from any USA Wrestling sanctioned event, meet, practice or activity, including the risk of PASSIVE OR ACTIVE NEGLIGENCE OF THE RELEASEES, or hidden, latent or obvious defects in the facilities or equipment used.
3. Releasor acknowledges and fully understands that each participant in any USA Wrestling sanctioned event, meet, practice or activity, including Releasor, will be engaging in activities that involve risk of serious injury, including permanent, temporary, total or partial disability, disfigurement, paralysis and other losses to person or property, including death, and that severe social and economic losses may also result not only from Releasor's own actions, inactions or negligence, but also from the actions, inactions or negligence of others notwithstanding the rules of play or the condition of the premises or of any equipment used. Furthermore Releasor acknowledges and fully understands that there may be other associated risks with such activities which are not known or not reasonably foreseeable at this time.

USA WRESTLING MEMBERSHIP – CREATING A WRESTLER'S CARD INSTRUCTIONS

TO CREATE A MEMBERSHIP:

- 1) You will need to create a New Account (enter parents info). Whether you are an existing/returning member or a new member.
- 2) Once you create an account, select 'Go to Profiles'. Fill out the form and Click 'Create Profile'. On the next screen, enter the Parents information and select 'Create Profile'.
- 3) Claim the Profile. NOTE: Parents are able to claim more than one profile for an account in families with multiple children, select 'New Profile'.
- 4) Parents can now renew memberships (prior year) and purchase new memberships.

RENEW AND/OR PURCHASE STEPS:

- 5) Log In (top of the screen). To renew any card under your profile, go to Memberships. This will bring up any profiles under your membership.
- 6) Select the 'Renew Now' button next to the Profile you are getting a USAW Card for.
- 7) Pick the type of Membership for Purchase – select 'Athlete Membership'.
- 8) Pick the type of Available Memberships – '\$42 – Athlete – Traditional Athlete Membership'.
- 9) Parents can choose to have a plastic (not required, just preference) USA Wrestling Card mailed to them for an additional \$10 fee or simply print the USA Wrestling Card at the completion of the purchase. This is your copy. The club will be notified through the site.
- 10) Select the Acknowledge of USA Wrestling Waiver and select 'Save & Continue to Checkout'.
- 11) Complete the transaction by selecting the 'Pay by Credit Card' button and filling in the USA Wrestling Purchases credit card fields and selecting Pay.
