 - Discussion on whether any information should be released to anyone except Board members; privacy issues stated
 - Motion by Justin and seconded by Don to restrict residents' information to Board members in order to respect privacy of all residents. Motion carried.
- Request for information on development, restrictions, and bylaw requirements for lot on southeast corner

- Boating guidelines will be distributed to all lake residents
 - Discussion on boat (lake) registration and stickers. All boats need to have sticker to provide evidence of resident/registered boat use only
 - Boat size/engine size discussed and Board reassured that guidelines will be included in the information sent to lake residents

- Discussed possible "plugging" of sprinkler lines that currently water on east side of entrance gates. Tabled until construction of roundabout and sidewalk plans are finalized
