- (ii.) persons who renewed any SIB CD in Louisiana between January 1, 2007 and February 13, 2009; or
- (iii.) any person for whom The Stanford Trust Company purchased SIB CDs in Louisiana between January 1, 2007 and February 13, 2009.



IT IS HEREBY FURTHER ORDERED, ADJUDGED, AND DECREED that Preis Gordon, APLC is hereby appointed as Class Counsel.

IT IS HEREBY FURTHER ORDERED, ADJUDGED, AND DECREED that all costs associated with the Plaintiffs' Motion for Class Certification and the hearing on Motion for Class Certification are assessed equally between SEI and OFI.
