Dues received by February 15, 2020 are eligible for a 5% discount. This applies to dues only.

Annual Dues may be paid in full, halves, or three times a year. If you choose to pay your dues by half or quarter, please follow the schedule shown below for amounts and due dates (to eliminate confusion and penalties). There is a \$10.00 fee per payment for installments. (There are no half year dues except for new members, one time only, to begin June 1 at Boards discretion.) If fees and/or dues are paid with a credit card, there will be a convenience fee of 4.0% charged.
