Tax Budget Discussion:

Lisa Morris, Fiscal Officer explained that the amount in the 2020 budget under the Police Department in question shows the revenue the Township anticipates receiving from the traffic cameras. This data was established based on the revenue from 2019. Since this is a temporary budget amendments can be made in January 2020 for the permanent budget, said Morris.

The Administrator shared that at any point the Township can submit an amendment to their budget to the County.

Police Department Report:

Byron Smith, Police Chief shared that he and the Township Administrator met with La Mega Media, Inc. at 103.1 FM (Hispanic radio station). This interview focused on how the police and the community can work together to strengthen our neighborhoods. On Thursday, August 15, 2019 from 3:00 p.m. to 7:00 p.m. there will be an event similar to a <u>Cops and Kids</u> event in the parking lot of the old Westland Mall near the La Plaza Tapatia. All are welcome. There will be activities for the kids, food, give-a-ways, etc. said Smith.

Smith stated he received notice of the lawsuit involving former officer Robert Wells. All information received will be sent to our Township attorney, said Smith.

Smith asked the Board if the police department could go back to using the hand-held speed cameras. Alex shared his concerns about the language in the new transportation bill which could impact local government funding. Fleshman asked Smith what the Township would lose in local government funding. Smith said, based on his understanding the Township could lose \$60,000.00 in local government funding but would make this money back and more with revenue from the traffic cameras. Alex asked to table discussion until further understanding is gained.

Alex made a motion to table resuming the traffic cameras until further information is obtained and an understanding is gained by the Board on the legislation outlined in the transportation bill. Fleshman seconded the motion. A vote was taken: Fleshman, yes; Horn, yes; Alex yes. The motion was passed.

Lt. Ratliff updated the Board on the renovation of the modular.

Deputy Ronk said the relationship between the FCSO and Franklin Township has improved over time. Horn asked if the FCSO is keeping an eye on an alleged drug house on Jackson Road. Ronk confirmed the FCSO is monitoring the situation and will move this to SIU as determined on activity.

Fire Department Report:

James Welch, Fire Chief asked the Board to place fire fighter Fleahman on FMLA. His exact leave date is dependent on his wife's pregnancy, said Welch.

Alex explained that all dispensaries which have been approved currently are located in the City of Columbus. Several of the locations are just outside of smaller jurisdictions such as Grandview and Franklin Township said Alex.

William Huffman, member of the audience asked the Board if the Township mandates local tire businesses to cover their used tires when stored outside. Alex answered that this is an area that Franklin County Public Health (FCPH) monitors and has a code enforcement officer. The Township also has a contract with FCSO to spray for mosquitoes as well to test for West Nile.

Huffman asked what the Township is doing to tackle the prostitution problem since the Columbus Vice has been disbanded. The Police Chief said the FCSO
