The Friends of Pennypacker Mills is a 501(c)(3) tax-exempt non-profit corporation established to support the educational programs and preservation of the Pennypacker Mills Historic Site.

Incorporated in January 2010, the Friends of Pennypacker Mills ("Friends") have accomplished a great deal so far.

### **ACCOMPLISHMENTS**

#### 2010:

The Friends funded a fence around the Children's Heritage Garden and paid for a water pump to be installed near the barn, which houses the 1900s History Center.



#### 2012:

Friends The contributed funds for the acquisition of items belonging Galusha Pennypacker, second cousin of amue 1 Pennypacker and one o f the youngest people to hold the rank of brigadier general



in the U.S. Army, to this day.

#### 2013:

For the restoration of the servants' quarters, we supported paint analysis to determine the original finish on the kitchen cabinets.

#### 2015:

The Friends funded redesign and reinstallation of the flower beds at the entrance to the mansion path using plants that were available in the early 1900s.



#### 2016-2017:

We completed our Interpretive Signs Campaign, with the installation of five signs on the site. One is located where the mill, from which the property derives its name, formerly stood.



A larger, two-sided sign has been placed near the monument adjacent to the entrance to the property.

It includes a 1900 map of the site

Two identical signs have been placed at entrances to the mowed path through the meadow.
