Imran Khan congratulates Modi

Pakistan Prime Minister Imran Khan called up his Indian counterpart Narendra Modi and congratulated him on BJP's resounding victory in the Lok Sabha elections, according to Pakistan Foreign Ministry spokesperson. Khan expressed his desire for both countries to work together for the betterment of their people, the spokesperson said. Reiterating his vision for peace, progress and prosperity in South Asia, the Pakistan PM said he looked forward to working with Modi to advance these objectives.

Khan had also tweeted his congratulations to Modi on his massive win and had expressed he was looking forward to working with his Indian counterpart for peace and prosperity in South Asia. Confirming the development, the Ministry of External Affairs said PM Modi during the telephonic conversation called for creating trust and an environment free of violence and terrorism for fostering peace and prosperity in the region. "The Prime Minister thanked the Prime Minister of Pakistan for his telephone call and greetings," it said.

Recalling his initiatives in line with his government's "neighbourhood first" policy, Modi referred to his earlier suggestion to Khan to fight poverty jointly, the MEA said. "He stressed that creating trust and an environment free

of violence and terrorism were essential for fostering cooperation for peace, progress and prosperity in our region," it added. The results of India's general elections are very significant for Pakistan as the formation of the next government in New Delhi will determine the course of Indo-Pakistan ties. The relationship between the two nuclear-armed nations has nosedived ever since the Pulwama terror attack and subsequent Balakot air strikes.

In an interview to The Indian Express, PM Modi had said the "way ahead" with the neighboring nation Pakistan depends on the action it takes against terrorism.


Balakot air strikes in Pakistan before the polls soared Modi's popularity in India. The IAF air strike and action against Pakistan featured many times during Modi's Lok Sabha election campaign.

Notably, Khan had batted for a second-term for the Modi-led BJP saying there may be a better chance of peace talks with India if the incumbent government is back.







ICC World Cup 2019: Players to watch out for - Rohit Sharma

Sharma currently holds the record for highest individual ODI score(264), which helped India to put a mammoth score of 404 on the scoreboard.

Mumbai: Gifted with hitting the ball with impeccable timing, Rohit Sharma became the most successful captain in the IPL history when he led Mumbai Indians to their fifth IPL trophy on Sunday.

With a career spanning over a decade, the Mumbaikar paved his way to the national side by performing for Mumbai in First-class cricket. Sharma was successful in scoring a double century against Gujarat in the 2006-07 season of the Ranji Trophy.

The 32-year-old broke into the international scene in 2007, when he was given an opportunity against South Africa in the 2007 ICC World Twenty20. He was a last-minute replacement for an injured Yuvraj Singh. Rohit managed to score 50 runs off 41 balls, helping India to win the game and advance to semi-finals of the tournament.

Rohit was shuffled in the team's middle-order until the Champions Trophy 2013. His career soared after he was given the chance to open the innings alongside Shikhar Dhawan. The opening pair played a prominent role to help India clinch their second Champions Trophy.

Rohit Sharma joined the league of legends like Sachin Tendulkar and Virender Sehwag by smashing a double century in 2013. But the

saga did not end there. Sharma hammered his second double century against Sri Lanka in 2014. He achieved the feat of scoring 264 runs in 173 balls, comprising 33 fours and 9 sixes.

Sharma currently holds the record for the highest individual ODI score, which helped India to put a mammoth score of 404 on the scoreboard at Eden Gardens.

Rohit was snapped up by Deccan Chargers in the first edition of the IPL, but his path shifted towards Mumbai Indians when they acquired him for 2 million dollars in 2011. Rohit made his presence felt in the Indians' dugout by scoring his first IPL century in 2012. He thrashed 109 runs off just 60 balls against Kolkata Knight Riders and was also awarded Man of the Match trophy.

Rohit's test career initiated much later than his ODI career. He made his Test debut in 2013, five years after playing white ball cricket. Sharma made an immediate impact by scoring 177 runs at Eden Gardens on his debut against West Indies. He played a crucial role in retrieving the scoreboard as half of the Indian batting line-up had collapsed at the score of 83.

Rohit's performance earned him the Man of Match trophy as India won by an innings and 51 runs. Furthermore, he hammered another ton in the next match on his home ground - Wankhede and became third Indian to score consecutive centuries in the first two tests. Rohit Sharma's career has improved drasti-



cally since he was given the responsibility of opening the innings. Rohit's biggest forte is his ability to integrate his effortless playing style while playing an aggressive knock.

One of the memorable knocks of the right-hander was against England in 2018. Chasing a target of 268, Rohit steered the team's way by smashing 137 off 114 balls, with 15 fours and 4 sixes. He managed to score two tons in the five-match ODI series.

Rohit is expected to replicate such stellar performances in the World Cup 2019. Batting traditionally has been India's strength and fans are anticipating that the opening pair of Rohit and Dhawan will work wonders on England's pitches.

Having an experience of 206 ODIs, Rohit has amassed 8010 runs in his career at an impressive average of 47.39. His illustrious ODI career also consists of 41 half-centuries and 22 centuries.

Inform About Beggars, Get Rs. 1,000 From Police

The Hyderabad police are putting beggars in rehabilitations centres in the central prisons at Chanchalguda and Cherlapally. The Director General of Prisons and Correctional Services V K Singh has announced that if any beggar is found in any part of Hyderabad, citizens can call the control room numbers 040-24511791 / 040-24527846 or the Anandashram, Chanchalguda, number 040-24414940 and report them, and get an award of Rs 1,000 from the Telangana Prisons Department.

This step was part of the initiatives being taken to eradicate begging in the city, Singh said.

He said that the department had taken up the responsibility of rehabilitating the beggars. The department had two facilities, both named Anand Ashram, at the Central Prison in Chanchalguda and the Central Prison in Cherlapally for the rehabilitation of male and female beggars respectively. So far, it had picked up 8,438

male beggars and 4,977 female beggars.

"Our proposals to extend the facilities of Anand Ashram elsewhere are pending with the government. Once we get the necessary approvals, we will start Anand Ashrams in all the districts of Telangana," he added.



PAKISTANI-AMERICAN MIT STUDENT KILLED
IN NEW JERSEY CAR CRASH

A 19-year-old Pakistani-American MIT student was killed Saturday night in a head-on crash in New Jersey when a drunk driver drove into her car after crossing over into the opposite lane.

The death of Aliza Akhtar, who was a distinguished student and recipient of a fully funded scholarship for her studies at the Massachusetts Institute of Technology,

plunged the family into grief and shocked the large community in New Jersey and New York. Members of the community expressed their heartfelt condolences over death of the bright student, who was just beginning to carve out a great future for herself.

She was daughter of political activist Naveed Akhtar Waraich, who is affiliated with Pakistan Tehreek e Insaaf party.

Akhtar's 15-year-old sister was also traveling with her, and

was treated for her injuries in a hospital.

According to Middlesex County Prosecutor's Office Aliaksandr Tsytsenia, who is 28, crossed his Mercedes over double-yellow lines on Texas Road in Old Bridge.

He was intoxicated and struck Akhtar's oncoming Toyota, who suffered severe injuries and was pronounced dead in the hospital.

Police caught Tsytsenia, who tried to escape after the accident.



Prosecutors say Tsytsenia faces charges of vehicular homicide, leaving the scene of an accident, assault by auto, and driving while intoxicated.

Saudi Arabia allows Umrah Pilgrims to visit any city during Umrah Visit

We know that Umrah Pilgrims were not allowed to visit any city other than Jeddah, Makkah, and Madina. We had been recommending since long that allowing Umrah pilgrims to visit the entire Kingdom would improve domestic tourism.

Umrah Pilgrims are allowed to visit any city in Saudi Arabia: In an earlier post, we have discussed that there are many benefits of converting Umrah Visa into Tourist Visa. Finally, it seems that authorities have given an ear to these statements as Saudi authorities have confirmed that Umrah visitors can travel to any city in Saudi Arabia.

What are the conditions? The pilgrims, however, shall stay at the Two Holy Mosques for at least 15 days. This means that they shall spend half of their stay at the Holy Mosques and a half according to their own wish.

Abdulaziz Wazzan who is the current undersecretary of the Hajj Ministry for Umrah Affairs disclosed that more than 19 million pilgrims perform Umrah every year. This year the Umrah pilgrims will be facilitated with an ease of moving to different cities of Saudi Arabia.

Umrah Pilgrims with 15 days' visa are not allowed: Those pilgrims who come to Saudi Arabia with an intention of Umrah on Umrah visa of 30 days, can move around the country yet they will have to spend 15 days visiting the Two Holy Mosques.

It also means that the pilgrims who come on an Umrah visa of 15 days would not be allowed to visit other cities as 15 days stay in Makkah and Madina is mandatory on every Umrah trip.

Religious Tourism: There are so many religious places in Saudi Arabia which everyone would like to visit. For example, people like to go to Taif to see the place where Hazrat Muhammad S.A.W. was tortured.

They want to go to Madain Saleh to see the place where Hazrat Saleh A.S. used to live. They want to go to Tabuk to see the places where Hazrat Hud A.S. and the people of Aad used to live

Moreover, wells of Hazrat Musa A.S. are also in Saudi Arabia where he spent around 10 years of his life. By allowing Umrah pilgrims to visit any city around the country, people would be able to travel each and every city in Saudi Arabia wherever they want.

Economic Benefits to the Country: It will also benefit the Saudi economy as they will spend more money in Saudi Arabia. Many new tourism companies will start operations in Saudi Arabia which would ultimately result in more employment opportunities for Saudi people. All in all, it is a good move by the Saudi authorities.

Zakat: Its Impact on Social Order

Zakat is a charity – a very special kind of it. It is designed to help the poor and needy members of the society, and more importantly, to do it in a way that influences positively the social order. The Zakat system reflects Allah’s (swt) wisdom.

Let’s be clear – the primary reason Muslims give Zakat is to comply with Allah’s (swt) ordinance. It is similar to other ordinances of performing the prayers, fasting or performing the Hajj, which have all been designated by the Prophet (S) as the Pillars of Islam. Zakat’s importance is evident also because it is mentioned more than thirty times in the Quran. Allah (swt) describes great rewards for those who give Zakat in many places in the Quran, such as [2:261], and warns of consequences for those who ‘niggardly cling on’ to the wealth [3:180].

Zakat seeks to establish a positive relationship between the giver and receiver of charity. It applies to the wealth of the giver, not to his/her income. After the wealth has been with a Muslim for one full year, he/she removes a small part of it as Zakat/charity. This is required of a Muslim without even knowing who needs the charity. The receiver of charity accepts it as his/her right under the circumstances. There is no sense of favor generated in the giver nor a sense of obligation in the receiver.

Zakat is a centrally organized activity in an Islamic state. Even Muslims living in a non-Islamic state are urged to organize Zakat centrally. It is amazing and noteworthy that, to make central administration possible, Allah (swt) Himself has spelled out that the administrators of Zakat can be paid from the Zakat funds [9:60]. The central administration also enables anonymity between the giver and the receiver. Central Zakat systems are established in many of the Muslim states such as Pakistan, Malaysia and several Middle Eastern states. In non-Muslim states, such as England, South Africa and Australia Muslim communities have also established central zakat systems, as has the Chicago Muslim community under the name “Zakat Chicago”.

One might ask, is Zakat effective in resolving the needs of the poor and unfortunate? Historical accounts suggest that it did in peaceful times. Today’s data is not available from Muslim countries to answer the question. Wealth distribution and poverty data, however, is available from many developed countries. Let’s see how our country America, for example, would fare if all Americans gave charity in the amount of 2.5% of their wealth. Below is a simplified calculation.


America’s privately held wealth was estimated in 2018 to be \$98.15 Trillion.

Wealth distribution data shows that the wealthiest 20% of Americans, 66 million of them (with America’s population at 330 million), possess 85% of the wealth, or \$83.4T.

Let’s assume that the wealthiest Americans have had their wealth for one full year, which is generally valid with some exceptions. If the wealthiest 20% were to pay 2.5% of their wealth in charity (similar to Zakat), they would be paying an amount of \$2.09T.

The poorest 20% of Americans, 66 million of them, live under the poverty line and have net negative wealth because of debt. They need assistance.

The \$2.09T of charity paid by the wealthy, distributed equally among the 66 million of poorest Americans, would provide each of them with \$31,700! That would not just be of some help to them, but would lift a vast majority of them out of poverty.

**Humbly accept people's verdict, prepare for 2020
Delhi polls:
Kejriwal to AAP workers**

Kejriwal, addressing party workers in west Delhi's Punjabi Bagh, said anti-corruption crusader Anna Hazare told him that "when one comes into politics or public life, one should have the ability to endure humiliation".

Motivating disheartened AAP workers after the party's crushing defeat in the Lok Sabha polls, Delhi Chief Minister Arvind Kejriwal Sunday asked them to humbly accept people's verdict and concentrate on the assembly elections slated for next year.

Kejriwal, addressing party workers in west Delhi's Punjabi Bagh, said anti-corruption crusader Anna Hazare told him that "when one comes into politics or public life, one should have the ability to endure humiliation" "We have to bear humiliation at times and I am proud of my workers for humbly accepting that insult," he said.

"Now, you go to the people of Delhi and tell them that the big election has ended and small elections are going to come, and in these elections, cast your vote on the basis of 'kaam' (work)



and not 'naam' (name)," he said.

The Aam Aadmi Party (AAP) lost on all seven Lok Sabha seats in the national capital by huge margins of votes Kejriwal said the party has not deviated from its principles of honesty and hard work which is its biggest strength.

"All of us are as honest as we were on November 26, 2013 when the party was formed. I am proud to say we have not deviated from the values of the party. Several CBI raids were conducted against me, Manish Sisodia (deputy chief minister) and Satyendra Jain (health minister), but corruption of not even a single paisa was found. You all should be proud of it," he said.

The chief minister asserted that all the work done by the AAP in Delhi has been due to the support of party workers and they should take pride in it.

"I can say with confidence that we got 54 per cent votes in the last assembly elections and this time we would win by more votes," he said.

Sisodia also asked AAP workers to start preparing for the 2020 assembly elections.

"The assembly elections next year will not be fought by any individual MLA or councillor. It will be contested by Team Kejriwal and our slogan will be 'ladenge, jeetenge' (we will fight and win)," he said.



Tackling Islamophobia focal point of PM Imran's maiden speech at OIC

Leaders from across the Organisation of Islamic Cooperation (OIC) met in Saudi Arabia early Saturday for the 14th session of the Islamic Summit, which follows two emergency Arab meetings the night before in Makkah criticising Iran's behaviour and influence in countries like Syria, Iraq and Lebanon.

The Muslim leaders discussed a breadth of critical issues, ranging from a spike in tensions in the Persian Gulf, to Palestinian statehood, the plight of Rohingya refugees and the growing threat of Islamophobia.

Prime Minister Imran Khan was among the leaders who spoke at the summit. The premier started his maiden speech at the OIC by raising the issue of Islamophobia: "When someone from the West blasphemed our Holy Prophet (PBUH), I always felt the response from the Muslim Ummah and OIC was lacking."

"The OIC — us heads of states — owes a responsibility to the Muslim world [...] when somebody blasphemes our Prophet (PBUH), it is a failure of the OIC that we have not been able to explain to the other countries the love and affection we feel for our Holy Prophet," said Prime Minister Imran.

"Some western countries are suffering from Islamophobia. The West should differentiate between moderate Muslim and extremist Muslim."
"The international community has to

respect the feelings of more than 1 billion Muslims," he added.

"I also want to bring up the point that the Muslim world must pay more attention to science and technology," the premier urged. "We must pay more attention to quality education and universities; an area in which the Muslim world lags. I fear the Muslim world may be left behind again and this is the best forum to raise this concern in."

He also touched upon the plight of the people of Kashmir as well as Palestine, saying Pakistan supports the two-states solution and recognising East Jerusalem as the capital of Palestine.

"The people of Kashmir must also have their right to self determination; us as a body must stand against the oppression happening with the Muslim world."

At the summit, the premier met Saudi Crown Prince Mohammed bin Salman.

The conference welcomed Pakistan's offer to host the 48th session of the Council of Foreign Ministers in Islamabad in 2021.

It commended Pakistan for its "generosity and hospitality for hosting Afghan Refugees in the past 40 years", said a statement released by the Foreign Office.



Dynasties: Who Lost - Who Won

Dynasts lost: Rahul Gandhi lost Amethi and his party lost 2019 elections badly, again. So did Milind Deora, Jyotiraditya Scindia, Deepinder Singh Hooda of the Congress. The common thread is that they are all part of famous political dynasties. Telangana chief minister K Chandrasekhar Rao's daughter, Karnataka CM HD Kumaraswamy's son and Rajasthan CM Ashok Gehlot's son also lost from the seats they contested from. Akhilesh Yadav won from Azamgarh in UP, but his wife Dimple lost from a stronghold; his party didn't fare well, either.



Dynasts won:

However, Stalin, DMK founder M Karunanidhi's son, led his party to a landslide win in Tamil Nadu. BJP's Poonam Mahajan (Pramod Mahajan's daughter) won against Priya Dutt (Sunil Dutt's daughter). BJP ally and Ram Vilas Paswan's son, Chirag Paswan won from Jamui in Bihar. Both Varun Gandhi and Maneka Gandhi of the BJP won their respective seats and so did Vasundhara Raje's son Dushyant Singh from Jhalawar in Raj-



asthan. Parvesh, former Delhi chief minister Sahib Singh Verma's son, set a record for the largest victory margin in Delhi. Jaganmohan Reddy and Naveen Patnaik, who led the parties they founded to victory in their respective states, also had powerful politician fathers.



Dynasty, performance or wave?

BJP chief Amit Shah said the mandate to the BJP had "buried the politics of dynasty". His party leaders parroted that line too. Dynasty is an electoral liability, say political commentators. However, is dynasty the reason these dynasts lost? While many dynasts in the opposition lost, some won too. Almost all those with famous surnames who contested on a BJP ticket won their respective seats. Some like Jaganmohan Reddy or Naveen Patnaik who have formed their own parties and built their own political bases won because of the hard work they put in. So what does all that add up to? Is India really saying no to dynasty or is it the politics of the day and a candidate's



own track record that sway voters?



Why the BJP still can't do without NDA

For the second successive Lok Sabha polls, the BJP has managed to cross the halfway mark of 272 seats — where it had won 282 seats in 2014, this time, it won 21 more seats to finish with 303 seats. So why does the single largest party with a majority still need to humour its smaller allies?


Beyond the Centre: There's life outside the Parliament, especially in the states where the BJP has a coalition government with one or the other ally — such as in Bihar, where it's in bed with the Nitish Kumar-led JD(U), Maharashtra, where the Shiv Sena is crucial for support despite its constant barbs in its official mouthpiece Saamna, the North East, where the BJP along with other non-Congress parties in each state formed the North East Democratic Alliance (NEDA) which is currently in power in Assam, Tripura, Arunachal

Pradesh, Meghalaya, Nagaland, Sikkim and Manipur. The BJP, which earlier had a wafer thin majority in Goa, where it's in alliance with the GFP, has now managed a majority after winning three assembly bypolls on Thursday. Even in states where it is not in power, such as in Punjab, where it's in alliance with the SAD, the BJP can ill-afford to antagonise a party that has a strong hold in a Sikh-dominated state.

Beyond the Lok Sabha: The Parliament has two houses — and while the BJP can afford to ride roughshod over its allies in the lower house, the Lok Sabha, it needs them in the Rajya Sabha to push through important legislative business such as bills, amendments and new laws. That's because the BJP has only 73 members in the 245 member upper house — the halfway mark being 123, which even after adding the allies seats, it is unable to achieve as the

NDA total comes to 102 members. Given the paucity of friends, it would make little sense to antagonise the allies.

Beyond the homilies: There's a saying — keep your enemies close, but keep your friends closer. The BJP, in the past, has been helped out by non-NDA parties such as Naveen Patnaik-led BJD and the K Chandrashekar Rao-led TRS — like last year, in the election of the Deputy Chairman of the Rajya Sabha. In fact, the BJD has indicated its willingness to join the NDA if Odisha was granted special status — and this was before the results for the



2019 Lok Sabha and assembly polls were declared. Keeping them in good humour may be politically expedient as while they may help out the BJP in times of need sometimes, they can also be of help to a mahagathbandhan if it suits them. In fact, having them part of the NDA rules out that possibility.

Be ready to quit, Jagan Mohan Reddy tells MPs

Vijayawada: YSRC president and Chief Minister-elect Y.S. Jagan Mohan Reddy has reportedly indicated to newly-elected party MPs to be ready to resign to press the party's demand for special status for Andhra Pradesh.

The new MPs who came to the YSRC Parliamentary Party meeting were shocked when Mr Reddy hinted at resignation in the first meeting.

The YSRC has 22 of the 25 Lok Sabha seats in the state. Five YSRC MPs had resigned in the previous Lok Sabha for special status.

Mr Reddy was elected leader of the YSRC Legislature Party at a meeting held at his residence. The YSRC MPs'

meeting happened later during which Mr Reddy asked the MPs to fight for special category status in Parliament.

He said the YSRC will not give up its fight. It would first try to persuade the Centre. If the efforts fail, the party would resort to all types of strategies including resignation of MPs to pressurise the Centre.

While the reference to their resignation appears to have shocked them, the MPs vowed to work to get special status.

The Parliamentary Party meeting ended without electing a leader, and the MPs asked Mr Reddy to select one among them.

Newly elected MPs thanked Mr Reddy for giving them a



chance. Bapatla MP-elect Nandigam Suresh said that he was an activist but Mr Reddy had reposed faith in him. The YSRC meeting was held in Jagan's house.

Abdullah to Hari Das in 80 Years – A Journey Through Politics of India-Gulam Samdani



It was a gloomy morning World War II was on the horizon, the combined leadership of congress under Mahatma Gandhi had declared their opposition to the war and as had become the habit of Muslim League to go against congress under the leadership of Mohammed Ali Jinnah, they decided to support the war effort in order to get a sweeter distance with the British, Rashtriya Swayamsevak Sangh (RSS) decided to keep a silence on this regards, since they adored the leadership in Germany but did not want to get on the bad side of the British.

These days were the ones that laid the foundations of political placements and desires. There was always an uneasiness in the Muslim outfits and Hindu outfits about Congress & Muslim Leagues demand of Independence. There was this sense that what would happen if British leaves, who will rule and what kind of situation would exist within India.

On the side of British, after the revolt of 1857 they matured the Indian colony to a good working system, they had realized that one of the main pain points of the Sepoy Mutiny or the First Indian Freedom Struggle was the lack of participation of Indians into governance. Towards this they started placing wealthy educated Hindus and a few educated Muslims in positions of limited authority. These positions extended from being Collector of a village, to being Judges with limited civil powers etc. Hindus in specific started getting educated more to fulfill the machine that was being developed by the British.

Muslims got their first university Mohammedan Anglo Oriental University under the efforts of Sir Syed Ahmed Khan in 1875. The general Muslims still did not support the cause of an English education, thought of as almost a Blasphemy, but it did provide a venue for the Muslims in the North of India to proceed to a degree education locally. Until now only the interested upper class Nawabs alone could afford the study in England, even they were far and few due to the backward thinking of the Muslims in the era and the stigma towards a western education.

It was very easy for Hindus to adjust to British rule compared to Muslims, since the Hindus had essentially stayed off the peak of pyramid for approximately 300 years, while the Muslims had just lost control over to the British. In many terms to the British Hindus were better subjects compared to the Muslims, who still had their false perceptions of superiority of power. At the same time for British it was a religious heart ache with the Muslims, as the closer the differences are the harder the drifts are between people.

With the beginning of Muslim education that started late, almost 40 years after the Hindus were already well educated this barrier between Muslims & British started coming down gradually at least in the upper channels of society.

Both Muslims & Hindus had got accustomed to the thought of British as their ruler by the 1900s. While the opportunity that British gave to the Indians did really help strengthen the country of India with courts, police and other systems of Governance, it also gave thoughts in the minds of educated Indians that had activist mentalities. These Indians caused the creation of parties the Congress Party established in 1885 and the Muslim League came to existence in 1906. The Original demand of Congress was limited to "Self-Governance" under the British mandate, and which was essentially answered with the Government of India 1919 Act for allowing Limited "Self-Governance" within India.

As with Human aspirations that are never confined to a limit scope of control, with the advent of Mahatma

Gandhi in 1915, it became more evident that even with the "Self-Governance" in place the lives of common Indians were not getting better. Mahatma Gandhi felt that the British needed to leave the destiny of India in the hands of Indians. The aspired path of Mahatma was in direct conflict of the Mohammed Ali Jinnah who regarded the path of "Satyagraha" as a path of Anarchy, he left Congress and joined Muslim League in 1920. In the same year Muslim League passed the Lahore resolution and demanded for a separate nation. Mahatma Gandhi's path was very much closer to reality, a path of Human need and the ability of Humans to come together to achieve a common goal of independence and self determination of destiny. Mahatma had roamed across India and understood the pulse and the pains of Indians, many like Mohammed Ali Jinnah specially the upper-class Muslim leadership of activist Nawabs in the Muslim League did not understand the pains of common Muslims. Their demand of a separate nation was more ingrained from their incapacities to relinquish pride and their inability to break bread in their minds with the fellow secular Hindu of the Congress Party.

There was reality to the fears of Muslim league, considering that Religion was the staple food of every Indian be he of any faith. On the other hand, Mahatma aspired for a great nation made of Hindus and Muslims living side by side as brothers. The same fears that engulfed the Muslim League was also a concern of Hindus that build their party representing the Hindu Right in 1925 called the Rashtriya Swayamsevak Sangh (RSS).

The Indian activist leadership was developing into a chair with 4 legs, the Congress with Secular credentials that had Mahatma Gandhi, Nehru, Abdul Kalam Azad representing the United India Movement, the Muslim League under Jinnah with the desire for a separate Muslim nation, the Hindu Right Rashtriya Swayamsevak Sangh founded by Keshav Baliram Hedgewar with the interest in building a Hindu Nation a desire to bring back the glory to India as a Hindu state and there was a fourth leg a small but very activist leg the Communist Party of India established in 1925.

The problem with Muslim League, Rashtriya Swayamsevak Sangh were their high-flying desires, it was more like the seed was not laid in the field, but they were talking about what type of bread will baked from the wheat that comes from the ground. The Communist Party of India had the most valiant of activist, their ideologies rang bells only in the hearts of the most Human among the Indians at that time. This gave Indian National Congress the upper hand towards being the most realistic approach to the conversations of India's future.

People were more impressed by the approach of Mahatma of demanding independence via non-violence because a working Indian with family to take care of could demand but did not have that strength of going completely against the powerful British by violent means. People had lives to live and Mahatma gave them the path where they could keep demanding. The other angle of Mahatma's non-violence was the incapacity of the ruling British to suppress with violence a non-violent demand. They did use in certain case undue violence to suppress these non-violent meetings but the British officers that committed those oppressive tactics were quickly slapped on the wrist by the upper administrations of the British like the case Jallianwala Bagh a massacre done by General Dyer.

While Muslim League was patronizing the Nawabs towards the partition of country to retain their lifestyle and power, there was Maulana Abdul Kalam Azad an

ardent supporter of Mahatma Gandhi's style of outreach of brotherhood. As his name reflected he was an Azad of thought right from his teenage years. Gone through his trysts

in spirituality he had become a far more Human than anyone else and understood that the Human brotherhood of Muslims and Hindus could alone salvage and help this great nation of India. Maulana Abdul Kalam Azad walked besides Mahatma Gandhi taking with him many common Muslims that were more interested in their daily lives and their economical problems due to the British rule.

All these reasonable attitudes to nation building and independence gave the center stage to Indian National Congress when the British finally decided to leave India. From 1929 to 1947 British used to the fullest both Muslim League and Rashtriya Swayamsevak Sangh to inlay the ideals of a Muslim/Hindu state and hate, there was deep desire to cause the failure of the approach of Mahatma Gandhi of a united struggle with the British.

At the pre-night of independence, Indian National Congress tried hard to convince Muslim League of the fallacy of the partition, the unreasonable demand that would cause millions of Muslims and their Hindu brothers into a disarray. The minds of Muslim League were so engrained into the partition that no reasoning of the pain that Muslim population would have to endure could convince the Muslim League otherwise. Rashtriya Swayamsevak Sangh on their side felt that giving the Muslim League what they wanted would allow the path of a Hindu nation. Sadly, for them this was not a picture that took shape because of their lack of participation in the political process and because they remained on the sidelines of activism in the Indian Freedom Struggle. They the RSS had support among certain sections of the Hindus religious right, but they did not have that level of connection to claim a hand at Governance.

The pain that India had to go through during the partition can never be realized by people of today. Thanks to the blind ambitions and impractical demand of Muslim League and Jinnah, Muslims of India were left Leaderless because all the leadership of the Muslims left the people they used to guide from the Muhallah nukkar and the great gatherings for the separate nation. Riots ensued, due to many misunderstanding and the pain of partition, helplessness the leaderless Muslims clashed with the Hindus in vain. Streets burnt, cities burnt, this was not the picture the Great Mahatma Gandhi with all his flaws had envisioned, he wanted a Hindu brother to live with his Muslim brother peacefully.

Mahatma Gandhi with Maulana Abdul Kalam Azad on his side started travelling around the country trying to establish peace and talk to communities. These efforts of Mahatma and Maulana Azad helped, and peace eventually returned to the streets. While Nehru and Sardar were establishing governance using the able structures left by the British, Baba Saheb Ambedkar started working the Constitution committee.

On the fateful day of January 30th, 1948, Mahatma was shot by Nathuram Godse. The whole country fell into a shock. How could this happen? Yes, when the religion over rides a person's humanity no Mahatma can survive those flames of hatred that religion can aspire among certain people.

The country had lost its father, a father that dreamed of peaceful co-existence. The dream that the wall of Partition breaking down died with Mahatma Gandhi.

Congress under the able leadership of Motilal Nehru, Lal Bahadur Shastri, Sardar Vallabh bhai Patel United the rest of India. India after independence still had princely states like the Jaipur Riyasat, Hyderabad State and Madras State, three large kingdoms that the British had favored to stay in power as these kingdoms had developed a shared power structure with the British. Getting the Rajas into the Indian Union was not easy, the credit goes to Sardar the Iron man of India. His intelligence and prowess got him the tile of Iron man of India.

India was united under the leadership of Indian National Congress. Sardar Patel as home minister of India put a ban on Rasthriya Swayamsevak Sangh activities in February of 1948, which was lifted in July after under Gowalkar's leadership, it was promised that RSS would undertake its loyalties to the Indian Constitution.

In 1966 due to the untimely death of Lal Bahadur Shastri while in Tashkent caused the coming of Indira Gandhi to power.

The era of Indira was not the era that Nehru and Lal Bahadur Shastri entertained. Indira tried on being an Iron Lady. She believed in having followers and not a participatory, conciliatory government, her style of governance grew her more enemies and discontent spread around the governance structures. She then landed into a rift with the Judiciary over the powers of parliament, and the ability of parliament and her to make sweeping rulings of fundamental rights of people. When discontent grows and when participation is not the norm, the first thing that suffers is the economy. Between 1975-77 Indira put an emergency within the country, this is most surprising considering that she grew up in the British era, saw her father and Mahatma Gandhi get arrested by the British. Sometimes people tend to absorb and appreciate the capacities of the oppressors and become oppressors themselves.

Her Iron hand brought forth the atmosphere of discontent and within this era came the joining of Bharatiya Jana Sangh (1951-1977) a silent political wing of the erstwhile Sangh Parivar the Rashtriya Swayamsevak Sangh into Janata Party, RSS had been all these years actively building a base of activists, followers at the same time keeping their promise to be loyal to the constitution.

The Iron hand of Indira and her ego gave the right spark needed to present a need for an alternate leadership within India, Indian National Congress had lost its glorious understanding of what being a people's party meant and instead became a party of Indira Gandhi and family.

Discontent was ripe within the country, though after Indira lost the election after the emergency, she quickly gained power back in 1980. This was partly due to the underlying system she had set up and partly due to the incapacities of the alternate front to come to a working relationship. The other reason for the collapse of the Moraji Desai 1977-79 government was the Rashtriya Swayamsevak Sangh relationships. Some important leaders within the coalition also linked to RSS did not like the introduction of the rule that a person cannot be part of two organizations at the same time. In 1980 Indira came back to power with her ever expansive ego, it seemed at this point she had completely taken up the persona of the Oppressors that her father non-violently fought to uproot from India. In one such outings of her oppression she opened the doors of legal oppression of an Indian government on Indians. This was operation BlueStar a first official mass scale oppression and killings of Sikhs by the security forces under the command of Indira Gandhi.

Indira and her son Sanjay represented the new era of Indian oppression by an Indian government. Sanjay launched the campaign to force euthanize Indian men.

Sanjay lost his life to a plane accident. And with her un-relinquishing thirst for power and lack of capacity to bear opposition caused her death in 1984. Day by day India realized the party of Mahatma had gone far and far from the Mahatma that the party idealized, it was replaced by an egoistic family that felt that they were the center of the Indian Universe and the members of the party thought of the family as the sun and the moon. Though Janata party never realized again to full power like 1977, the true power behind it the Bharatiya Jana Sangh shaped into Bharatiya Janata Party in April 1980 under the leadership of Atal Bihari Vajpayee.

After Indira's death killed by her own security guard, her son Rajiv Gandhi took power and while he became the Prime Minister, the angry activists of great national party of Mahatma Gandhi, Nehru launched into the streets killed and raped Sikh communities across the North.

Rajiv was not arrogant like his mother or like his big brother, but he had some real dirty politics up his sleeve, he was good at that. He played two cards that laid the foundation for religious politics within India, first was towards the Muslims in the Shaherbano case he intervened and made a law that over-ruled the Judgement of the courts to provide alimony to Shaherbano from her husband, siting the dictate that Indian constitution should allow for religious freedoms. The second card he played was to open the doors of the opening of the doors of Babri Masjid for the Hindu populous, these were locked up in 1948 and only a yearly pooja was conducted before this point.

Congress gave some great gifts to Sangh Parivar, which gave the Hindu Right an opportunity to stake claim and provide an alternate ideology, a force of hope for the country. Firstly, the nature of rule by Indira and Sanjay made the country aware that they needed to stand up now to the legacies that once liberated them, then the period of Rajiv Gandhi showed them how they could manipulate the Indian mind with religion that now religion was going to be the dice in the game. The downfall of the Congress ideology and loss of secular credentials of India completely rests on the heads of the three Gandhi's Indira, Sanjay and Rajiv. This was followed by a brief stint by Prime minister PV Narasimha Rao from 1991-95, his years saw a revolution in Indian economy by opening the doors to foreign investment, but also was mired by his ineffectiveness in stopping the destruction of Babri Masjid in 1996. PV Narasimha Rao sealed the deal that the Gandhi's started and laid the ideal that it was OK for Indians to destroy and take law in their own hands.

Slowly and steadily Rashtriya Swayamsevak Sangh, headed by its political wing Bharatiya Janata Party started laying out the political gains with the very nationalistic credentials of "Nation First" from the panchayats to the localities, to the Lok Sabha. Day by day the dream of Hindu Rashtra seemed nearer. Atal Bihari Vajpayee ruled effectively from 1996 through 2004. There were many credits to Atal Bihari Vajpayee's rule. Towards the end of his rule in 2002 the unfortunate Godhra happened in Gujrat, a misunderstanding and an accident at a train station between religious groups created riots and thousands died. A fate similar to 1984 after the death of Indira came upon Muslims within Gujrat. The then Chief Minister of Gujrat Narendra Modi who is the first prime minister from BJP to win a second term is credited with the inability to handle the situation and control the riots of 2002. Everyone can remember the words of Shri Late Atal Behari Vajpayee reminding the Gujrat state government of their Raj Dharma.

From 2004-2014 the Congress Party under Manmohan Singh ruled for two terms. Manmohan Singh an able

person without ego and need of praise for himself led a coalition government successfully for 2 terms. He is probably the first noble prime minister from the Congress party after Lal Bahadur Shastri. Sadly, the party and the coalition were mired with puppeteering by Sonia Gandhi and the party leaders that wanted to continue the family legacy, there were scams and scandals involving different coalition partners.

In 2014 the party anointed Rahul Gandhi as the party prime minister candidate, a person who at the time could not provide straight interviews or answers. The party and the coalition received massive defeat.

The Sangh Parivar decided to field Narendra Damodardas Modi as the real unapologetic Sanghi Prime Minister, skipping Advani the second in command to Atal Bihari Vajpayee. Truth or perception the years since 2014 has seen many vigilantism-based incidents within India in which the Minorities including Muslims and Lower caste people being man handled, some died going through the actions of the Hindu Vigilante groups.

Vigilantism though a common attribute among the Indian persona of taking law in their own hands, on the other hand it now seemed to have an official face and power. It seemed legitimized. The parties like Congress and others did not leave any opportunity to reflect this to be an official command of the Prime Minister Narendra Modi and his own ideology. Though no proof exists to directly blame Narendra Modi, but the flexibility of Bharatiya Janata Party to allow the extremist ideologue people in the party keeps bringing the question to the front. What does the Prime Minister think of this? And How does he plan to stop this Vigilantism?

Muslims on their part are challenged day and night with the idea that they are being led by a person who did not effectively react to the killing of thousands of Muslims in Gujrat, but then Sikhs on their end went through the same during the very egoistic era of the Gandhi's.

Its been a long journey for the Rashtriya Swayamsevak Sangh from being held responsible to the killing of Mahatma Gandhi to winning a second term to rule the Great Country India.

A dream RSS saw in 1925 fulfilled with hard work, activism, from 2014 onwards they sit on a comfortable and defined seat with a proper majority within the Parliament. We all hope that the power they have got with so much hard work and sincerity be used to establish the moto of the Prime Minister "Sabka Saath, Sabka Vikas" with an add-on from yours sincerely "Sabko Nyay, Sabki Raksha" through proper implementation of the idealized Rama Rajyam within this great country.

'Rich Muslims' expense on Umrah, marriage can teach 3 lakh poor Muslim kids for 18 yrs'

With 120 million Indian Muslims living on Rs 67 a day, scholars want rich community members to spend less on lavish weddings, multiple pilgrimages. Faizur Rahman, an Urdu-speaking native of Chennai, is an executive committee member of Harmony India, an organisation to promote secularism and communal harmony which is headed by N. Ram, the Editor-in-Chief of The Hindu. He is also the founding secretary of Forum for the Promotion of Moderate Thought in Islam.

Sharing his experiences with this writer, Rahman says, he has lost count of the number of public forums (and private discussions) he has used in the last two decades to speak out against baseless ritualism and extravagance (israaf) in Islam.

Dr M. Aslam Parvaiz, author and scholar, is the Vice Chancellor of the Maulana Azad National Urdu University, Hyderabad. Both Rahman and Parvaiz have been traveling all-round the country, interacting with Muslim community leaders with a plea to cut down spending on lavish marriages and Umrah.

Umrah is a "minor pilgrimage" undertaken by Muslims whenever they enter the holy city of Makkah. In Islam, it is optional for Muslims to perform Umrah. Its similarity to the major and obligatory Islamic pilgrimage "Haj" has made some fusion of the two natural, though pilgrims have the choice of performing the Umrah separately or in combination with the haj.

These scholars are self-confessed practising Muslims and not against Umrah per se. They say they only wish to create awareness among Muslims that Umrah not being an obligatory ritual in Islam one need not perform it every year. Instead that money may be used for the socio-economic development of our community at a time when it desperately needs it.

As per the National Commission for Enterprises in Unorganised Sector (NCEUS) report of 2007, 84% of the Muslim population of India lives on a daily income of less than Rs 20. Now, 12 twelve years later, this figure may have gone above Rs 20.

According to the Socio Economic Caste Census 2011, there are 24.39 crore households in India, and 17.91 crore of them are in rural areas where the main earning member makes less than Rs 5,000 a month. Only 8% of the rural households have a member earning more than Rs 10,000 a month. Put differently, if a household has four members the amount available for each member (at an average of Rs 8,000 per month) is just about Rs 67! For the Muslims in India, this would mean that more than 120 million of them are forced to live on less than Rs 70 a day! Therefore, is it not the duty of wealthy Muslims to remedy this situation? they ask.

Rahman says he has received a mixed response from national level organizations such as the All India Muslim Personal Law Board (AIMPLB) who have maintained a stoic silence on these issues. However, some Muslim organizations and moulvis (priests) in Chennai, have expressed outrage against Rahman's liberal and philanthropic interpretation of Islam. "In their blinkered view, asking Muslims to stop spending money on non-obligatory pilgrimages amounts to a blasphemous denial of Islamic practices," Rahman said.

Rahman says he has also received quiet support from a few madrasa-based religious scholars. One such 'maulana' went on to write an article in an Urdu magazine against wasting money on umrahs and multiple Haj. Maulana Hafizur Rahman Azami Omeri wrote a piece in Two Circles, a prominent web portal addressing Muslim community issues. Omeri argues that as per Hadees (sayings of Prophet) in Bukhari when Hazrat Bibi Aisha (Prophet's wife) asked as to which among two neighbours deserves our benefaction when resources are limited, the Prophet answered: "The one whose door is nearest to you."

Omeri insists that in Islam Huqooqul ibaad (humanitarianism) has been given precedence over Huqooqullah (duties towards God). He quotes an "eye-opening" statement from Imam Ghazali on multiple Haj wherein the Imam laments, "These rich people are very fond of spending their

money on the Hajj. They perform the Hajj again and again sometimes even at the cost of their neighbours suffering in hunger. Abdullah ibn Mas'ud was absolutely right when he said: 'During the last days of the world there will be a surfeit of people performing the Hajj unnecessarily. The journey will appear easy to them and there will be no shortage of funds. But they will return from the Hajj poorer without any real benefit. They will be travelling over deserts and open ground while their neighbour will be suffering deprivation. Neither will they empathise with him nor will they display civility.'

As per records, 4,48,268 Muslims applied for Haj in 2017. Rahman takes this as a sign of 4,50,000 Muslims having the capacity to spend around Rs 2,50,000 every year on pilgrimage. This works out to more than Rs 10,000 crore. "If we add to this amount the money Muslims annually spend on non-obligatory Umrah, we get the figure of almost Rs 15,000 crores! Even if a small portion of this amount is to be diverted for humanitarian causes, it will come under the definition of effective altruism which, by the way, is not out of sync with the egalitarian teachings of Islam," insists Rahman.

He argues that if any Muslim is asked for his reasons for performing Umrah, the reply will invariably be, 'for sawaab' (divine reward). But more 'sawaab' can be gathered right here in India by helping a needy person at half the price of an Umrah, pleads Rahman.

As per a conservative estimate, over 250,000 Muslims travel to Makkah and Madina for Umrah every year. And the average cost of the entire trip is around Rs 1,40,000-2,00,000. Therefore, the annual amount spent by Indian Muslims on Umrah alone works out to a whopping Rs 4,100 crores! In comparison, the amount allocated in the 2017-18 budget by the Government of India to the Ministry of Minority Affairs was Rs 4,535 crore.

Muslims spend a lot of money on marriages every year. In fact, a lot more than what they spend on the annual Umrah. Just look at statistics given below.

Minimum guests from the Bride's side — 300
 Minimum guests from the Groom's side — 300
 Minimum cost of the Nikah feast for 600 guests @ Rs 200 per guest — Rs 1.5 lakh
 Minimum cost of the Valima feast for 600 guests at the same rate — Rs 1.5 lakh
 Average money spent on jewellery by bride's side — Rs 2 lakh
 Average money spent on jewellery by groom's side — Rs 1 lakh
 Cost of renting the function hall for Nikah — Rs 1 lakh
 Cost of renting the function hall for Valima — Rs 1 lakh
 Misc. expenditure on decoration etc — Rs 50,000
 Total average expenditure of one wedding comes to Rs 8 lakh.

In a total Muslim population of about 180 millions, assuming that at least 150,000 (less than 0.001 per cent of 180 million) middle class weddings take place in a year in India, the total money spent by the Muslim community per year on weddings is: 150,000 weddings multiplied by Rs 6.4 lakh which equals Rs 12,000 crores. Add to this, the Rs 4,100 crore spent on Umrahs and another Rs 1,000 crore on multiple Haj. In other words, Muslims in India spend a minimum of Rs 17,100 crore per year on extravagant weddings, non-obligatory pilgrimages.

Let us now see how much it costs to educate a child. At an average annual fees of Rs 10,000, the cost of educating a child from LKG to 12th standard is 14 years x 10,000 = Rs 1,40,000. For 4 years of technical education @ Rs 1,00,000 per year = Rs 4,00,000. Total cost is Rs 5,40,000.

Dividing 17,000 crore by 540,000 we get 3,14,814. This means, more than three lakh poor Muslim children can be educated for 18 years on the money spent in just one year by the rich Muslims on non-obligatory pilgrimages.

Dr Parvaiz, an accomplished scientist who has been editing and publishing a monthly journal in Urdu,



Science, for the last over 25 years, has been relentlessly speaking at various forums requesting the Muslims to concentrate on Huqooqul ibaad for the moment as the condition of Muslim community is very bad. Allah is not in need of our Umrahs or multiple Hajs. But our Ummah (community) is in desperate need of humanitarian help, Dr Parvaiz argues. He quotes that one who does not take care of orphans and does not arrange and motivates others also to feed displaced people has belied his Deen Islam (Qur'an 107:2-3). Any contribution towards this would be worth several hundred times the sawaab of an Umrah or a second Haj. In this context, Dr Parvaiz draws attention of Muslims towards a hadith in Bukhari in which the Prophet said; "One who strives for the widows and the poor is like the one who strives in the way of Allah. I shall regard him as one who stands up for prayer without rest and as one who fasts without break."

For ages Muslims have been shielded from new ideas in the name of taqleed (sectarian conformism), and ijhtihad (liberal interpretation of Islam) is discouraged," argues Rahman adding, "In my view, Muslims will be certainly open to religious liberalism if they are not burdened with the fear of a clerical backlash. It is not that Muslims do not realise the need for pulling their community out of poverty and illiteracy. They do, and also have the money to embark on such a mission."

Going by this school of thought, it is not because of lack of viable models of philanthropy among Muslims that money is not reaching the genuinely deprived. Rahman states: "It is the lack of a philanthropic mind-set which is the cause. If anything can change this mind-set it is the widespread dissemination of a counter-narrative that can challenge and neutralise the anachronistic sermons emanating from most Muslim pulpits."



Trolled for decrying attack on Muslim, Gautam Gambhir stands firm: I live in black & white

A senior leader also said Gambhir should have refrained from the tweet given that “investigation is still underway and facts are being ascertained”.

Facing a backlash on Twitter after describing the alleged attack on a Muslim man in Gurgaon as “deplorable” and urging authorities to act, newly elected BJP MP Gautam Gambhir told The Indian Express that “trolls and critics are not a problem” and he will “continue to live in black and white”, and that “it is easier to say the truth rather than hide behind the froth of falsehood”.

Reacting to the alleged attack on 25-year-old Mohammad Barkat Aalam, who said his skull cap was thrown on the ground while he was returning from a mosque Saturday, Gambhir, elected MP from East Delhi, first tweeted: “In Gurugram Muslim man told to remove skullcap, chant Jai Shri Ram. It is deplorable. Exemplary action needed by Gurugram authorities. We are a secular nation where Javed Akhtar writes ‘O Palan hare, nirgun aur nyare’ and Rakesh Om Prakash Mehra gave us the song ‘Arziyan’ in Delhi 6.”

The tweet generated over 4,500 comments, with several people asking why he was “being selective” by responding to an attack on a minority community member. Three hours after his initial tweet, Gambhir posted another: “My thoughts on secularism emanate from honourable PM Narendra Modi’s mantra ‘Sabka Saath, Sabka Vikas, Sabka Vishwas’. I am not limiting myself to Gurugram incident alone, any oppression based on caste/religion is deplorable. Tolerance and inclusive growth is what idea of India is based on.”

Speaking to The Indian Express, Gambhir said: “Having been a cricketer, criticism is not new for me. I am used to it. So trolls and critics are not a problem. Having played sports which is governed by definite, I will continue to live in black and a white. Somehow have never

liked greys, in fact you won’t find a grey in my wardrobe too. It is easier to say the truth rather than hide behind the froth of falsehood.” “By inclusiveness, I mean a growth that takes everyone along. Like our PM, Mr Modi said, ‘Sabka Saath, Sabka Vikas and Sabka Vishwas’. How will you win the trust of everyone if they don’t feel safe? And that too just for practising one’s preferred religion. And like I also said, my views are not restricted to Gurgaon incident but it is a blanket point of view on lynchings, hatred and any kind of oppression.”

Senior leaders in the party acknowledged that Gambhir’s comments did not go down well with a section of his partymen in Delhi, who felt he “spoke out of turn, especially given that Haryana is a BJP-ruled state and assembly elections are just months away”. A senior leader also said Gambhir should have refrained from the tweet given that “investigation is still underway and facts are being ascertained”. He said such remarks give ammunition to the Opposition to target the state government.

Officially, too, the BJP took a different stand than Gambhir, with party spokesperson Tajinder Pal Singh Bagga tweeting: “Some people are trying to give a communal colour to the internal argument in Gurgaon. Giving every fight between two groups a Hindu-Muslim angle is politics of dividing the nation. In the call that was made to the police by the Muslim party, there was no reference of Hindu-Muslim. Later on it has been given a Hindu-Muslim colour.” When contacted, Bagga maintained that the incident was being given a communal colour.

Delhi BJP chief Manoj Tiwari said Gambhir had reacted with “innocence” on the matter. “We believe in our PM’s motto of Sabka



Saath, Sabka Vikas and Sabka Vishwas. In this matter, all I can say is that police should investigate and find the truth,” he said. “However, I would like to caution people of our country that now that our party has come to power, a section of people will try to paint things with a communal angle. People should be alert, and not fall for such things.”

Delhi BJP vice-president Rajiv Babbar, who was also looking after Gambhir’s campaign, said people were reading too much into the tweet. “It is a simple tweet asking for action from the authorities,” he said.

ED grills Nowhera Shaikh, 2 others for Rs 3,000 crores fraud

Hyderabad: The Enforcement Directorate (ED) grilled Nowhera Shaikh, Molly Thomas and Biju Thomas in connection with the 24 entities and 182 bank accounts through which the Rs 3,000 crores that they had collected from 1,72,114 investors was diverted.

The ED sleuths had arrested the trio under the Prevention of Money Laundering Act (PMLA), 2002, in a fraudulent money circulation scheme of the Heera Group, Hyderabad.

During the course of the ED investigation, so far, it has been revealed that the accused persons and their group companies had collected the money from investors across India on the pretext of investment. The accused were produced before the Metropolitan Session Judge, Hyderabad which sent them to seven days of enforcement custody.

The ED has initiated investigation under the PMLA on the basis of FIRs registered by the Telangana Police against Nowhera Shaikh, Molly Thomas and Biju Thomas and Heera Group of companies.

Deposits were collected from victims in Hyderabad, Telangana, Andhra Pradesh, Kerala, and other states in India and also from NRIs in UAE, Saudi Ara-

bia and other Middle East countries. Investigations revealed that the group companies did not have any actual business activity through which they could earn the promised profits/returns.

According to investigation, Nowhera Shaikh and others diverted the collected amounts to their personal accounts through their company bank accounts/benamis for wrongful gain and amassed huge movable and immovable properties. Nowhera Shaikh opened 24 entities under Heera Group and 182 bank accounts were opened in different banks in various places in the country in the name of these 24 entities. Further, 10 bank accounts were also opened in foreign countries such as UAE, Saudi Arabia etc.

Biju Thomas, MD of Suvan Technologies Solutions India Pvt Ltd, Kerala, developed the software for the Heera Group of Companies and all the account details were maintained by his firm. Molly Thomas worked as the PA to Nowhera Shaikh and assisted



her in carrying out the criminal activities.

The ED is questioning the accused in connections with their different companies, bank accounts and multiple properties identified across the country.

Nowhera claimed that she was being harassed and that the cases booked against her and the group were false.

How Amarinder Singh held his fort against Modi wave

Punjab proved to be the only face-saver for the Congress in the parliamentary elections in north India, with two-time Chief Minister Captain Amarinder Singh securing victory for his party in eight out of the state's 13 Lok Sabha seats.

Defying the Bharatiya Janata Party's (BJP) anti-dynasty tirade, the Punjab Chief Minister managed to secure a fourth term for his wife Preneet Kaur from Patiala. Preneet Kaur defeated her Shiromani Akali Dal-BJP combine's Surjit Singh Rakhra by record margin of 162,718 votes.

However, Amarinder Singh has let it be known that he is not satisfied with his party performance in state's urban pockets. Without mincing words, he even recommended a change in the portfolio of Local Bodies Minister Navjot Singh Sidhu to ensure speedy compliance of development projects.

The Chief Minister said the urban vote bank had been the backbone of the Congress in Punjab but Sidhu's failure to do any development work had impacted the party, which

had performed well in the rural areas this time.

Ahead of the elections, he had categorically told his ministers and legislators to work for party candidates, failing which there may be repercussions on the composition of the Cabinet.

Political observers believe Amarinder Singh used his former Army background to effectively counter Prime Minister Modi's nationalism and national security agenda and it worked in his favour because fellow 'faujis' (army-men) associated with his message. His promise of a memorial in Bargari for the 2015 Behbal Kalan and Kotkapura firing victims also put the former SAD-BJP combine government in a spot. And shrewd Amarinder Singh time and again raked up the sacrilege incidents during the elections.

"The poll results clearly indicate the voters have not forgotten sacrilege incidents that hurt the sentiments of the Sikhs during the SAD-BJP government stint in 2015," a political observer told IANS.

His handling of the issue of the 1984 riots, by condemning it publicly, also helped counter the polarisation of votes



Some political observers feel this trio may dig up old cases against Mr Naidu to create further problems for him in the coming days. The YSRC has alleged corruption in various issues concerning Mr Naidu.

In recent times, Mr Naidu has distanced himself from several political parties and bureaucrats. At national level

he made strenuous efforts to prevent a second coming of Mr Modi Minister by trying to form an anti-BJP coalition. He took on the Election Commission as well. His remarks about AP Chief Secretary L.V. Subramanyam, who was appointed by the Election Commission, were not well received in the top echelons of the bureaucracy.

How Mr Naidu will face these problems will be interesting to watch. His immediate task will be to prevent his party MLAs from defecting and persuade party leaders and cadre to stay with the party for the next five years. In recent days defections have become common in every political party. It's a boon to Mr Naidu that Mr Reddy will not admit any MLA into his party unless he resigns from the Assembly. Many may not be ready to do this after spending huge amounts of money to win the seat. To spend more money to win a byelection may not suit the MLAs. Mr Naidu had



admitted about 23 YSRC MLAs into his party and made some of them ministers

Margin fell at Harish's Siddipet too: KT Rama Rao

He said that national leaders like Rahul Gandhi and former prime minister H.D. Deve Gowda had also lost the election

Hyderabad: TRS working president K.T. Rama Rao said on Tuesday that he was not prepared to accept that he did not perform his job well, which led to the party's losses in the Lok Sabha elections in the state. He said he did not feel that he had failed as working president.

He was speaking informally with mediapersons in the backdrop of the party's defeat in the Lok Sabha election at Karimnagar, which he oversaw, and Nizamabad, and the victory by three lakh votes at Medak where party leader T. Harish Rao was incharge.

Asked about the Medak result, Mr Rama Rao said that though the party had won with a huge majority, the lead of the TRS had decreased in Siddipet, which is represented by Mr Harish Rao. Mr Rama Rao also said there was no truth in the talk that Mr Harish Rao was sidelined. On the defeat of Ms K. Kavitha from Nizamabad, he said that the large number of farmers contesting from the constitu-

ency were not the reason for the loss. Those who filed the nominations were not farmers, but political leaders, he said and alleged that the Congress and BJP leaders had colluded in the election.

"Don't forget that Kavitha is the daughter of a fighter. I and Kavitha had faced many setbacks in the past and one defeat would not demoralise us," he said.

Maintaining that there were several factors and reasons behind the victory of the BJP and defeat of the TRS in certain seats, he said even the BJP leaders would not have thought that they would win Adilabad. The BJP got 50,000 votes in Sircilla segment in the Lok Sabha polls but only 3,000 in the Assembly elections in December, he pointed out. He said that national leaders like Congress president Rahul Gandhi and former prime minister H.D. Deve Gowda



had also lost the election.

He pointed out that there would have been no difference even if TRS would have won all 16 seats as the BJP got a majority on its own.

Azim Premji Pledges Donations Worth Rs. 53,000 Crore, People Call Him 'Corporate Robin Hood'

India's second-richest man, Azim Premji, on Wednesday gave away 34 per cent of his shares in Wipro Ltd to charitable causes, cementing his status as the most philanthropic Indian. He has earmarked economic benefits of shares worth Rs 52,750 crore, for his foundation involved in philanthropy, according to a statement. With this, the total value of the endowment corpus, which supports Azim Premji Foundation's philanthropic activities, contributed by Premji has swelled to a staggering Rs 1.45 lakh crore, which includes 67 per cent of economic ownership of Wipro Ltd, it said.

"He has done this (contribution) by additionally earmarking all economic benefits for philanthropic purposes, in approximately 34 per cent of the shares in Wipro Limited (current market value Rs 52,750 crore), held by certain entities controlled by him," according to the statement by the Azim Premji Foundation.

Social media was abuzz with praises for the philanthropist with some calling him 'corporate robinhood' This is in addition to his earlier donations to philanthropy, which included Wipro's shares, as well as other assets owned by him.

The promoter holding in Bengaluru-based IT services giant Wipro Ltd stood at 74.3 per cent as on December 2018.


The Azim Premji Foundation works in education in the country and supports other not-for-profit organisations working in some specific areas through multi-year financial grants.

"The Foundation's extensive field work in education has been in some of the most disadvantaged parts of India, to help contribute to the improvement of quality and equity of the public (government) schooling system," it added.

Ancient seawater dating back to Ice Age discovered in Indian Ocean

In a first, scientists have discovered the remnants of seawater dating back to the Ice Age, tucked inside rock formations in the middle of the Indian Ocean

In a first, scientists have discovered the remnants of seawater dating back to the Ice Age, tucked inside rock formations in the middle of the Indian Ocean.

Researchers from the University of Chicago in the US made the discovery on a months-long scientific mission exploring the limestone deposits that form the Maldives.

The ship, the JOIDES Resolution, is specifically built for ocean science and is equipped with a drill that can extract cores of rock over a mile long from up to three miles beneath the seafloor.

Then scientists either vacuum out the water or use a hydraulic press to squeeze the water out of the sediments. "Previously, all we had to go on to reconstruct seawater from the last Ice Age were indirect clues, like fossil corals and chemical signatures from sediments on the seafloor," said Clara Blattler, an assistant professor of geophysical sciences at the University of Chicago.

"But from all indications, it looks pretty clear we now have an actual piece of this 20,000-year-old ocean," Blattler said in a statement.

The scientists were actually studying those rocks to determine how sediments are formed in the area, which is influenced by the yearly Asian monsoon cycle.

However, when they extracted the water, they noticed their preliminary tests were coming back salty — much saltier than normal seawater. "That was the first indication we had something unusual on our hands," Blattler said.

The scientists took the vials of water back to their labs and ran a rigorous battery of tests on the chemical elements and isotopes that made up the seawater.

All of their data showed that the water was not from today's ocean, but the last remnants of a previous era that had migrated slowly through the rock.

Scientists are interested in reconstructing the last Ice Age because the patterns that drove its circulation, climate and weather were very different from today's. Understanding these



patterns could shed light on how the planet's climate will react in the future.

"Any model you build of the climate has to be able to accurately predict the past," Blattler said.

For example, she said, ocean circulation is a primary player in climate, and scientists have a lot of questions about how that looked during an Ice Age.

"Since so much fresh water was pulled into glaciers, the oceans would have been significantly saltier — which is what we saw," Blattler said. "The properties of the seawater we found in the Maldives suggests that salinity in the Southern Ocean may have been more important in driving circulation than it is today

Muslim representation increases to 27 from its lowest margin in previous Lok Sabha

Muslim representation in 17th Lok Sabha has increased by five taking the community's tally to 27 from 22 in the outgoing Lok Sabha with the BJP getting its lone Muslim face as Saumitra Khan, who won from West Bengal against Chief Minister Mamata Banerjee's Trinamool Congress.

Most of the winning candidates are from opposition parties while only one candidate of the Bharatiya Janata Party (BJP) which won 303 out of 542 seats across the country, could make it to the Lower House.

Saumitra Khan is the lone BJP MP in the current Lok Sabha while Mahbub Ali Kaiser is the Lok Janshakti Party's (LJP) winning candidate from Khagaria in Bihar. Both will be representing the ruling National Democratic Alliance (NDA) in the Lok Sabha.

Muslim representation in the 16th Lok Sabha had dipped to its lowest so far at 22. In 15th Lok Sabha, 33 members of the community were elected. The highest number of Muslim MPs in the Lok Sabha was in 1980 when 49 members of the community were elected. The BJP had fielded six Muslim candidates. Khan, a former Trinamool Congress member who switched to the BJP ahead of the polls, won from Bishnupur in West Bengal, where the lotus bloomed and the BJP won 18 of the total 42 seats.

Khan defeated Trinamool's Shyam Lal Santra by a margin of 78,047 votes. Khan got 6,57,019 votes in his favour.

The BJP had fielded Mafuja Khatun from Jangipur, a constituency where 61.79 per cent of the population is Muslim. She was third while the winner was Trinamool's, Khalilur Rahaman. The seat was earlier represented by

Congress's Abhijit Mukherjee, son of former President Pranab Mukherjee. Abhijit was second garnering 2,55,836 votes.

Humayun Kabir was another BJP candidate who contested from Murshidabad, where the community comprises 66 per cent of the population. Kabir got 2,47,809 votes but remained third.

Other Muslim candidates of the party failed to save their deposits. The party had fielded three Muslim candidates in Kashmir. Sofi Yousuf contested from Anantnag and garnered only 10,225 votes. Mohammad Maqbool War got 7,894 votes in Baramula while Sheikh Khalid Jehangir got 4,631 votes in Srinagar. Most of the elected Muslim candidates belong to the Congress (5) and Trinamool Congress (5), followed by the Samajwadi Party (3), Bahujan Samaj Party (3) and the Jammu and Kashmir National Conference (3).

Uttar Pradesh and West Bengal, which have a considerable Muslim population, are sending six MPs each from the community. In the 2014 Lok Sabha elections, no Muslim candidate had won from Uttar Pradesh as the BJP had won 71 of the 80 Lok Sabha seats.

Bahujan Samaj Party candidates Afzal Ansari from Ghazipur, Fazalur Rahman from Saharanpur and Danish Ali in Amroha, and Samajwadi Party's Azam Khan from Rampur, Shafique Rehman Barq from Sambhal and S.T. Hasan from Moradabad made their way to the Lok Sabha. The Congress had fielded six Muslim candidates in Uttar Pradesh, but none of them won a seat.

Jammu and Kashmir, a Muslim-majority state, has elected three MPs, all from the National Conference. Bihar, which



had sent four Muslim MPs to the Lok Sabha in 2014, will only have two MPs from the community this year. Besides Kaiser while another is Mohammad Jawed of the Congress, who won from Kishanganj. Three Muslim candidates won from Kerala, while two from Assam will also be in the 17th Lok Sabha.

Mohammed Faizal of the Nationalist Congress Party won the lone seat in Lakshadweep. The Congress' Mohammad Sadique also won the Faridkot seat from Punjab. Indian Union Muslim League candidate K. Navas Kani won from Ramanathapuram in Tamil Nadu.

The All India Majlis-e-Itthadul Muslimeen will have two candidates in Parliament - party chief Asaduddin Owaisi from Hyderabad and Imtiaz Jaleel from Aurangabad in Maharashtra. Jaleel's victory gains significance as Aurangabad is not a Muslim majority constituency.

The party in Maharashtra had formed an alliance with Prakash Ambedkar's Vanchit Bahujan Aghadi.



7 things you can do to prevent a stroke

What can you do to prevent stroke? Age makes us more susceptible to having a stroke, as does having a mother, father, or other close relative who has had a stroke. You can't reverse the years or change your family history, but there are many other stroke risk factors that you can control—provided that you're aware of them. "Knowledge is power," says Dr. Natalia Rost, associate professor of neurology at Harvard Medical School and associate director of the Acute Stroke Service at Massachusetts General Hospital. "If you know that a particular risk factor is sabotaging your health and predisposing you to a higher risk of stroke, you can take steps to alleviate the effects of that risk."

How to prevent stroke

Here are seven ways to start reining in your risks today to avoid stroke, before a stroke has the chance to strike.

1. Lower blood pressure

High blood pressure is a huge factor, doubling or even quadrupling your stroke risk if it is not controlled. "High blood pressure is the biggest contributor to the risk of stroke in both men and women," Dr. Rost says. "Monitoring blood pressure and, if it is elevated, treating it, is probably the biggest difference people can make to their vascular health."

Your ideal goal: Maintain a blood pressure of less than 135/85. But for some, a less aggressive goal (such as 140/90) may be more appropriate.

How to achieve it:

Reduce the salt in your diet to no more than 1,500 milligrams a day (about a half teaspoon).

Avoid high-cholesterol foods, such as burgers, cheese, and ice cream.

Eat 4 to 5 cups of fruits and vegetables every day, one serving of fish two to three times a week, and several daily servings of whole grains and low-fat dairy.

Get more exercise — at least 30 minutes of activity a day, and more, if possible.

Quit smoking, if you smoke.

If needed, take blood pressure medicines.

2. Lose weight

Obesity, as well as the complications linked to it (including high blood pressure and diabetes), raises your odds of having a stroke. If you're overweight, losing as little as 10

pounds can have a real impact on your stroke risk.

Your goal: While an ideal body mass index (BMI) is 25 or less, that may not be realistic for you. Work with your doctor to create a personal weight loss strategy.

How to achieve it:

Try to eat no more than 1,500 to 2,000 calories a day (depending on your activity level and your current BMI).

Increase the amount of exercise you do with activities like walking, golfing, or playing tennis, and by making activity part of every single day.

3. Exercise more

Exercise contributes to losing weight and lowering blood pressure, but it also stands on its own as an independent stroke reducer.

Your goal: Exercise at a moderate intensity at least five days a week.

How to achieve it:

Take a walk around your neighborhood every morning after breakfast.

Start a fitness club with friends.

When you exercise, reach the level at which you're breathing hard, but you can still talk.

Take the stairs instead of an elevator when you can.

If you don't have 30 consecutive minutes to exercise, break it up into 10- to 15-minute sessions a few times each day.

4. If you drink — do it in moderation

Drinking a little alcohol may decrease your risk of stroke. "Studies show that if you have about one drink per day, your risk may be lower," says to Dr. Rost. "Once you start drinking more than two drinks per day, your risk goes up very sharply."

Your goal: Don't drink alcohol or do it in moderation.

How to achieve it:

Have no more than one glass of alcohol a day.

Make red wine your first choice, because it contains resveratrol, which is thought to protect the heart and brain.

Watch your portion sizes. A standard-sized drink is a 5-ounce glass of wine, 12-ounce beer, or 1.5-ounce glass of hard liquor.

5. Treat atrial fibrillation

Atrial fibrillation is a form of irregular heartbeat that causes clots to form in the heart. Those clots can then travel to the brain, producing a stroke. "Atrial fibrillation

carries almost a fivefold risk of stroke, and should be taken seriously," Dr. Rost says.

Your goal: If you have atrial fibrillation, get it treated.

How to achieve it:

If you have symptoms such as heart palpitations or shortness of breath, see your doctor for an exam.

You may need to take an anticoagulant drug (blood thinner) such as warfarin (Coumadin) or one of the newer direct-acting anticoagulant drugs to reduce your stroke risk from atrial fibrillation. Your doctors can guide you through this treatment.

6. Treat diabetes

Having high blood sugar damages blood vessels over time, making clots more likely to form inside them.

Your goal: Keep your blood sugar under control.

How to achieve it:

Monitor your blood sugar as directed by your doctor. Use diet, exercise, and medicines to keep your blood sugar within the recommended range.

7. Quit smoking

Smoking accelerates clot formation in a couple of different ways. It thickens your blood, and it increases the amount of plaque buildup in the arteries. "Along with a healthy diet and regular exercise, smoking cessation is one of the most powerful lifestyle changes that will help you reduce your stroke risk significantly," Dr. Rost says.

Your goal: Quit smoking.

Ask your doctor for advice on the most appropriate way for you to quit.

Use quit-smoking aids, such as nicotine pills or patches, counseling, or medicine.

Don't give up. Most smokers need several tries to quit. See each attempt as bringing you one step closer to successfully beating the habit.



Shocked by RJD rout, Lalu Prasad gives up meal at hospital

Lalu apparently could not digest that his party drew a blank in its stronghold Bihar and also in the neighbouring Jharkhand. This is the first instance after its inception in 1997, that the RJD could not win a parliamentary seat in Bihar.

Stunned by the rout of his Rashtriya Janata Dal in Bihar and Jharkhand in the Lok Sabha election, Lalu Prasad gave up lunch for two days after the declaration of poll results on May 23. Prasad had the meal on Sunday, May 26, after doctors, worried for his health, pleaded him that proper food intake was required for his medication to continue, Dr Umesh Prasad, head of the team looking after him, told PTI. The RJD president is under treatment for blood pressure, sugar and kidney ailment at the Ranchi-based Rajendra Prasad Institute of Medical Sciences since December 2017 after he was sent to jail by a court, RIMS sources said.

The doctor said Prasad's health parameters are normal. The jovial RJD supremo, known for his earthy humours, apparently could not digest that his party drew a blank in its stronghold Bihar and also in the neighbouring Jharkhand.

This is the first instance after its inception in 1997, that the RJD could not win a parliamentary seat in Bihar but it's the second time in a row that it failed to open an account in Jharkhand.

Heading the 'mahagathbandhan' in Bihar, the RJD had fought on 19 seats and shared Arrah constituency with CPI(ML); it got a drubbing at the hands of NDA on all the seats. Prasad's eldest daughter Misa Bharti was defeated for a second time by Union minister Ramkripal Yadav, her father's former close associate, on Pataliputra constituency. On Saran seat,

held by the RJD president for several times in the past, Chandrika Rai, father-in-law of his elder son Tej Pratap Yadav, tasted defeat at the hands of BJP's Rajiv Pratap Rudy.

Of the 40 Lok Sabha seats in Bihar, only Kishanganj was won by Congress, a grand alliance ally. This was the first occasion that RJD went into an election without its popular leader Lalu Prasad. His wife Rabri Devi and son and heir apparent Tejashwi Yadav could do little to perk party's poll performance.

Even during the "Modi wave" of 2014, RJD had managed to win four Lok Sabha seats in Bihar. Later, in the Bihar election, Prasad's party in alliance with JD(U) and Congress emerged as the single largest party with 80 MLAs. Chief Minister Nitish Kumar left the grand alliance in July 2017 and joined hands with BJP again.

RJD spokesman Mritunjay Tiwari told PTI over phone from Patna, that the party would discuss in detail what went wrong for it in the election. But he said Prasad's absence was a big reason for the drubbing.

Two TMC MLAs, over 50 councillors join BJP: Is Mamata's party under saffron threat? Tiwari said the results have given the party "a lesson" which the leadership would definitely take into account to win back people's support. The RJD, which formed the mahagathbandhan with Congress, JMM and Jharkhand Vikas Morcha (Prajatantrik), got only Palamau (SC) seat as per the seat-sharing adjustment among them.

But it lost the seat. In Koderma, former RJD state unit president Annapurna Devi fought on BJP ticket and defeated JVM president Babulal Marandi. RJD leaders on Monday are meeting for a review of the party's humiliating performance, its leader Kailash Yadav said.

Ajay Devgn's father Veeru Devgan dead: A pictorial tribute to the action choreographer


Veeru Devgan, father of actor Ajay Devgn, started off his career as an action choreographer. He choreographed action sequences in over 80 films.

New Lok Sabha has 475 'crorepati' MPs: ADR

The ADR arrived at the figure of 'crorepati' MPs after analysing the affidavits on assets and liabilities of 539 new MPs.

A total of 475 members of the new Lok Sabha are 'crorepatitis' with Madhya Pradesh Chief Minister Kamal Nath's son Nakul Nath topping the list, the Association of Democratic Reforms said Sunday. The ADR arrived at the figure of 'crorepati' MPs after analysing the affidavits on assets and liabilities of 539 new MPs.

The ADR said it was unable to access affidavits of three of the 542 new MPs — two of the BJP and one of the Congress. The BJP won 303 seats in the 17th Lok Sabha and the Congress 52. Elections were held for 542 of the 543 Lok Sabha seats. The election for Vellore Lok Sabha seat had been cancelled by the Election Commission of India, citing abuse of money power. A fresh date is yet to be announced. Two members of the 545-strong House are nominated.

Out of the 301 new BJP MPs, whose affidavits were exam-

ined, 265 (88 per cent) were found crorepati, while all 18 winners of its NDA partner Shiv Sena had assets exceeding Rs one crore. In the Congress, 43 out of its 51 MPs (totalling 96 per cent) were found to be 'crorepati'.

Similarly, 22 (96 per cent) out of 23 DMK MPs, 20 (91 per cent) out of 22 of the Trinamool Congress MPs and 19 (86 per cent) out of 22 YSR Congress MPs had assets exceeding Rs one crore. The top three crorepatitis MPs are from the Congress, the ADR said.

Nath, who won from Chhindwara, Madhya Pradesh, has declared assets worth Rs 660 crore, followed by Vasanthakumar H from Kanniyakumari, Tamil Nadu (Rs 417 crore) and D K Suresh from Bengaluru Rural, Karnataka (Rs 338 crore).

The average of assets per winner in the Lok Sabha elections is Rs 20.93 crore. There are 266 members in the new Lok Sabha whose assets are Rs 5 crore or above.

Widow builds a dream hospital for people who can't afford costly treatment

Back in those days, when people didn't get access to basic medical facilities, problems haunted them like hell. Even if there were medical centres to address health problems, some people didn't have enough money to pay for the expensive treatment and hence living became tougher for them.

Subhasini Mistry was one among the people in her village didn't have the money to pay the medical expenses of her husband. She couldn't afford treatment in the critical situation and as a result, her husband passed away and she was widowed at the age of 23.

Her husband's name is Sadhan Chandra Mistry. He plied his trade as an agricultural worker and one day, he fell sick while working on the paddy farm. He suffered from diarrhoea and was immediately rushed to the hospital. Sadly the doctors and nurses paid no attention to the patient as his family was penniless.

The heartbroken Subhasini might have lost her husband but she made sure that this same situation shouldn't repeat to others. It was when she decided to build a charity hospital so that even the economically backward sections of the society wouldn't have to worry about the medical expenses and hospital charges.

Mistry tells IANS, "When my husband passed away, I

was in shock initially. Then I realised I had four hungry mouths to feed... I had no education and couldn't even tell the time. So I decided I would do whatever work that was available."

Subhasini had to take care of her four children all by herself. The one-woman army worked hard day in day out as a housemaid, labourer, and then sold vegetables to make a living. Subhasini tells IANS, that she had put two of her own children in an orphanage because she couldn't afford to educate them.

As per India Today, she saved as much as money to buy one-bigga (which is one-third of an acre) plot. However, in 1993, the Humanity Trust came into existence and the temporary clinic was set up with the help of the local residents.

Slowly, a permanent building of Humanity Hospital came to Hanspukur village near Kolkata in 1996. The hospital was inaugurated by the then-West Bengal governor, K.V. Raghunath Reddy.

Apart from building a hospital which runs on charity, her dream was to see one of her children to become a doctor in her hospital. Now, her son is one among the 12 doctors



at the hospital. His name is Ajoy who is her younger son. He fulfilled his mother's dream.

She told United Nations in India, adding that 'no one should be denied medical attention'. While other hospital charges lakhs of rupees for surgeries, her hospital charges just Rs.10 for registration fee and gives treatments for free. She has also launched another hospital at Sundarbans.

The Bharatiya Janata Party (BJP) did not give the Lok Sabha ticket to any Muslim this time too. Barring the fa-

ther-son duo of Mulayam Singh Yadav and Akhilesh Yadav, it was Samajwadi Party's Muslim nominees who took the party's tally to five.

The Samajwadi Party (SP) and the Bahujan Samaj Party (BSP) had fielded four and six Muslim candidates, respectively.

Till the 2014 Lok Sabha elections, Muslims played a crucial role in 30-odd constituencies, primarily in the western and central UP.

They accounted for 15-50 per cent of votes in the constituencies.

AIMIM's Jaleel wins Aurangabad seat, beats Khaire

The All India Majlis-E-Ittehadul Muslimeen (AIMIM) candidate, Imtiaz Jaleel has won from the Aurangabad seat with a margin of 4,492 votes, which was also the lowest margin of victory in Maharashtra, becoming the first Lok Sabha MP of the party from the state. He defeated Shiv Sena's Chandrakant Khaire.

Mr Khaire, during campaigning, had alleged that BJP state president Rao Saheb Danve had helped his son-in-law Harshwardhan Jadhav who was contesting against him. Mr Jadhav polled more than 2.75 lakh votes and was even leading in Aurangabad LS seat during initial rounds of counting.


Mr Khaire also complained about Mr Danve to Amit Shah and Devendra Fadnavis. Mr Jadhav had refuted Mr Khaire's allegations and said that the fear of losing elections was forcing him to make such comments.

Another Shiv Sena heavyweight Anandrao Adsul suffered shock defeat in Amravati Lok Sabha constituency where independent candidate Navneet Kaur Rana won by a margin of 36,951 votes.

Ms Rana was backed by the Nationalist Congress Party. She secured more than five lakh votes while Mr Adsul got 4.70 lakh votes.

In the 2014 Lok Sabha elections, Mr Adsul had won from Amravati by defeating the NCP candidate by a margin of 1,37,932 votes.

However, Raju Shetti, founder of Swabhimani Shetkari Sanghatana, who was the only Lok Sabha MP from Maharashtra who did not any of the mainstream parties, lost from Hatkanagle Lok Sabha seat. He lost to Shiv Sena's Dhairyasheel Mane by a margin of over 97,000 votes, in a



bitterly fought contest after he exited National Democratic Alliance (NDA) and joined Congress, Nationalist Congress Party combine.

Muslims are shareholders, not tenants in India: Owaisi

Stating that Muslims are shareholders and not tenants in India, AIMIM chief Asaduddin Owaisi said their fight to get the rights guaranteed by the country's Constitution will continue.

The Hyderabad MP also said there was no need for Muslims to be scared over BJP retaining power at the Centre with over 300 seats in Lok Sabha.

Owaisi was addressing 'Jalsa Youmul Quran' at the historic Mecca Masjid here on the occasion of 'Jumatul Vida' or last Friday of holy month of Ramadan.

The All India Majlis-e-Ittehadul Muslimeen (AIMIM) chief said winning over 300 seats did not mean Prime Minister Narendra Modi can do whatever he likes or snatch the Constitutional rights of the minorities.

"Muslims are hissedaar (shareholder) and not kirayedaar (tenants) in India. They

are equal citizens of this country and they can't be denied the rights guaranteed to them by the Constitution," he said.

Owaisi, who was re-elected from Hyderabad for a fourth consecutive term, said his party would continue to fight for the due share and rights of Muslims, Dalits and other oppressed people.

Stressing the need for unity among Muslims and the need to carry Dalits along, Owaisi pointed out that by joining hands with his "elder brother" Prakash Ambedkar in Maharashtra, the AIMIM won the Aurangabad Lok Sabha seat.

Owaisi said Muslims need not get scared by the victory of BJP as the Constitution of India remained supreme and it make no difference who was in power.

The AIMIM leader said the series of incidents of beating up of Muslims in the name of cow or wearing skull cap during last few were aimed to creating fear among

Muslims. He said that the history shows Muslims never gave up their belief and identity even in the face of worst excesses.




