Supervisor mentioned that the Township was informed by our building inspector, Ed Engle, that the house on Macon Rd is to be taken down.

Discussed new Fire Truck purchase which will be paid for in mostly cash. Supervisor mentioned several new updated features and purchase price going down from \$430,000 to \$420,000.

Supervisor is meeting with C. Ken Williams from Reading regarding Cemetery road repair bid.

Township received an Assessor Contract bid from Amanda LaCelle which is higher by \$1.00 per parcel. Shelly from Lenawee County Equalization, our current Assessor, has stated that their per parcel cost will increase from \$12.95 to \$13.00.
