

**CONTRACT FOR DAYTIME PARTY OF WEDGEWOOD HILLS SWIM CLUB  
(Use this contract for a daytime party with the recreation room)**

Party contracts must be signed by the authorized adult taking full and financial responsibility for the party.

Parties must be:

1. Scheduled with the pool manager two weeks in advance of the party date.
2. Booked with the party's count of attendees (adults and children).
3. Paid in full before party date.

Parties can be scheduled on any day that the pool is open to members. There are two party slots available each day: 12:30-2:30pm or 3:30-5:30pm. The pool will remain open to members during these parties. The party room is available. The picnic tables are also available to be reserved for these daytime parties. The charcoal grill (next to the picnic tables) cannot be used during the daytime parties.

Party Fees:

- Rental Fee -
  - Pool Members: \$150 (\$50 deposit and this contract must be received by the pool manager one week prior to the party date).
  - Non-members: \$200 (\$50 deposit and this contract must be received by the pool manager one week prior to the party date)

Cancellation Policy: \$50 will be returned to the party contact for parties cancelled 48 hours prior to the party date. Parties that cancel in less than 48 hours prior to the party date are not entitled to a refund. In the event that the pool does not open due to bad weather, the Club will send a full refund to the party contact. However, once your party has begun there will be no refunds.

POOL RULES WILL BE ENFORCED (including no smoking, no foul language and no glass containers).

**Party will not be booked until this contract is completed and returned with the \$50 deposit. Deposit is non-refundable. Wedgewood Hills Swim Club will work with you to adjust dates if you need to reschedule, but we cannot guarantee that we will be able to adjust the date once booked.**

\_\_\_\_\_ Myself and all of my guests agree to follow all rules posted by Wedgewood Hills Swim Club. Failure to do so may lead to being ejected from the premises.

\_\_\_\_\_ I understand that if police are called for any reason due to any action of my guests, I will be held responsible for any fine or fee levied by the police and/or Susquehanna Township.

\_\_\_\_\_ I understand that I will be held liable for any damage to the club that my guests may cause.

\_\_\_\_\_ I understand that a signed waiver will be required for each non-member in your party before they can swim.

\_\_\_\_\_ If the party has not vacated the party room after the allotted time, an additional charge of \$5 per minute will be charged. Late charges may forfeit you from booking additional parties.

\_\_\_\_\_ Party room will be returned to the same condition it was received once the party is over. All trash will be removed or put into appropriate containers. Party room must be vacated within 20 minutes of the end of the party.

\_\_\_\_\_ I understand that glass containers and alcohol are **not** permitted on the premises.

\_\_\_\_\_ I understand that loud music is **not** permitted on the premises.

### **Party Instructions:**

1. We will need the total number of party guests (adults and children) whether they are going to swim or not. We will need to know exactly how many people in your party are members of the Swim Club. Every guest of the pool party will need to check in at the front gate, get a wristband and sign in to the party log.
2. The maximum number of guests for each party is 30 guests (unless the pool contract indicates a larger number). A guest is anyone entering the pool area and staying during the party, regardless if they swim or not.
3. Please arrive at the pool 15 minutes before the start of your party to receive further instructions from the staff.
4. When you arrive, we will give you 30 wristbands for your guests who are non-members of the Club.
5. Each guest who is not a club member will need a wristband to enter the pool area.
6. Guests who are pool members may stay and continue to swim after the party is over.
7. Guests who are not pool members may purchase a guest pass for \$5 to stay and swim for the rest of the day.
