- a. DeGoey moved and was seconded by Thomassen to approve Resolution Number 2017-02 to approve the FY 2017 budget amendment. Upon roll call vote, motion carried unanimously.
- b. Tom Clark submitted a letter of resignation effective 5/24/17. The city clerk will publish a notice of intent to fill the city council vacancy by appointment to be done at the next regularly scheduled meeting.
- c. The Council reviewed the restrictions the City of Newton imposed on fireworks as well as the less restrictive state regulations. The Council decided the City will follow the state regulations at this time and revisit in the future, if needed. State regulations say fireworks can be used from June 1 to July 8 and December 10 to January 3 between the hours of 9 a.m. to 10 p.m. On July Fourth and the Saturdays and Sundays immediately preceding and following July Fourth, the hours expand from 9 a.m. to 12:30 a.m. and on December 31 to the next day fireworks are allowed between 9 a.m. to 12:30 a.m. Also, on the Saturdays and Sundays immediately preceding and following December 31 fireworks can be used from 9 a.m. to 11 p.m.

Humke moved and was seconded by DeGoey to approve all the items on the consent agenda including the minutes from the May 4, 2017 meeting, revised list of bills, and reconciliation report for May.
