2019 Quilt Show
Instructions & Rules



GENERAL INSTRUCTIONS

1. Each entrant must abide by these general show rules. The entrant does not have to be the creator of the quilt. The entrant **MUST** enter the quilter's name and **MUST** include the pattern name, pattern designer's name, and/or pattern source.
2. Items previously entered in a WMQG show will not be accepted.
3. This is a judged show. Two judges from the National Association of Certified Quilt Judges (NACQJ) will conduct judging.
4. The entrant will select the category of the quilt entry. The entry will not be accepted, without a category designated. For a full description of each category, please visit our website at www.wmqg.net.
5. Every entry must consist of at least three layers (top, batting, and backing) and be hand or machine quilted or tied. This includes quilted clothing, accessory, and home décor items. Any entry **NOT** meeting this requirement will not be accepted.
6. The judges will award first, second, third places and honorable mention ribbons, in each category, if merited. All entries will be eligible for Best of Show, Judge's Choice (1 per judge), President's Choice, Mayor's Choice, Best Color Theory, and Viewer's Choice. Additionally all hand quilted items will be eligible for Best Hand Quilted; all non-professionally machine quilted items will be eligible for Best Non-Professional Machine Quilting; and all professionally machine quilted items will be eligible for Best Machine Quilting.
7. Ten Percent (10%) of the sale price of all entries sold at the show will go to WMQG.

QUILT ENTRY RULES

1. Entrant may enter one item per category. Please use a separate entry form for each item. Keep a copy of the completed form for your records. This copy along with a valid photo ID is required to pick up your entry! Quilt entry form and rules are also on our website at www.wmqg.net.
2. An entry fee MUST accompany the form for each item entered (make checks payable to WMQG.) Members \$10 per item; Non-Members \$20 for first item, \$10 each additional item. ENTRY FEES ARE NON-REFUNDABLE.
3. All entry forms AND fees MUST be received on or before Monday, January 14, 2019. Completed entry forms will be accepted at the monthly Quilt Guild meeting or they may be mailed to LaDonna Meyer, Entry Coordinator, 45034 County Street 2680, Cyril, OK 73029.
4. All entries MUST be received by Monday, February 4, 2019. Quilts not received by this deadline will be returned and NOT placed in the show. NO EXCEPTIONS. Quilts may be delivered in person to any quilt guild meeting or to LaDonna Meyer, Entry Coordinator – 580-695-1562. You may bring quilts to First Baptist Church – West, 7302 NW Cache Road, Lawton, OK, on Monday, February 4, 2019, 6:30pm to 7:30pm.
5. Color photo of entries MUST accompany entry forms. The entry needs to be finished for this photo. The photos are used to help plan the quilt show and will not be returned. It is the entrant's responsibility to obtain the photo. Photos will NOT be taken at the guild meeting.
6. All entries must remain on display for the duration of the show.
7. All quilts (except miniatures) must have a 4 inch finished sleeve attached to the back of the quilt. The top of the sleeve should be attached no higher than 90-92 inches from the bottom edge of larger quilts. Quilts without a sleeve will not be accepted for entry and will be returned to owner. See our website at www.wmqg.net for instructions to construct a sleeve.
8. All quilts must have a fabric identification label sewn or basted on the back of the quilt's lower right-hand corner. This label will state the entrant's name, address, and phone number.
9. Deliver each entry placed in its own pillowcase with the entrant's name, address, and phone number printed on the pillowcase.
10. You may pick up your entry after the show. Entries will be released at the quilt show location on February 9, 2019 between 4 and 4:30pm. You must bring a copy of your entry form AND a valid photo ID in order to claim your entry!
