**AMANA NEWS AND NOTES**

**Meeting for CCA Bond Issue Held Ballot is March 1 - You Vote in Middle Amana**

Eight residents of the Amana Colonies met with a Clear Creek Amana staff members and board members at a Monday, February 7 meeting to discuss the proposed \$65 million bond issue. The vote on the bond issue will be held Tuesday, March, 1.

All Amana Colony residents may vote at the Middle Amana Fire Station on March 1. Right now you can stop by the Iowa County Auditor's Office at the Iowa County Courthouse Annex in Marengo to pick up an absentee ballot or vote on site. Bring ID with you.

One of the top questions asked at the meeting: "Will this raise my property taxes?" The answer was No. The district has seen enough new construction, new development and growth both in commercial and residential property that the valuation of these new properties adds to the school district's ability to raise monies on the sale of the bonds.

The result -- this \$65 million bond issue will not raise property tax levies for the CCA School District in Johnson or Iowa County. As it stated on the CCA website (Go to "2022 Bond" tab on the home page) under "Impact on School Tax Levy" it reads, The district will maintain the current tax rate of 17.059. Our growth is not only in student enrollment but also in the commercial and residential tax base, which allows us to keep a fairly stable tax rate.

Rick Hergert, a former CCA School Board member, attended the meeting and voiced his support for the project noting that the projections show the school district will grow by an additional 600 students in the next four years. That means 30 new class rooms will be needed. Stressing how important it is to keep class sizes small, and the CCA district's long term commitment to neighborhood elementary schools, he said that building a new school in the area where significant growth is to occur makes sense. He said that the school's growth and enrollment committee has been told that there are already 620 residential lots plotted in this area. Hence a

new 600-student elementary is needed.

As a point of fact, the CCA student enrollment has risen 142% since 2000.

The two level elementary school cost projection is \$40 million. The school district was successful in obtaining 30 acres for the school site at a cost of \$1, he added. The new school is to be located on the western edge of the City of Coralville, west of Costco, north of the large mobile home park.

Additionally this bond issue will pay for the construction of larger band and music facilities at the middle school and replace the middle school roof.

If it passes, a new vocational training class room will be built for vocational training classes (also known as shop/ construction/ tech classes) at CCA High School. When the high school was moved in 2009 the shop remained at the Middle School, now with the growth at both schools, a new shop space is needed at the High School.

Elementary schools will see an upgrade in the their outdoor and playground spaces. At the Amana School in Middle Amana they would like to redo the tennis courts and add pickle ball courts.

For details about the bond issue go to the 2022 Bond tab on the CCA district website home page. There are two power point presentations and answers to frequently asked questions on the link.

A 60 percent majority is needed to pass the bond issue ballot. With a successful bond referendum the Clear Creek Amana Schools will:

- Build a new 600 student elementary school on the eastern edge (Coralville) of the CCA School District.
- Build a Fine Arts addition to the Middle School
- Build a Fine Arts and Career and Technical vocational addition to the High School
- Replace and Improve the Middle School Roof
- Make related site improvements to the Middle School and High School.
- Make improvements to the existing elementary school playgrounds/ grounds including new tennis and pickle ball courts at Amana Elementary.

Several public meetings were held in the school district in February. The number of people attending the meetings varied but they were not crowded.

**PUBLIC NOTICE****Antidegradation Alternatives Analysis for Whirlpool Corporation – Amana Operations (Amana, Iowa County, Iowa) Notice Date: February 17, 2022**

Notice is hereby given that Whirlpool Corporation – Amana Operations (Amana, Iowa County, Iowa) has completed a draft antidegradation alternatives analysis to move compliance demonstration for the Expanded PolyStyrene Styrofoam (EPS) steam process wastewater from Outfall 001 to interim monitoring location Outfall 025. The National Pollutant Discharge Elimination System (NPDES) Permit currently includes effluent limits for biochemical oxygen demand (BOD5), oil and grease, and total suspended solids (TSS) at Outfall 001, in accordance with federal effluent limitations guidelines for the Plastics Molding and Forming Point Source Category (40 CFR Part 463, Subpart A).

The BOD5, oil and grease, and TSS effluent limits have been applied at Outfall 001 rather than the EPS steam process wastewater directly due to the previous inability to isolate and sample the EPS steam process wastewater stream. The action being considered is establishment of an interim monitoring location, Outfall 025, which will monitor EPS steam process wastewater independent of other water sources. There will be no changes to the quality or quantity of the EPS steam process wastewater; however, the effluent limits for BOD5, oil and grease, and TSS will increase due to the flow rate of the EPS steam process wastewater being corrected. The effluent limits for these parameters will be applied at Outfall 025 rather than Outfall 001. EPS steam process wastewater will continue to discharge from Outfall 001 to an unnamed creek tributary to the Iowa River. The unnamed creek receiving water is protected for Class A2 secondary contact recreational use and Class B (WW-2) warm water beneficial uses.

Anyone wishing to comment on the proposed establishment of Outfall 025 must do so in writing within 30 days of the date shown at the top of this notice.
