D. Consider and Discuss Resolution No. 2021-04-12-01

A RESOLUTION OF THE CITY OF CISCO, TEXAS, FINDING THAT AEP TEXAS INC.'S APPLICATION TO AMEND ITS DISTRIBUTION COST RECOVERY FACTORS TO INCREASE DISTRIBUTION RATES WITHIN THE CITY SHOULD BE DENIED; AUTHORIZING PARTICIPATION WITH THE CITIES SERVED BY AEP TEXAS; AUTHORIZING HIRING OF LEGAL COUNSEL; FINDING THAT THE CITY'S REASONABLE RATE CASE EXPENSES SHALL BE REIMBURSED BY THE COMPANY; FINDING THAT THE MEETING AT WHICH THIS RESOLUTION IS PASSED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW; REQUIRING NOTICE OF THIS RESOLUTION TO THE COMPANY AND LEGAL COUNSEL.

Mr. Archer explained that the proposed resolution would serve to deny AEP rate increases to the citizens of the city.

E. Consider and Discuss Ordinance No. 0-2021-7

AN ORDINANCE OF THE CITY OF CISCO, TEXAS AMENDING CERTAIN SUBSECTIONS OF CHAPTER 14 "OFFENSES AND MISCELLANEOUS PROVISIONS" OF THE CITY'S CODE OF ORDINANCES; SPECIFICALLY ADDING ARTICLE VI "NOISE" PROHIBITING UNREASONABLE, DISTURBING, OR UNNECESSARY NOISE IN THE CITY LIMITS OF THE CITY OF CISCO, TEXAS. (First Reading)

Mr. Archer explained that the proposed ordinance would be a tool for residents affected by unreasonable noise. Chief Preston added that the ordinance would define noise and specify what constitutes unreasonable noise. Councilmember Toof questioned several aspects of the ordinance including how strict it could get because there were no specific decibel limits spelled out in the ordinance. His concern was that regular family gatherings could be punished if neighbors called in. Chief Preston answered that the inclusion of specific decibel limits would require the officers to carry decibel readers which are expensive and would basically render the ordinance unenforceable due to it being cost prohibitive. Chief Preston went on to assure Councilmember Toof that the officers would use best judgement to determine if any noise was offensive or unreasonable to the extent of making contact.

F. Consider and Discuss Adoption of Amended Planning & Zoning Map Previously Adopted in Ordinance No. 0-2017-14.

The City Secretary explained the changes being proposed by the Planning & Zoning Commission including a couple of zoning errors resulting from incomplete platting information when map was first adopted.

Mr. Archer explained that the school district had requested a dissolution of the current Memorandum of Understanding because the board had decided to use private security for school patrol. Without action, the MOU will automatically dissolve in 90 days.

No news has come in regarding the annexation of Hidden Shores. City wide cleanup will be this weekend, April 10-11.

Councilmember R. Johnson asked about the 10 year Street Improvement Plan and Mr. Archer indicated that he would share that with the Council by email.
