

Because of this change we are adjusting the class run order to make for a more efficient running trial.

Directions to Fun Fur Paws (22352 Stargate Place, Mt. Vernon, WA 98274):

From I-5 NORTH or SOUTH:

- Take Exit #218 to Starbird Road.
- Go east on Starbird Rd to the 4-way stop at Bulson Rd
- Turn left onto Bulson Rd
- At the intersection with Tyee Rd, turn left to remain on Bulson Rd
- Turn right onto Stargate Place, at the Sign for Fun Fur Paws
- Follow Stargate Place to the arena and parking area

Crating: There will be crating space inside the stall area. You may need to share your stall with others as space is somewhat limited. You may arrive for crating set-up after 4:00 pm Thursday.

Move-ups: The deadline to send in your move-up is Monday, Oct 1, 2018 at 6:00 pm. Move-ups must be submitted in writing (email ok).

Height Cards/Measuring: We will not have a VMO measuring at this trial. All dogs without height cards will still have to be measured by a judge prior to their first run. We will measure dogs from 7:00 am to 7:30 am and various times throughout the day.

Start Time & Running Order: Check in and measuring time will begin at 7:00 am on both days, with first dog on the line at 8:00 am. This will be a 2 ring, 1 judge trial. The class running order will be as follows:
