

Reminder About Using Live Mail

Many of you may need a reminder that users of Microsoft's free Windows Live Mail 2012 on Windows 7 who have an Outlook.com account have not been able to send or receive emails as of June 30, 2016.

If you have a Microsoft mailing address including @outlook.com, @hotmail.com, @live.com, or @msn.com, you have been impacted by this change.

The process is simple - your options are listed below and Microsoft support is available should you encounter any issues. You can always access your Outlook.com account via any web browser at any time, and you will continue to have access to all your data that is currently in Windows Live Mail 2012.

If you currently use Windows Live Mail 2012 to connect to Outlook.com, it is recommended that you switch to the Mail app on Windows. This is the most-used desktop email app among Outlook.com users today. It is designed to work with the new Outlook.com, offers a more modern and touch-friendly interface and integrates with the Windows platform. Like Windows Live Mail 2012, the Mail app on Windows is free.

If you are a Windows Live Mail 2012 user, keep reading for specific

instructions on the next steps you need to take.

It is recommended you switch to the Mail app that is built in to Windows 8.1 and Windows 10. You do not need to install any software; simply launch the Mail app, navigate to "Add Account" and enter your Outlook.com email address and password. Because the data in your Outlook.com account is stored in the cloud, there is no need to manually move it from Windows Live Mail 2012 to the Mail app.

If you are using Windows 7, you can upgrade to a newer version of Windows to enjoy the Mail app and the other benefits.

If you are using Windows 7 and do not wish to use the Mail app, you can access your account via a web browser or you can take advantage of a free one-year subscription for Office 365 Personal and use Outlook 2016 to connect to your account. This Office 365 subscription includes the Outlook 2016 email application as well as other productivity applications such as Word, PowerPoint and Excel. It works on Windows 7, Windows 8/8.1 and Windows 10.

LASAR Members Earn Public Safety Diver Certification

Four members of LASAR recently received their Public Safety Diver (PSD) certification. Letty Rodriguez, Dillon Santinelli, Robin Lee and Bailey Helms completed three weeks of classroom and water training and earned their PSD International Certification on June 23. These graduates will now join LASAR’s other primary rescue and back-up divers for any future search and rescue missions.

PSDs not only train to find missing people or objects underwater, but are also trained on how to effectively interview witnesses. As expected, a witness of a boating or water-related accident could be quite emotional.

In some cases, they may have just witnessed one of their loved ones disappear on the water. To get critical information from a distraught or excited witness takes a methodical but empathetic interviewer. A productive interview of a witness could save vital minutes, often the difference between a successful rescue versus a body recovery.

LASAR also conducted a “fun day” dive at Morrison Springs

Park in Florida. The divers explored large fallen cypress trees on the sandy-bottom spring, giving them a chance to practice their scuba and team-diving skills in clear waters and calm conditions.

All of these dives are an opportunity for the unit to gain competency and familiarity to be better prepared for search and rescue missions.

Make Sure You Don't Miss Out

I am embarrassed to admit it, but I admire advertisers and their ability to sell us products we didn't even know we needed. Some of these advertisers are geniuses at convincing us that if we had their product, it would fill a hole in our lives and bring us complete satisfaction.

There's a term you'll hear advertisers use today. It's called FOMO - the fear of missing out.

It's the idea that someone somewhere is having a better time than we are, living a richer life than we are, taking a better vacation than we are and that we'd better cram as many experiences into our life as possible so we don't miss out on the good life. But is all this anxiety and chasing down better options what a full life is all about?

I think Jesus is addressing this question when he visits two sisters, Mary and Martha, who opened their home to him. Luke 10:38-42 states, "As Jesus and his disciples were on their way, he came to a village where a woman named Martha opened her home to him. She had a sister called Mary, who sat at the Lord's feet listening to what he said. But Martha was distracted by all the preparations that had to be made. She came to him and asked, "Lord, don't you care that my sister has left me to do the work by myself? Tell her to help me!"

Martha wants to be the good host, so she rushes around, taking care of all the details. Marthas are vitally important in our lives. Some of us would be in trouble if we didn't have a Martha to make sure things get done.

It's really tough to be a good host and to take care of others' needs, especially if no one seems to appreciate your efforts. Mary wants to be a good host too, but she has a different approach. She sits at Jesus' feet and listens to him teach. When Martha complains that her sister isn't helping, Jesus says, "Martha, Martha, you are worried and upset about many things, but few things are needed - or indeed only one. Mary has chosen what is better, and it will not be taken away from her."

guilt on Martha's shoulders. He's trying to teach both about the essence of life. Life is short. Don't get lured into using up your energy on what doesn't matter. Only one thing matters. It is the better option. And it can't be taken away from you.

I believe it is the best cure for FOMO there is—sitting at the feet of Jesus. Jesus' response to Mary and Martha reveals three truths.

First, don't miss out on the opportunity to know God. We promote achievement, consumption and cultivation of the self over our relationship with God. Yet God is our Creator. What good is our life if it is not reflecting God's glory and conforming to God's plans? All of Martha's rushing around to serve Jesus was draining her. If she didn't stop and just enjoy Jesus' presence, then he would end up getting the leftovers of her love and attention.

Second, don't miss out on the opportunity to give and to receive love. After all, this is the true essence of life. A pastor serving a church in Paraguay tells of a native Maka Indian man named Rafael that came to visit him. When he asked Rafael what he wanted, Rafael replied, "I don't want anything; I have just come near." Rafael just wanted to sit on the pastor's porch and be near his new friend. The ultimate goal is enjoying God's presence.

Third, don't miss the joy of living in this moment. Every second is an opportunity for us to experience God. If we're going to spend our lives chasing something, this is what we should be chasing. God is in this moment. It's God we don't want to miss.

Are you seizing this moment to pray, to focus on God, to look for the creator of the universe to speak to you and fill you with His love?

Only one thing matters, it is the best option and it can't be taken away from you. If you are suffering from FOMO, make sure you're not missing out on the kingdom of God, God's presence and rule in your life.

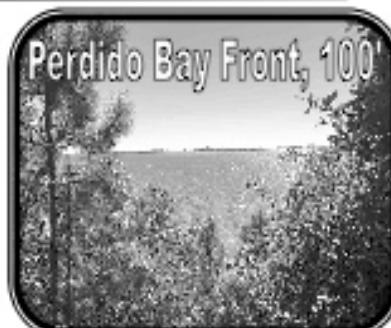

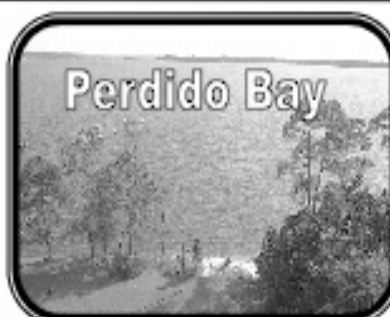

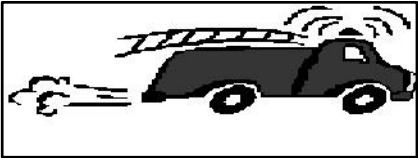

Lillian Volunteer Fire Department

Lillian Volunteer Fire Department responded to 69 calls dispatched by 911 operators in June including 40 medical assistance, 13 public assists, 3 motor vehicle accidents, 2 brush fires, 2 structure fires, 4 fire alarms and 5 miscellaneous calls. If you are interested in becoming a volunteer, give us a call at 962-2696 and leave a message. We will return your call.

As mentioned last month, Mr. C. Page donated two vehicles to LVFD for extrication practice. On two Tuesdays in July we dedicated our training for this purpose. Mike Cleveland, one of our volunteers and a retired captain of the Huntsville Fire Department, gave Lillian and Perdido Beach volunteer fire departments two exceptional classes on how to perform an extrication ensuring safety for the fire fighter and victims. The first class included detailed Power Point presentations and discussions, and the following Tuesday was all hands-on. A delicate approach is needed to minimize injury to the victim during the extrication so continuous training is valuable time spent working on these skills.

It's not all work and training at LVFD, we are always happy to be a part of the celebrations within our community. During July we were kept quite busy.

We attended the Shepherd of the Bay annual summer camp. We brought out Engine 3716 and sprayed the children (plus two firefighters) with water from one of the wide fire hose nozzles. Yes, everyone got drenched. And of course, the Lillian Community Club gave their usual exceptional annual fireworks display. LVFD was there to join in the celebration and to ensure everyone enjoyed the fireworks in a fun and safe environment on June 29. The next day, LVFD joined the Point Church in providing more fun and excitement for the children. We took several of our apparatus to the Lillian Recreational Park to give the kids a

great time running through and dodging the water sprays.

One item I would like to bring up to everyone in Lillian and the surrounding community is clear house numbers. LVFD is often called on emergencies late in the evening and all hours of the night. One of our biggest obstacles is finding the correct address. You may have your number on the door which is hard to read at night or it isn't legible on the mail box. This makes it very difficult to find the correct house and we don't want to wake up the wrong house at two in the morning. I would ask you all to check your house numbers at night and make sure it is very clear and easy for anyone to read with a flashlight in the dark. Thank you!

Remember the burn ban is now in affect and will continue until Nov. 1.

How Does Social Security Fit Into Your Retirement Strategy?

It might not be on your calendar, but Aug. 14 is Social Security Day. Since it was enacted on Aug. 14, 1935, Social Security has provided some financial support for millions of Americans during their retirement years. While Social Security benefits by themselves probably aren't enough to enable you to retire comfortably, they can be a key part of your overall retirement income strategy.

To help you make decisions about Social Security, you will need to answer these questions:

- When should I start taking my benefits? You can take Social Security once you reach 62, but if you wait until your full retirement age, which will probably be between 66 and 67, you'll get much bigger monthly checks, and if you wait until 70, you'll get the biggest possible payments. Before deciding when to begin receiving your benefits, you'll need to weigh a few factors, including your estimated longevity and other sources of income.
- How should I consider potential spousal

benefits? If you are married, or if you're divorced but were married for at least 10 years, you could receive up to half of your spouse's full retirement benefit (offset by your own benefit, and reduced if you claim early). If you outlive your spouse, you could claim survivor benefits, which can provide either your own benefits or 100% of your deceased spouse's, whichever is larger. Consequently, the higher-earning spouse might want to postpone taking benefits for as long as possible to maximize the survivor benefit.

- How much can I earn without reducing my Social Security benefits? If you are younger than your full retirement age and you are receiving Social Security, the Social Security Administration will withhold \$1 from your benefits for each \$2 you earn over a certain threshold (which, in 2019, is \$17,640). For the year you reach your full retirement age, your benefits could be withheld by \$1 for every \$3 you earn over \$46,920. But once

you reach your full retirement age, you can earn as much as you want without your benefits being withheld, although your benefits could still be taxed.

- How much of my pre-retirement income will Social Security replace? You should expect Social Security to replace slightly more than a third of your pre-retirement income. However, the higher your income during working years, the lower the replacement value of Social Security will be.
- What other sources of retirement income should I develop? Contribute as much as you can afford to your IRA and your 401(k) or similar employer-sponsored retirement plan.

Keep in mind that your decisions about Social Security filing strategies should always be based on your specific needs and health considerations. For more information, visit the Social Security website at [socialsecurity.gov](https://www.socialsecurity.gov).

You may have concerns about the

Protect Your Puppy Against Parvovirus

It is puppy season along the Gulf coast and it's time to remind everyone of the importance of getting them vaccinated. In our area, a disease called Parvovirus is very common and very deadly. It is highly contagious and attacks the gastrointestinal tract of puppies.

Spread by direct dog-to-dog contact, and contact with contaminated feces, soil, food and water bowls, leashes and hands, this virus is able to travel from place to place on hair, feet and shoes and is very resistant to most cleaning agents. Bleach must be used to decontaminate. All dogs are at risk, but puppies less than 4 months old and any dog that hasn't been vaccinated is especially susceptible.

If a dog contracts parvovirus, some of the typical signs include lethargy, vomiting, diarrhea, bloody stool, fever and loss of appetite. The severity of vomiting and diarrhea can cause such dehydration that some puppies will not survive. If you are seeing any of these signs, please contact a veterinarian immediately. Vets are able to test for the virus and provide the support your pet needs to overcome the disease. This requires 3-10 days of intensive care in the hospital.

Luckily, parvovirus is easy to prevent. All it takes is several vaccines for the

growing puppy and an annual vaccine booster for an adult dog. The vaccines are safe, inexpensive and effective at protecting your pet from a deadly virus. We recommend puppies be seen for vaccinations and a quick exam at 6, 9 and 15 weeks of age and then twice annually thereafter. This allows the vet to perform a comprehensive exam and ensure all is well with your furry companion. If you are concerned about your pet's vaccination status and want to give them an update, please call.

Yearly vaccination by a vet is required to guarantee the continued health of your pet. Various contagious diseases can be prevented by the vaccinations. If your pet contracts one of the diseases after being properly vaccinated by a vet, the manufacturer of the vaccine will pay for the treatment of your pet. Vaccinations purchased over the counter from farm or pet stores carry no such guarantee.
