ENTRY INFORMATION

ENTRY FEES:

- Trials Classes, PT, HT and Herding Instinct: \$50 per run.
- Farm Dog Certification: \$45 per test.

MAIL entries with check or money order payable to PVSSC to Jack Gurney, 245 Springvale Rd., Great Falls, VA 22066.

DOGS MAY BE ENTERED in a course trial or test AND FDC in the same event.

DAY OF TEST ENTRIES:

- Herding Instinct Tests until the judging limits are reached. Exhibitors should submit an entry form one (1) hour prior to the listed start time for Instinct Tests. The Judging Program will be on the PVSSC website prior to the trial date.
- Farm Dog Certification will be accepted between 9:00 A.M. and noon. Day of Show entries will be tested following those that pre-registered.

ENTRIES CLOSE: October 17, 2019 at 4:00 P.M. at the Trial Secretary's home, after which entries cannot be accepted, changed or cancelled, except for move-ups. **The Drawing for running order** will take place at the home of Jack Gurney, Trial Secretary on October 17, 2019.

- When trial entry limits have been reached all additional entries received prior to the closing date will go on an Alternate List for each level that exceeds the published limit(s). This trial will keep an alternate list of five (5) runs per stock/course.
- Entrants on the alternates' list must check in with the Trial Secretary at the trial 30 minutes before the commencement of their class.
- Entry fee will be refunded to the alternates whose dogs do not have an opportunity to run.
- Requests for move-up must be given to the Secretary 30 minutes prior to the trial starting.

BITCHES IN SEASON will be run at the end of the running order in all trial and test classes, **EXCEPT for Farm Dog**. FDC rules DO NOT permit dogs in season to be tested.

ELIGIBILITY OF DOGS

AKC Herding Regulations

HT and PT: Open to all herding breeds nine months or older and registered with the AKC or have an ILP/PAL and are eligible to compete in herding trials and tests.

Herding Instinct Test: Open to all herding breeds six months of age or older who are registered with the AKC or have been granted an ILP/PAL and are eligible to compete in herding trials and tests.

Farm Dog Certification: Open to all dogs 9 months and older that are individually registered with the AKC, recorded in the FSS program, have PAL numbers or enrolled in the AKC Canine Partners program. Females in season may **not** enter. Dogs with physical challenges (including amputees) are eligible to enter provided, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the test.

NOTICE TO EXHIBITORS

REFUND POLICY:

- Entry fees will not be refunded in the event that a dog is absent, disqualified, or excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee. If because of riots, civil disturbances, or other acts beyond the control of the show giving club, it is impossible to open or complete the show, no refunds will be made.
- Refunds of entries pulled after closing date will be made as long as an alternate is available to replace the run.
- No refund for duplicate entries or any other cause beyond the control of the PVSSC after the closing date (Rules Applying to Dog Shows, Chapter 11, Section (6) including injured or sick dogs or handlers. In the event of a spouse, sibling, parent or entered dog's untimely death, an event committee refund decision will be made.
- The PVSSC may decline any entries for cause and may remove any dog on account of disease, viciousness, or other cause and no one shall have any claim or recourse against the PVSSC or any official thereof. In this case, no refund will be made.

A-COURSE LAYOUT: Sheep and cattle use the same field. The A-Course layout for ducks, sheep and cattle is a mirror image of the diagram shown in the AKC Regulations.

LUNCH: Lunch will be provided to all volunteers. Exhibitors may purchase lunch for a nominal donation.

PHOTOGRAPHER: Carl Gernazio will be on site taking action photos and posed title photos.

DAY OF TEST ENTRIES will be accepted for Herding Instinct AND Farm Dog Certification Test **ONLY** if the judging limits have not been met. To register fill out the attached entry form and present it to the Trial Secretary for scheduling. Day of Show entries will be tested following those that pre-register.

- Sheep (Assorted mixes), 3-5 sheep/run in trial classes. Value of sheep: \$300 each.
- Ducks (Blue Swede and Blue Swede hybrids), 5 ducks per run. Value of ducks: \$75 each.
- Cattle (Assorted breeds), 3 cattle per run. Value of cattle: \$1,200 each.
