

Mr. ICON Detroit Leather 2020 Contestant Requirements:



CONTESTANT MUST:

1. Identify as a gay male
2. Participate in fundraising at the Mr. ICON Detroit Leather Contestant Meet and Greet on Friday, October 18, 2019
3. Promote the Mr. ICON Detroit Leather contest nationally
4. Compete in International Mr. Leather (IML) in 2020
5. Host a minimum of three (3) fundraising events in Michigan before IML 2020 (May 2020) as Mr. ICON Detroit Leather; First one (your victory party) to be held within a month of winning title. Winner can hold the other 2 events wherever the winner chooses. Events & Dates must be approved by contest producer team.
6. Participate as judge for, and assist with, the 2021 Mr. ICON Detroit Leather contest
7. Maintain good standing within the leather community at all times
8. Refrain from creating or promoting a contest/weekend event that competes with the Mr. ICON Detroit Leather contest or the Mr. ICON Detroit Leather Weekend
9. Refrain from competing in any other "Title Holder" contest that is part of the IML circuit until after the Mr. ICON Detroit Leather title ends (winning contestant only)
10. Refrain from publishing or broadcasting any professional pornography during your title year (winning contestant only)

Scoring:

Contestants will be scored on how well they represent themselves in their interview and on stage. They will be judged on: 1) stage presence; 2) personality; 3) embodiment of leather lifestyle; and 4) physique for the following contest categories:

- Interview (Saturday afternoon)
- Bar wear (Saturday night)
- Leather image and Speech (Saturday night)
- Leather jock and Q&A from judges (Saturday night)

Judging: Contestants will be judged on the aforementioned categories by a panel of judges. Points awarded by the judges will be added together for each contestant and the contestant with the cumulative highest number of points will be declared the winner. In the event of a tie, the lowest category scores for the top contestants will be eliminated until a winner can be declared.

All contestants are required to arrive at Menjo's no later than 9:00 pm on Friday Oct 19, 2018

All applications are due by 9 pm, Friday October 18, 2019
