City Council Minutes

August 1st, 2016

The City Council of the City of New Munich met in regular session at 6:35 p.m., in the City Hall. Jim Poepping, Shawn Duevel, Pat Nathe, Dan Krueger and Ron Doll were present.

On a motion by Ron Doll, seconded by Shawn Duevel and carried the minutes from July 5th, 2016 were approved.

Fire Chief, Allen Fiedler was present to inform the Council of three calls last month, two medical and one false alarm. He also submitted one bill that needs to be paid, \$28.09, Chief meeting. The fire department will be doing maintenance on the hydrants for the next 5 weeks. The clerk will send notices around. On a motion by Pat Nathe, seconded by Dan Krueger, carried and approved 30 hydrant markers will be purchased at \$26.95 each.

Waste/Water Operator, Tom Valerius was present to inform the Council that on the Waste/water end, the system is running good. On the water end the poly phosphate pump is not working correctly. He informed the Council that 114,000 gallons were used during poly pigging.

On a motion by Pat Nathe, seconded by Dan Krueger and carried the following building permits were approved, Chuck Borgerding and Ecker Feeds.

Danny Schwieters was present and had concerns about a notice he received from the city. He also asked to get a copy of all the city ordinances. The clerk will email him a copy.

Daniel Bueckers's, Owner of Danny's Disposal & Recycling, Inc. was present to get a five year extension on the agreement for hauling refuse and recycling for the City of New Munich. (April 2017-2022). On a motion by Pat Nathe, second by Ron Doll and carried the agreement was approved.
