

The History of the Dysfunctional Health Care System

I wanted to post the following statements, about the medical field and big PHARMA, due to a lack of truth, in these fields, concerning their history. Early in the past century, the number of “alternative” medicine practitioners was twice as large as the number of those practicing “allopathic” medicine. The rules for medical practice were changed between 1910 and 1925 by the American Medical Association, in conjunction with the Association of American Medical Colleges. The rules were changed through the “Flexner Report,” which was funded by big business, (the Carnegie and Rockefeller Foundations). This report basically forced the medical schools of the time to either take on the new “scientific” orientation, or close their doors forever! The results were astronomical! All except 25% of the existing medical schools closed their doors, while 66% of the students were forced to quit. In one fail swoop, the financially elite and BIG money took over the practice of medicine, and has maintained this control ever since!

The Declaration of Alma Alta, of 1977, extended the powers of the Flexner Report around the world. This was done through the World Health Organization. The WHO is the Ministry of Health of the United Nations and reaches the entire world with its imposing control through the world health policies that it establishes and forces onto the governments of ALL countries. In 1978, the WHO met to impose “scientific” medicine, globally, as the only valid system. They also moved to eliminate ALL other medical practices, as indicated in the Flexner Report of 1910. In 1983, they set forth the Expanded Program on Immunization, to “watch over” the vaccination of the world’s children. In 1984 the WHO joined the UN, in the adaptation of Convention of the Rights of the Child. This basically replaces any rights and authority of the parents, with a duty to obey the administrative authorities. This includes blood transfusions, vaccinations, and scientific medicine in general, as well as any severe medical treatments that the “authorities” desire to be done, without the parent’s consent!

The profit of the health care industry belongs to those who make the most money, and NOT to the public themselves. High-tech profits from medical testing; PHARMA profits from medications; BOTH make the profit from hospitals, pharmacies, and laboratories. The dictator of who profits what is the insurance industry. Hmmm....According to this line of profit, it appears that the truth can be found in the following: “The health-care system is run by the high-tech and pharmaceutical industries in conjunction with the insurance industry, which organizes the payments made. The hospitals, clinics, laboratories, and pharmacies dispense the products of the high-tech and pharmaceutical industries. The doctors are the paid consultants. The government legitimizes the health-care system by allocating additional funds for research and policing the entire system through its agencies (Department of Agriculture, Food and Drug Administration, and so forth). The patients are the consumers who are exploited by this system. More patients, more sickness, longer and more complicated sickness equals more and more money. Is it no wonder then that the banks work together with the bio-tech, chemical, agribusiness, and pharmaceutical industries to achieve this end.”*

Remember that, “Real strength comes from understanding history”**. We need to free ourselves from the conditioning that has been prevalent all around us, all our lives. We have had our brains imprinted with this false conditioning, by those whom we have put our blind faith, i.e., the FDA, CDC, AMA, APA, and WHO. These organizations are inundated with people who run back and forth, to and fro, and/or own stock in one or more of the major pharmaceutical industries, all of which share the same philosophies and practices. A large portion of these organizations have been part of a huge conglomerate that was disbanded after WWII. Once again, Hmmm...

Did you know that, “The people who bring you your Bayer Aspirin are the same folks who built and ran the Auschwitz Concentration Camp.” ** This camp was the one that has the distinction of being the largest mass extermination factory in human history! This camp was a subsidiary of IG Farben, which is now known as the Bayer Aspirin Company. “On April 14, 1941, in Ludwigshafen, Otto Armbrust, the IG Farben board member responsible for the Auschwitz project, stated to his IG Farben board colleagues, ‘our new friendship with the SS is a blessing. We have determined all measures integrating the concentration camps to benefit our company.’ ... I have thrown myself into my work wholeheartedly. Especially as I have the opportunity to test our new preparations. I feel like I am in paradise.’ ” **

Many of the board members of I.G. Farben were prosecuted and convicted of war crimes on the basis of mass murder, slavery, and other crimes against humanity, but after only a few years ALL of them were released from their punishments. They continued to consult top German businesses and returned to the control of the pharmaceutical companies that they had known long before Hitler reached puberty. They continued well after Hitler’s death, also. Well after the fall of Nazi Germany, the pharmaceutical companies, in Germany, continued to hire former members of the Nazi regime to fill their highest position... chairman of the board.

“By accepted legal standards, the Bayer Company of today is, in fact, the Bayer of World War II. In 1998, the pharmaceutical giant, Bayer, conducted pesticide experiments on humans in what was called the Inveresk trials. Three years later, the company behind the tests stands accused of breaking the Nuremberg Code. *The Sunday Herald* in England reported that subjects were given a single dose of a substance called azinphos-methyl (AM) and then observed for seven days. This is just the tip of the iceberg that shows the kinds of attitudes that have always been a part of pharmaceutical companies like Lilly, which lied about the safety of thimerosal in the 1930’s and then proceeded to put its mercury-based compound ‘almost’ secretly into vaccines and many other medical products for decades without interference from the FDA.” **

“It is a historical fact that it was the Rockefeller-Colorado industrial complexes that were instrumental in fostering chemical-based drug treatment as the basis for health care, and true to form they have been the dominant adversaries against safer non-drug treatments. When John D. Rockefeller interlocked his American-based, international empire with that of I.G. Farben in 1928 ‘there was created the largest and most powerful cartel the world has ever known. Not only has that cartel survived through the years, it has grown and prospered. Today it plays a major role in both the science and politics of cancer therapy,’ wrote G. Edward Griffin in a *World Without Cancer* and *The Politics of Cancer Therapy*.’ “ **

“A major reason why health care is in such a shambles is that the medical establishment has allowed itself to be bought off by the pharmaceutical industry, whose prime motive is profit.” **

Were you aware that Heroin was originally created and sold as a prescription drug in the United States by I.G. Farben? This was outlawed in 1924. Then there is the horror story of the thalidomide tragedy, where expectant mothers took the drug and babies were born with flipper-like arms and legs, missing fingers and toes. Some newborns even had organs in the wrong places. This is something that has been repeated over and over again, with many different drugs and vaccines. Mandatory vaccine programs are, “A violation of the Nuremberg Code in that they force individuals to have medical treatment against their will, or to participate in the functional equivalent of a vast experiment without fully informed consent,” as stated by Jane Orient, M.D. **

“History will one day show that the people at the top, and probably in the middle of these organizations, are the greatest criminals that humanity has ever known, for it will be recorded that they have been responsible for the murder and deliberate poisoning and death of uncounted millions of people including, incredibly, newborn infants. This might seem like the most fantastic of fantastic statements you have ever read but when you put together the whole picture, we come to see that the principle organizations involved with medicine and public health subscribe to the same philosophies of the same people and organizations involved in the extermination of millions of people. The science and philosophy of the CDC and the FDA is that poisons are safe and suitable for mass consumption, and the AMA and the APA back them up to the hilt. People are gullible and have a natural tendency to believe government-approved products are safe. The people who should be locked in prison for eternity are the people who now demand proofs that known poisons are hazardous to you or your children’s health.” **

Aspartame is one of the MANY fallacies propagated by big PHARMA! It has been linked with several neuro-degenerative diseases and conditions including, but not limited to, Parkinson’s disease, Alzheimer’s disease, Huntington’s disease, and Multiple Sclerosis. Internally, aspartame breaks down into its constituent methanol and amino acids. This then degrades into formaldehyde. “The FDA lost all credibility with this product, which at first refused to approve it for consumption for obvious reasons, but then the man most responsible for the mess in Iraq, Donald Rumsfeld was hired by the G.D. Searle (the original developer of aspartame) as CEO, who then used political muscle instead of safety tests to force approval. “ **

“The chief patent holder of the sweetener now is the Monsanto Co., based in St. Louis. In 1967, Monsanto entered into a joint venture with I.G.
